
Water Supply Improvements: Boyup Brook (Shire of Boyup Brook) Notice of Authorisation to Construct a 1000m<sup>3</sup> Ground Level Tank

In accordance with the provisions of the Water Agencies (Powers) Act 1984, the Minister for Water Resources has authorised the Water Corporation to—

- Construct a reinforced concrete ground level water storage tank of approximately 1000 cubic metres capacity, 19.0 metres diameter and 4.0 metres wall height, with a metal sheeted roof of zincalume finish.
- Relocate a chlorination module from existing tank site.
- Construct the associated pipework including valves, meters and concrete valve pits.
- Construct 250mm below ground pipelines of approximately 1200m in length.

The location of the proposed works is within Boyup Brook Town as shown on the locality plan.

The works will improve the Boyup Brook water supply.
