# State Superannuation Amendment Regulations (No. 3) 2008

Made by the Governor in Executive Council.

## 1. Citation

These regulations are the *State Superannuation Amendment Regulations (No. 3)* 2008.

#### 2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

# 3. The regulations amended

The amendments in these regulations are to the *State Superannuation Regulations 2001*.

# 4. Regulation 3 amended

Regulation 3(1) is amended as follows:

- (a) by inserting in the appropriate alphabetical positions
  - "GESB Super (Retirement Access) Member" means a member of the GESB Super (Retirement Access) Scheme;
  - "GESB Super (Retirement Access) Scheme" means the superannuation scheme established by regulation 200;
- (b) by deleting the definitions of "Retirement Access Member" and "Retirement Access Scheme".

# 5. Regulation 93 amended

Regulation 93(2) is repealed and the following subregulation is inserted instead —

(2) A Commonwealth payment cannot be accepted under this regulation for a person who is a West State Super Member and not already a GESB Super Member.

# 6. Regulation 200A inserted

After regulation 200 the following regulation is inserted —

# 200A. Scheme renamed as GESB Super (Retirement Access) Scheme

When this regulation comes into operation the superannuation scheme established by regulation 200 is renamed as the GESB Super (Retirement Access) Scheme.

# 7. Regulation 204 repealed

Regulation 204 is repealed.

# 8. Regulation 205 amended

Regulation 205 is amended as follows:

- (a) by inserting before "A" the subregulation designation "(1)";
- (b) at the end of the regulation by inserting —
- (2) The Board must not accept a contribution for a person who is over 65 years of age if a regulated superannuation fund would be prevented by regulation 7.04 of the SIS Regulations from accepting the contribution.

# 9. Regulation 208 amended

Regulation 208(1)(a) is deleted.

# 10. Regulation 212 amended

(2A) The Board must ensure that for each readymade investment plan established under regulation 106(1) there is a corresponding readymade investment plan established under this regulation with the same asset allocation.

# 11. Regulation 214A inserted

214A. Member who is also a GESB Super Member

- (1) This regulation applies
  - (a) in relation to each GESB Super (Retirement Access) Member who is also a GESB Super Member; and
  - (b) despite anything in regulation 214.
- (2) If the Member's selection under regulation 108 is a readymade investment plan (as defined in regulation 105), then the Member is taken to have selected under regulation 214(1) the readymade investment plan (as defined in regulation 211) with the same asset allocation as that of the plan selected under regulation 108.
- (3) If the Member's selection under regulation 108 is a personalised investment plan (as defined in regulation 105), then the Member is taken to have selected
  - (a) under regulation 214(1), a personalised investment plan (as defined in regulation 211); and
  - (b) under regulation 214(1a), the same asset allocation as the Member has selected under regulation 108(2).

- (a) in relation to so much of the Member's account balance as constitutes an unrestricted non-preserved benefit, at any time; or

- (c) in relation to an eligible termination payment transferred to the GESB Super (Retirement Access) Scheme from a source other than a superannuation fund, at any time.
- (1B) A request under subregulation (1)(b) may be made at any time.

- (a) has been unable, after making reasonable enquires, to find an administrator or executor of the Member's estate: or
- (b) considers it desirable to do so in order to relieve or avoid hardship,

the Board may pay up to \$25 000 of the benefit —

- (c) to one or more of the Member's dependants in proportions determined by the Board; or
- (d) if, after making reasonable enquiries, the Board has been unable to find any dependant of the Member, to one or more other individuals in proportions determined by the Board.
- (4) In this regulation —

"dependant" has the same meaning as it has in section 10 of the SIS Act.

# 14. Regulation 219AA inserted

# 219AA. Transfer to eligible rollover fund

The Board may transfer the balance of a Member's retirement access account to an eligible rollover fund if that fund is permitted by the SIS Act to accept the benefit, whether or not the Member has requested the transfer.

# DIRECTOR OF PUBLIC PROSECUTIONS ACT 1991

Amendments to the Director of Public Prosecution Policy and Guidelines 2005

To amend the Director of Public Prosecutions Prosecution Policy and Guidelines 2005 accordance with the Director's power to issue guidelines under section 24 of the Director of Public Prosecutions Act 1991 (WA) by:

# **Decision to Charge**

1. By amending clause 5 by replacing "Western Australian Police Service (WAPS) with "Western Australia Police (WAP)" and by deleting all references in the guidelines to "WAPS" and replacing with "WAP".

#### Other Relevant Public Interest Factors

2. By inserting after paragraph 32(d)—

"(da) securing appropriate convictions, so far as it is practicable, to compliment the operation of the Community Protection (Offender Reporting) Act 2004 and the Working with Children (Criminal Record Checking) Act 2004."

#### **Taking Over an Indictable Prosecution**

- 3. By deleting—
  - (a) the title "TAKING OVER AN INDICTABLE PROSECUTION"
  - (b) clauses 61-65 inclusive.

# Notice of Discontinuance—Publication of Reasons

4. by amending clause 70 by deleting—

"In the normal course the WAPS or relevant department or agency and the victim will be consulted before any decision is made."

5. by inserting 70A—

"70A Where reasonably practicable, the police officer-in-charge of the investigation or other relevant department or agency ("the investigator") and the victim, must be advised whenever the ODPP is considering whether or not to discontinue a prosecution. The investigator should be consulted on any relevant matters, including perceived deficiencies in the evidence and any matters raised by the accused person. The victim's views on the proposed course of action should also be sought.

Consultations with the investigator and victim must be recorded prior to any decision.

While the views of the victim and the investigator must be properly considered before a final decision, the overriding consideration is the public interest."

#### **Charge Negotiation**

- 6. To amend clause 74 by deleting "experience" and replacing with "expedience".
- 7. To amend clause 77 by deleting the content of clause 77 and replacing it with—

"77. In considering whether to accept a plea the investigator and victim should be consulted. Consultations with the investigator and victim must be recorded prior to any decision.

If reference to any substantial and otherwise relevant and available evidence is omitted from a negotiated statement of facts, whether negotiated before or after a plea of guilty is entered, the views of the investigator and the victim should be sought about the statement of agreed facts before it is adopted, unless is not reasonably practicable to do so.

While the views of the victim and the investigator must be properly considered before a final decision, the overriding consideration is the public interest."

#### Victims

8. By inserting, after clause 124, clause 124A—

"124A Where practicable, victims of crime should be consulted in a timely manner regarding a decision to discontinue or to change substantially the charges laid and any decision to accept a plea to a lesser or alternative charge or charges."

- 9. By amending clause 125—
  - (a) By deleting paragraph "(b)" and replacing with—
    - "(b) any decision to discontinue or to change substantially the charges laid and any decision to accept a plea to a lesser or alternative charge or charges;"
- 10. By amending clause 126
- (a) by deleting clause 126 and replacing with-

"The obligations under parag8raph 124A do not apply where the victim has indicated that he or she does not want to be consulted or his or her whereabouts cannot be ascertained after reasonable inquiry."

11. By Inserting after clause 148—

# "STATE APPEALS AGAINST JURY ACQUITTALS

148A. The State's right to appeal against a judgment of acquittal entered after a jury's verdict of not guilty is only to be exercised in circumstances—

- (a) where a substantial error is likely to have affected the verdict;
- (b) where there are reasonable prospects that the appeal will be allowed;
- (c) where, on a retrial, there are reasonable prospects of conviction on the basis of the evidence available in relation to the charge; and
- (d) where it is in the public interest to continue the prosecution.

148B. The following additional factors are relevant to considering whether or not to institute an appeal against an acquittal—

- (a) whether the error amounts to an inconsistent application of the law;
- (b) whether the verdict of acquittal is so significant as to shock the public conscience; and
- (c) whether there is a public interest in correcting the error."
- 12. Amending clause 149 by deleting the words "The role of the State in an appeal against a directed acquittal is an exception to the rule against double jeopardy."
- 13. Amending clause 149 by deleting "such an appeal" and replacing those words with "an appeal against a directed acquittal."
- 14. Amending clause 153 by inserting after the words "A State appeal" the words "against sentence".

## BUSH FIRES ACT 1954 LOCAL GOVERNMENT ACT 1995

Shire of Plantagenet

BUSH FIRE BRIGADES AMENDMENT LOCAL LAW 2008

Under the power conferred by the Bush Fires Act 1954 and the Local Government Act 1995 and under all other powers enabling it, the Council of the Shire of Plantagenet resolved on 25 March 2008 to make the Shire of Plantagenet Bush Fires Brigade Amendment Local Law 2008.

In this local law, the Shire of Plantagenet Bush Fires Brigades Local Law as published in the Government Gazette on 7 April 2004 and amended by Shire of Plantagenet Bush Fire Brigades Local Law Amendment 2006 published in the Government Gazette on 17 March 2006, is referred to as the principal local law. The principal local law is amended as follows—

#### 1. Clause 1.2—Definitions

In subclause (1) of Clause 1.2 in the definition of "Rules", delete the comma and words ", as varied from time to time under clause 2.5".

#### 2. Clause 2.5—Variation of Rules

Delete clause 2.5

#### 3. Clauses in Part 2 to be renumbered

Renumber clauses 2.6, 2.7 and 2.8 to 2.5, 2.6 and 2.7 respectively.

#### 4. Clause 3.3—Delegation of Authority

In Clause 3.3 substitute the word "council" with the words "local government".

# 5. First Schedule—Rules Governing the Operation of Bush Fire Brigades Clause 2.4 Application for membership

In paragraph (a) of subclause 2.4(1) of the FIRST SCHEDULE, delete the words "of that in Appendix I" and substitute the words "determined by the local government from time to time".

In paragraph (b) of subclause 2.4(1) of the FIRST SCHEDULE, delete the words "of that in Appendix II" and substitute the words "determined by the local government from time to time".

In paragraph (c) of subclause 2.4(1) of the FIRST SCHEDULE, delete the words "of that in Appendix III" and substitute the words "determined by the local government from time to time".

#### 6. Appendices

Delete Appendices I, II and III.

#### LOCAL GOVERNMENT ACT 1995

Shire of Plantagenet

PARKING AND PARKING FACILITIES LOCAL LAW 2008

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Plantagenet resolved on 25 March 2008 to make the *Shire of Plantagenet Parking and Parking Facilities Local Law 2008*.

The Shire of Boddington Local Law Relating to Parking and Parking Facilities 2007 as published in the Government Gazette on 14 March 2007 is adopted as a local law of the Shire of Plantagenet with the modifications as are here set out.

#### 1. Preliminary

- (a) On construing the following modifications, where a modification requires the renumbering of a Part, clause, subclause or paragraph, subsequent modifications have been drafted on the basis that the renumbering has been effected.
- (b) Where the 'Shire of Boddington' is mentioned in the local law substitute 'Shire of Plantagenet'.

(c) Where the "Local Laws Relating to Parking and Parking Facilities 200" or "Local Laws Relating to Parking and Parking Facilities" is mentioned in the local law substitute "Parking and Parking Facilities Local Law 2008".

#### 2. Repeal

Add the following new clause—

#### '1.2 Repeal

The Shire of Plantagenet Parking and Parking Facilities Local Laws 1998 as published in the Government Gazette of 16 April 1999 are hereby repealed.

#### 3. Clause 2.2—Interpretation

In Clause 2.2—Interpretation, delete the words—

"'parking region' means the area within the Boddington townsite boundaries and any subsequent extension of the Boddington townsite boundaries;"

"'parking region' means the whole of the Shire of Plantagenet excluding any roads which come under the control of the Commissioner of Main Roads;".

#### 4. Clause 2.4—Application and Pre-Existing Signs

In subclause (4) of clause 2.4 delete the words "Schedule 4" and substitute "Schedule 3".

#### 5. Clause 4.1—Restrictions on parking in particular areas

In Clause 4.1—Restrictions on parking in particular areas—

- (a) delete the whole of paragraph (c) of subclause (3).

 $\label{thm:construct} \begin{tabular}{ll} To improve the reliability of the Nannup-Bridgetown water supply scheme, the Water Corporation proposes to construct the following works---$ 

- 27km of 300mm diameter PVC pipe from the new Nannup bore site to the existing Millstream Dam, complete with all fittings and connections.
- Three transfer pump stations, one at the Nannup bore site and two at locations along the pipe route. Each pump station will be a steel building approximately 8m x 5m x 5m high and having an environmental green finish.
- One 500kL balancing tank on the Nannup bore site and three 400kL balancing tanks at locations along the pipe route. Each tank will be of steel construction, approximately 12m-13m diameter and 4.5m high and having an environmental green finish. The tanks will be complete with access facilities, pipework, valves and fittings.


The location of the proposed works is in the Shire of Nannup as shown on the plan. The proposed works are scheduled to commence in May 2008 and will continue for a duration of approximately 8 months

The pipeline will be below ground PVC pipe and generally constructed using open trench excavation which will be backfilled and restored. Major road and river crossings will be constructed using trenchless technology.
