Town of Cambridge

STANDING ORDERS AMENDMENT LOCAL LAW 2008

Under the powers conferred by the *Local Government Act 1995* and all other powers enabling it, the Council of the Town of Cambridge resolved on 27 May 2008 to make the *Town of Cambridge Standing Orders Amendment Local Law 2008*.

PART 1—PRELIMINARY

1.1 Citation

This local law may be cited as the Town of Cambridge Standing Orders Amendment Local Law 2008.

1.2 Objective

The objective of this local law is to make minor amendments to the existing Standing Orders Local Law to allow Elected Members the opportunity to ask supplementary questions of an application proponent during the course of Committee discussion about the issue at hand.

1.3 Commencement

This local law comes into operation 14 days after the date of its publication in the Government Gazette.

1.4 Application

This local law applies throughout the district.

PART 2—AMENDMENT

2.1 Principal Local Law

In this amendment local law, the Town of Cambridge Standing Orders Local Law published in the *Government Gazette* on 2 May 2007 is referred to as the principal local law.

The principal local law is hereby amended as follows—

2.2 Amendment

2.2.1 Insert the following subclause after subclause 16.6—

"16.7 Questions by Members at Committee Meetings

- (1) During discussion on any item of business, Committee Members may, through the Presiding Member, ask any member of the public who has made a representation on that item one question relating to that item.
- (2) Further questions may be asked by the Presiding Member or by a Member with the consent of the Presiding Member.
- (3) Each question and response—
 - (a) must be brief, concise and to the point;
 - (b) is not to be accompanied by argument or debate."

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Jetties Amendment Regulations* (No. 2) 2008.

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on 1 July 2008.

ELECTRICITY (LICENSING) ORDER 2008

Made by the Director of Energy Safety under regulation 19(2)(k) of the *Electricity (Licensing)* Regulations 1991.

1. Citation

This Order may be cited as the Electricity (Licensing) Order 2008.

2. Commencement

This Order is to have effect from the day after the publication of this Order.

3. Declaration of electrical work not requiring a licence or permit

- (1) It is declared that electrical work comprising the servicing and repair of electrical appliances connected to or to be connected to a low voltage electricity supply by means of a plug and cord (or flexible cable) may be carried out by persons who are not the holders of a licence or permit issued under the provisions of the *Electricity (Licensing) Regulations 1991*.
- (2) In this clause—
 - "low voltage electricity supply" means electricity supplied at a pressure not exceeding 1,000 volts 50 hertz alternating current or 1,500 volts direct current.
 - "servicing and repair" means identifying faulty components within electrical appliances and replacing them on a like-for-like basis, and attaching plugs or cords (or flexible cables) and cords (or flexible cables) to electrical appliances.
 - "electrical appliance" means a device in which electrical energy is consumed or substantially changed in character by conversion into heat, sound, light or otherwise.
