**ELECTORAL ACT 1907**  
REGISTRATION OF POLITICAL PARTIES  
Proposal to Cancel Registration  
Daylight Saving Party

Under section 62L(2)(b) of the *Electoral Act 1907* the Electoral Commissioner may cancel the registration of a political party if the Electoral Commissioner is satisfied on reasonable grounds that the party is not a parliamentary party and does not have at least 500 members who are electors.

The Commissioner is satisfied on reasonable grounds that—

Daylight Saving Party

is not a parliamentary party and does not have at least 500 members who are electors.

It is therefore proposed to cancel the registration of the Daylight Saving Party as a political party in Western Australia.

This action requires the Electoral Commissioner to—

- (a) give written notice of the proposed cancellation to the secretary of the party at the address shown in the register;
- (b) give notice of the proposed cancellation in—
  - (i) the *Gazette*; and
  - (ii) a newspaper circulating generally in the State;

Notice in accordance with (a) has been given and this gazettal is in accordance with (b)(i) above. A similar notice will appear in *The West Australian* on 19 July 2008.

Persons may, within 14 days after the *Gazette* notice, object to the Electoral Commissioner in writing against the proposed cancellation.

KIMBERLEY PRAWN MANAGED FISHERY MANAGEMENT PLAN 1993  
Notice of Areas Closed to Fishing for Prawns

Notice No. 1 of 2008

I, Peter Millington, Chief Executive Officer of the Department of Fisheries, in accordance with clause 17 of the *Kimberley Prawn Managed Fishery Management Plan 1993* (the Plan) and being of the opinion that the prohibition is required in the better interests of the Kimberley Prawn Managed Fishery, do hereby—

1. Cancel *Notice No. 3 of 2007*, dated 9 November 2007;
2. Prohibit fishing for prawns in the Kimberley Prawn Managed Fishery in the waters described in Schedule 1 of the Plan from date of the gazettal of this Notice until 1000 hours WST on 1 August 2008;
3. Prohibit fishing in the waters described in (a), (b), (c) and (d) from the date of the gazettal of this Notice until 1630 WST on 14 November 2008—
  - (a) Collier Bay Inshore Closure  
Waters inshore of a line commencing at the intersection of 15°52.09' south latitude and 124°26.2' east longitude; thence generally south to 16° 04.2' south latitude and 124°26.3'

east longitude; thence generally south west to 16°17.00' south latitude and 124°18.1' east longitude; thence generally east to 16°17.2' south latitude and 124°07.6' east longitude.

(b) Brunswick Bay-York Sound Inshore Closure

Waters inshore of a line commencing at the intersection of 15°15.40' south latitude and 124°40.57' east longitude; thence generally north east to 15°09.50' south latitude and 124°50' east longitude; thence generally north east to 15°00.45' south latitude and 124°54.20' east longitude (Desfontaines Island); thence generally east to 14°57.90' south latitude and 125°01.20' east longitude (Ena Island); thence generally north east to 14°45.30' south latitude and 125°08.10' east longitude (Cape Pond).

(c) Admiralty Gulf Inshore Closure

Waters inshore a line commencing at the intersection of 14°19.50' south latitude and 125°43.50' east longitude; thence generally south east to 14°25.18' south latitude and 125°48.00' east longitude; thence due east to 14°25.18' south latitude and 125°55.00' east longitude; thence generally north east to 14°19.40' south latitude and 125°57.60' east longitude; thence due east to 14°19.40' south latitude and 126°04.00' east longitude; thence to the intersection of 14°19.40' and the high water mark on the mainland;

(d) Napier Broome Bay Inshore Closure

Waters inshore of a line commencing at the intersection 14°02.63' south latitude and 126°29.57' east longitude; thence generally south east to 14°05.2' south latitude and 126°31.3' east longitude; thence generally south east to 14°06.35' south latitude and 126°35.51'; thence generally north east to 13°58.3' south latitude and 126°42.2' east longitude; thence generally north east to 13°55.78' south latitude and 126°48.38' east longitude; and

4. Prohibit fishing for prawns in the waters described in Schedule 1 of the Plan commencing from 1630 hours WST on 14 November 2008 to 0600 hours WST on 31 October 2009.

**PERRY LAKES REDEVELOPMENT ACT 2005**

## NOTICE OF APPROVAL—PERRY LAKES REDEVELOPMENT PLAN

*Town of Cambridge*

General Description

In December 2005, State Parliament passed the *Perry Lakes Redevelopment Act (2005)* (hereafter referred to as “*PLRA*”) transferring responsibility for the redevelopment of the Perry Lakes land from the Town of Cambridge to the Western Australian Land Authority.

The Perry Lakes Redevelopment Plan (hereafter referred to as the “Redevelopment Plan”) provides a framework for the land’s future development and a context for the consideration and approval of subdivision and strata applications by establishing the general principles of urban design, land use, key road networks, open space and infrastructure.

The Minister for Planning and Infrastructure has approved the Redevelopment Plan with amendments and this notice is provided in accordance with Section 28 of the PLRA. The amendments to the Redevelopment Plan are as follows—

- i. the Redevelopment Plan being modified to include a new clause 2g(iv): Within each of Precincts 3, 9, 10, 11 and 12 a minimum of 20% of the total number of dwellings developed shall be a maximum of 70m<sup>2</sup> in plot ratio area and a further 20% of the total number of dwellings shall be a maximum of 100m<sup>2</sup> in plot ratio area, the number as calculated being rounded up or down as appropriate.
- ii. the Redevelopment Plan being modified to include a 20 metre road reserve for the east-west road between Precincts 7 and 9;
- iii. the Redevelopment Plan being modified to require a left slip-lane to be constructed at Alderbury Street turning into Brookdale Street and median islands to be constructed at Alderbury Street at the southern ends of Abordale and Ferndale Streets; and
- iv. the Redevelopment Plan being modified to include a strongly traffic calmed vehicle link with a low design speed where Meagher Drive is shown disconnected on the draft Redevelopment Plan.

The location of the proposed works is on Ajana Kalbarri Road, Kalbarri, approximately 2km north of Kalbarri as shown on the plan.

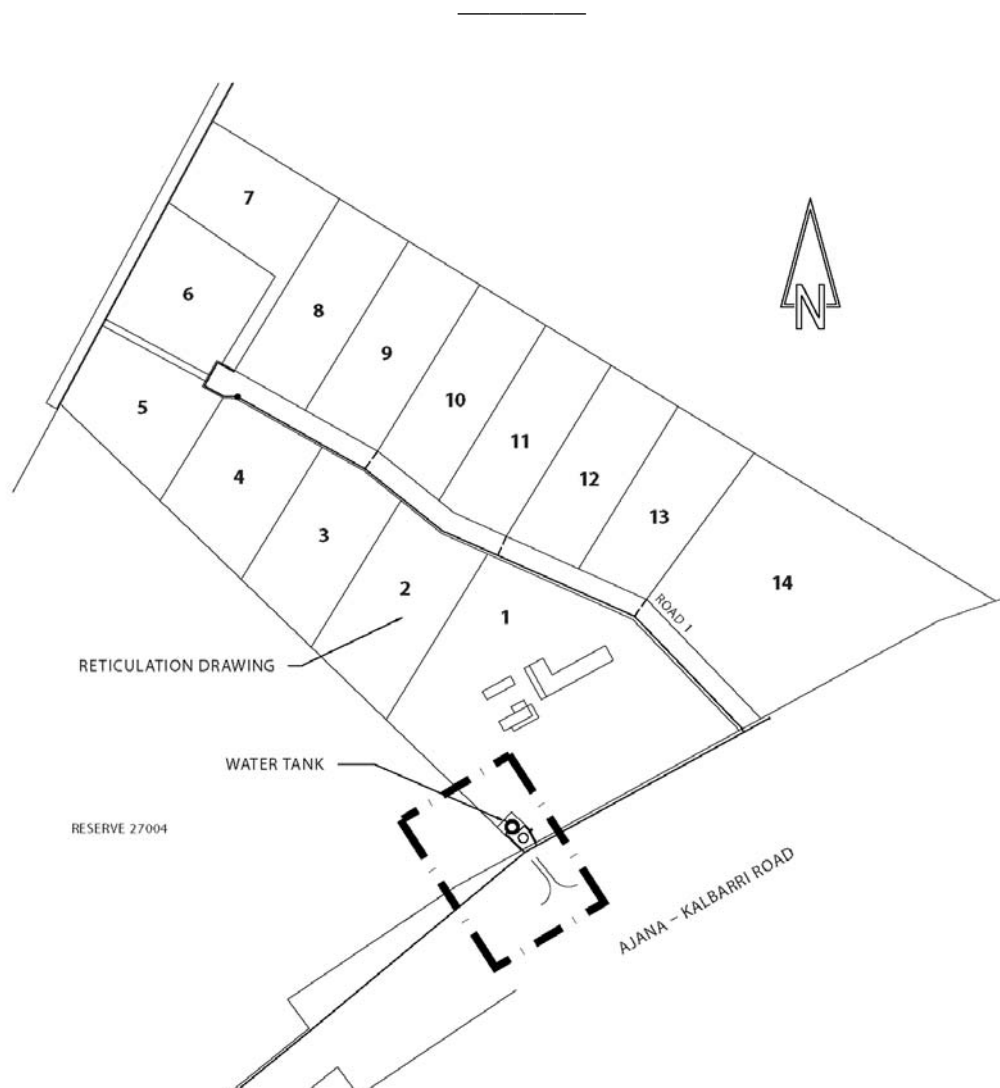
The proposed works are scheduled to commence in August 2008 and will continue for approximately 3 months.

In doing so, the Authority is to investigate and report on the following matters—

- the appropriate charging structures and recommended tariff levels for the Water Corporation, AQWEST and the Busselton Water Boards' water supply services;
- the appropriate charging structures and recommended tariff levels for the Water Corporation's wastewater services;
- the appropriate charging structures and recommended tariff levels for the Water Corporation's drainage services;
