LOCAL GOVERNMENT ACT 1995

Shire of Plantagenet ACTIVITIES IN THOROUGHFARES AND PUBLIC PLACES AND TRADING AMENDMENT LOCAL LAW 2008

Under the power conferred by the Local Government Act 1995 and under all other powers, the Council of the Shire of Plantagenet resolved on 23 September 2008 to make the Shire of Plantagenet Activities in Thoroughfares and Public Places and Trading Amendment Local Law 2008.

In this local law, the *Shire of Plantagenet Activities in Thoroughfares and Public Places and Trading Local Law* as published in the *Government Gazette* on 9 November 2001, is referred to as the principal local law. The principal local law is amended as follows:

1. General

(a) Delete the word 'authorized' wherever it appears in the local law and substitute the word 'authorised'.

(b) Delete the title '*Liquor Licensing Act 1988*' wherever it appears in the local law and substitute the title '*Liquor Control Act 1988*'.

(c) Delete the title 'Weights and Measures 1915' wherever it appears in the local law and substitute the title 'Trade Measurement Act 2006'.

2. 1.2—Definitions

In clause 1.2-

- (a) Delete the title 'Town Planning and Development Act 1928' wherever it appears and substitute the title 'Planning and Development Act 2005'.
- (b) In the definition of the 'townsite', delete the words 'the townsite of Mount Barker, Kendenup, Narrikup and Rocky Gully' and substitute the words 'townsites within the district'.
- (c) Insert in the appropriate alphabetical order the definition—
 - '**person liable for the control of a horse**' means the person who has the horse in his or her possession or under his or her control, but does not include—
 - (i) a registered veterinary surgeon, or a person acting on his behalf, in the course of his professional practice; or
 - (ii) a police officer or other person acting under a statutory duty or power or in the administration of the Act;

3. Clause 4.2—Prohibitions relating to animals

In clause 4.2 add the following subclauses-

- (3) Any person liable for the control of a horse who permits that horse to excrete in a public place or other local government property within any townsite in the district commits an offence unless the excreta is removed immediately and disposed of either on private land with consent of the owner or occupier or in such other manner as the local government or an authorised person may approve.
- (4) The following local government property is exempt from the provisions of subclause (3)—
 - (a) Pwakkenbak Trail, Reserve 15162, South Marmion Street and Warburton Road, Mount Barker.
 - (b) Mondurup Trail, Reserves 27183, 27185 and 24584, Lot 298 Marmion Street, Mount Barker.
 - (c) Ural's Trail and Frost Park, Reserve 1790, McDonald Avenue, Mount Barker.
 - (d) Polocrosse Grounds, Reserve 27184, McDonald Avenue, Mount Barker.
 - (e) Tree Farm, Lot 81 McDonald Avenue, Mount Barker.'

4. Clause 5.2—Application

In clause 5.2, delete the words 'This Part does not apply to the townsite' and substitute the words 'This Part does not apply to any townsite within the district'

5. Clause 5.11 Permit to clear

In subclause 5.11(1) delete the measurement '2m' and substitute '1.5m'.

6. Clause 8.1 Application of Part 9 Division 1 of Act

In subclause (b) of Clause 8.1, delete the words 'regulations 33 and 34' and substitute the words 'regulation 33'.

7. Schedule 1—Prescribed Offences

In Schedule 1, add the following in the appropriate numerical order under the respective columns 'Clause' 'Description' and 'Modified Penalty \$':

4.2(3)—Permitting a horse to excrete in a public place—100

Imitation Baby's Dummies

- being satisfied that John Lenders, the then Minister for Consumer Affairs in and for the State of Victoria has by notice dated 25 August 2004 published in the Victorian *Government Gazette* on 1 September 2004, made a law prohibiting the supply of goods described in the Schedule hereto; and
- order, pursuant to section 23R(2) of the *Consumer Affairs Act 1971*, that the supply of goods described in the Schedule be prohibited in this State; and
- further order that this Order shall take effect upon date of gazettal.

This order revokes and replaces an earlier Order dated 16 September 2004 and published in the Western Australian *Government Gazette* on 21 September 2004.

Schedule

Goods and objects that are imitation baby's dummies and objects that resemble a baby's dummy in appearance and size and which do not comply with the requirements of Australian Standard AS 2432-1991.

"Baby's dummy" means an object used to pacify a baby and the object includes a teat, which the baby sucks, but from which the baby does not obtain fluid.

Explanatory Note

This order prohibits the supply of imitation and novelty dummies, with or without electronic components, that may cause persons, in particular children, to confuse them with a baby's dummy and in consequence place them in their mouth and where such action may cause serious injury or death. This order does not apply to goods that comply with the requirements of Australian Standard AS 2432-1991.

Objects, including but not limited to 'ice pipes' that are used, intended for use, or designed for use in smoking or inhaling into the human body methamphetamine crystals (also known by other names including 'ice' and 'crystal meth').

Explanatory Note

This order prohibits the supply of 'ice pipes' and similar products specifically used for smoking or inhaling methamphetamine crystals including 'crystal meth' or 'ice'. Methamphetamine causes increased heart rate and blood pressure and can cause irreversible damage to blood vessels in the brain, producing strokes. Its use can result in cardiovascular collapse and death.

Moveable Soccer Goals

I, Anne Driscoll, Commissioner for Consumer Protection in and for the State of Western Australia-

- considering it necessary in the interests of the safety of the public;
- being satisfied that Marsha Thompson, the then Minister for Consumer Affairs in and for the State of Victoria has by notice dated 30 November 2005 published in the Victoria *Government Gazette* on 2 December 2005, made a law regulating the supply of goods described in Schedule 1 hereto; and
- order, pursuant to section 23R(3) of the *Consumer Affairs Act 1971*, that the supply of goods described in Schedule 1 is allowed in this State, subject to the conditions or restrictions specified in Schedule 2 subject to the exemptions specified in Schedule 3; and
- further order that this Order shall take effect upon date of gazettal.

This order revokes and replaces an earlier Order dated 7 June 2006 and published in the Western Australian *Government Gazette* on 9 June 2006.

Schedule 1

For the purposes of this order, "the goods" means moveable soccer goal which is a freestanding structure consisting of at least two upright posts, a crossbar and support bars that is designed—

- (a) to be used by adults or children for the purposes of a soccer goal; and
- (b) to be used without any form of support or restraint (other than pegs, stakes or other forms of temporary anchoring device); and
- (c) to be able to be moved to different locations.

Schedule 2

Conditions

In this Schedule, a moveable soccer goal, when set up in accordance with the manufacturer's instructions on a flat level surface without pegs, stakes or other forms of temporary anchoring device—

(a) must not fall over, or fail to return to an upright position, when subjected to a horizontal pull force of 2000 newtons to the centre of the crossbar for no less than 60 and no more than 70 seconds, and

- (b) must have all exposed corners and edges rounded with a radius of no less than 3 millimetres, and
- (c) must have permanently marked clearly and legibly in a conspicuous position on the crossbar or an upright post—
 - (i) the name or trademark of the manufacturer, retailer or importer of the moveable soccer goal, and
 - (ii) the words "WARNING—ALWAYS ANCHOR GOAL—NEVER CLIMB OR HANG ON CROSSBAR. Unanchored goals can tip over causing serious injury or death." with upper case letters at least 25 millimetres high and lower case letters at least 12.5 millimetres high, and
- (d) if part of the structure of the moveable soccer goal joins the base of an upright post and runs along the ground (a ground frame) the moveable soccer goal must not have any gap greater than 5 millimetres at the point where the ground frame joins the upright post, and no part of the ground frame must extend past the front or sides of the upright post.
- In this Schedule, a person who, in trade or commerce, supplies a moveable soccer goal-
 - (a) must hold a test report issued no more than 12 months before the supply, indicating—
 - (i) that the particular moveable soccer goal has been tested; and
 - (ii) the method used to carry out the test and the results of the test; and
 - (iii) that the results of the test show that the moveable soccer goal complies with this order prescribed for moveable soccer goals; and
 - (b) must supply a copy of the test report with the moveable soccer goal; and
 - (c) must, on request, make available, for inspection by an inspector (appointed under the *Consumer Affairs Act 1971*) any such test report held by the person; and
 - (d) must, if supplying a moveable soccer goal to which this order does not apply, supply with the moveable soccer goal a certificate setting out the reasons why this Order does not apply to that moveable soccer goal.

Schedule 3

Exemptions

This order does not apply to a moveable soccer goal—

- (a) that is supported by a sleeve set in the ground;
- (b) that weighs less than 28+0.25 kilograms, when weighed with all attachments (other than pegs, stakes or other forms of temporary anchoring device) using a commercially available scale; or
- (c) that is designed for indoor use only.

Explanatory Note

This order permanently prohibits the supply of a moveable soccer goal unless it complies with the conditions set out in Schedule 2. The object of the order is to reduce the incidence of serious injury or death resulting from the instability of the structure, causing it to overbalance and strike any person underneath it. Certain types of moveable soccer goals are exempted under Schedule 3.
