Shire of Denmark

AMENDMENT LOCAL LAW 2008

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Denmark resolved on 28 October 2008 to make the "Shire of Denmark Amendment Local Law 2008".

1. Citation

This Local Law may be cited as the "Shire of Denmark Amendment Local Law 2008".

2. Shire of Denmark Local Laws Relating to Fencing

The Shire of Denmark Local Laws Relating to Fencing published in the *Government Gazette of 29 May 2001* is amended as follows—

The First Schedule, part B (a), is amended by the deletion of "; " following the words "of 600~mm"

and inclusion of the following words—

"or where the fence is constructed of steel sheeting, the steel sheeting may be finished as close to ground level so as to not compromise the corrosion prevention requirements of the steel sheeting manufacturer;".

3. Shire of Denmark Parking and Parking Facilities Local Law

The Shire of Denmark Parking & Parking Facilities Local Law published in the Government Gazette of 29 May 2001 is amended as follows—

a. Clause 1.3 (1) Interpretation is amended.

This clause is amended by the inclusion of the following in its correct alphabetic sequence—

"ACROD Sticker" has the meaning given to it in the Code;

The following definitions in this clause are amended in accord with the following—

"bicycle"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"bus"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"Code"—delete "1975;" and replace with "2000;"

"footpath"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"motorcycle"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"no parking area"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"park"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"special purpose vehicle"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

"symbol"—delete "1989" in the first line of the definition and replace with "1999" and

"vehicle"—delete all of the definition wording and replace with "has the meaning given to it in the Code;"

b. Clause 2.4 Parking and Loading prohibitions and restrictions is amended.

This clause is amended by—

Inclusion of new subclause (3) as follows—

"(3) Notwithstanding the provisions of subclause (1)(b) a driver may park a vehicle in a permissive parking stall or station (except in a

parking area for people with disabilities) for twice the length of time allowed, provided that—

- (a) the driver's vehicle displays an ACROD sticker; and
- (b) a person with disabilities to which that ACROD sticker relates is either the driver of or a passenger in the vehicle."
- c. Clause 3.2 Restrictions on Parking in Particular Areas is amended.

Subclause (1) of this clause is amended by—

deleting the word "A" at the beginning of clause 3.2(1) and substituted with the words "Subject to subclause (2), a".

and further amended by the inclusion of the following-

"(d) if by a sign it is set apart for Disabled Persons and the vehicle does not display an "ACROD Sticker" which relates to either the driver or a passenger in the vehicle."

The following new subclause be inserted between subclauses (1) and (2)—

- "(2) (a) This subclause applies to a driver if—
 - (i) the driver's vehicle displays an ACROD sticker; and
 - (ii) a disabled person to which the ACROD sticker relates is either the driver of the vehicle or a passenger in the vehicle.
 - (b) The driver may park a vehicle in a thoroughfare or a part of a thoroughfare or part of a parking station, except in a thoroughfare or a part of a thoroughfare or part of a parking station to which a disabled parking sign relates for twice the period indicated on the sign."

Existing subclauses "(2)", "(3)", "(4)", "(5)" and "(6)" be renumbered to read "(3)", "(4)", "(5)", "(6)" and "(7)".

In renumbered subclause (7), amend "(5)" where it appears in the first line to read "(6)".

d. The Second Schedule is amended.

The Second Schedule is deleted and substituted with the following—

REGISTRATION OF POLITICAL PARTIES

Notice of Cancellation of Registration

Daylight Saving Party

".
