#### 1. Citation

These regulations are the *Children and Community Services Amendment Regulations 2008*.

#### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day on which the *Children and Community Services Amendment* (Reporting Sexual Abuse of Children) Act 2008 section 5 comes into operation.

#### 3. Regulations amended

These regulations amend the *Children and Community Services Regulations 2006*.

#### 4. Part 4A inserted

After regulation 8 insert:

## Part 4A — Reporting sexual abuse of children

#### 9A. Information to be included in report

(1) In this regulation —

**report** and **reporter** have the respective meanings given in section 124A.

- (2) For the purposes of section 124C(3)(e) a report is to contain the following information, to the extent that it is known to the reporter, in respect of any person alleged to be responsible for the sexual abuse
  - (a) the person's name;
  - (b) the person's contact details;
  - (c) the person's relationship to the child.

Town Planning Scheme No. 8—Scheme Amendment No. 89

It is hereby notified for public information, in accordance with Section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the Shire of Gingin's Town Planning Scheme Amendment No. 89 on 18 November 2008, for the purpose of—

- 1. Rezoning Lots 4, 5, 6 Gingin Road and Lot 191 corner Miragliotta Street in the locality of Lancelin from 'Fishing Industry' zone to 'Residential' zone with a density code of R40 as depicted on the Scheme Amendment Map.
- 2. Inserting the additional use 'A20' in Appendix 2 as follows—
  - 20 (a) Lots 4, 5, and 6 Gingin Road and Lot 191 Miragliotta Street, Lancelin.
    - (b) Holiday Accommodation, Shop, Restaurant and Office.
    - (c) i. Holiday Accommodation, Shop and Restaurant uses are permitted as an AA use.
      - ii. Office use is permitted as an IP use.
      - iii. All development on the site shall be in accordance with an outline development plan approved in accordance with the outline development plan provisions of the Scheme.
- 3. Modifying the Scheme Map to include the subject land as 'Residential' zone, allocating a density code of R40 and depicting the additional use 'A20'.
- 4. Inserting the following as clause 5.4 of the Scheme Text—

#### 5.4 OUTLINE DEVELOPMENT PLAN

- 5.4.1 The local government or the Western Australian Planning Commission may require the preparation of an outline development plan prior to considering any subdivision or development proposal in any zone.
- 5.4.2 Notwithstanding the requirements of this Scheme, all development is to comply with the requirements of any endorsed outline development plan/s.
- 5.4.3 Any departure or alterations to outline development plans may, subject to the approval of the Commission, be permitted if the local government considers that the proposed departure or alteration will not prejudice the progressive subdivision and development of the area.
- 5.4.4 A proposed outline development plan may, to the extent that it does not conflict with the Scheme, impose a classification on the land included in it by reference to reserves, zones or the Residential Design Codes, and where the proposed outline development plan becomes an outline development plan, the local government is to have due regard to such reserves, zones or Residential Design Codes when recommending subdivision or approving development of land within. In the absence of an endorsed outline development plan the symbols in the Zoning Table will apply.
- 5.4.5 Advertising of outline development plans—

The local government may within 30 days of receiving the outline development plan require that it be advertised in accordance with clause 6.4 of this Scheme.

5.4.6 Adoption of outline development plans—

Following adoption of the outline development plan, with or without modifications, the local government shall request the Commission to endorse the outline development plan as the basis for approval of subdivision applications within areas covered by the plan.

5.4.7 Right of Review—

The proponent of an outline development plan required by this Scheme may make application for review under Part 14 of the Planning & Development Act 2005—

- (a) The failure of the local government to make a determination on the content and requirement of an outline development plan (or an amendment to an outline development plan) within 120 days of receiving a request for direction;
- (b) A decision by the local government not to endorse an outline development plan (or an amendment to an outline development plan); and
- (c) Conditions of approval of the outline development plan (or an amendment to an outline development plan).
- 5. Renumbering the relevant clauses of Part V of the Scheme Text accordingly.
