Legal Profession Act 2008

Legal Profession Amendment Rules 2009

Made by the Legal Practice Board under Part 17 of the Act.

1. Citation

These rules are the *Legal Profession Amendment Rules* 2009.

2. Commencement

These rules come into operation as follows —

- (a) rules 1 and 2 on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules on the day after that day.

3. Rules amended

These rules amend the *Legal Profession Rules* 2009.

4. Rule 3A inserted

At the end of Part 1 insert:

3A. Supervised legal practice

- (1) This rule applies for the purposes of the definition, in section 3 of the Act, of *supervised legal practice* paragraph (f).
- (2) Legal practice is approved if it is engaged in in a capacity approved under rule 19 for the purposes of the definition, in section 50 of the Act, of *restricted legal practice* paragraph (f).

5. Rule 7A inserted

At the end of Part 2 Division 1 insert:

7A. Contributions to Guarantee Fund (s. 337)

For the purposes of section 337 of the Act the prescribed amount is \$20.

FISH RESOURCES MANAGEMENT ACT 1994

SOUTH WEST TRAWL MANAGEMENT PLAN AMENDMENT 2009

FD 344/02 [895]

Made by the Minister under section 54.

1. Citation

This instrument is the South West Trawl Management Plan Amendment 2009.

2. Commencement

The amendments in this instrument shall come into operation on 1 May 2009.

3. Management plan amended

The amendments in this instrument are to the South West Trawl Limited Entry Fishery Notice 1989*.

4. Clause 3 amended

In clause 3 insert in the correct alphabetical position—

"approved ALC" means an "approved automatic location communicator" as defined in regulation 55A:

"approved directions" has the same meaning as in regulation 55A;

"calendar year" means the period of twelve months commencing on 1 January in any year;

"closed waters" means any waters of the Fishery in which fishing is prohibited;

"nomination" means a nomination sent to the Department via an approved ALC;

"Port Areas" means the areas specified in Schedule 2A;

"underway" means that a boat is not at anchor, or made fast to the shore or aground;

5. Clause 7 amended

In clause 7(1)—

- (a) in paragraph (a)(i) delete "2(1)" and insert—
 "2(a)"
- (b) in paragraph (a)(ii) delete "2(1)" and insert—"2(a)"
- (c) in paragraph (b)(i) delete "2(2)" and insert—"2(b)"
- (d) in paragraph (b)(ii) delete "2(2)" and insert—"2(b)"
- (e) in paragraph (c)(i) delete "2(3)" and insert—"2(c)"
- (f) in paragraph (c)(ii) delete "2(3)" and insert— "2(c)"
- (g) in paragraph (d) delete "2(4)" and insert: "2(d)"

6. Clause 10 replaced

Delete clause 10 and insert—

"Closure of Fishery

- 10. A person must not take, or attempt to take, fish by means of an otter trawl net in—
 - (a) a Port Area at any time;
 - (b) the waters described in item 2(c) of Schedule 1 at any time;
 - (c) all the waters described in item 1 of Schedule 2 at any time;
 - (d) the waters described in item 2(a) of Schedule 1 during the period commencing on 15 November and ending on 31 December in any year;
 - (e) the waters described in item 2(a) of Schedule 2 during the period commencing 15 November and ending on 31 December in any year; and
 - (f) the waters described in item 2(b) of Schedule 2 during the period commencing on 1 December in any year and ending on 31 January the following year."

7. Clauses 10B and 10C inserted

After clause 10A insert the following clauses—

"Requirements relating to the installation of an ALC

- 10B. (1) A person must not use an authorised boat in the Fishery unless—
 - (a) an approved ALC has been installed in that boat in accordance with the approved directions;
 - (b) an approved ALC has been serviced and is being used in accordance with the approved directions; and
 - (c) a legible copy of the approved directions is kept onboard the authorised boat at all times.
- (2) It is a condition of a licence that the authorised boat must not be used in the Fishery unless an approved ALC has been installed, serviced and used in accordance with the approved directions.
- (3) It is a condition of a licence that regulations 55C and 55D are complied with at all times.

Requirements relating to nominations to be given by an ALC

- **10C.** (1) The master of an authorised boat must not use that boat—
 - (a) to enter into or fish in the waters of the Fishery; or
 - (b) outside a Port Area within the waters of the Fishery,
- at any time when any part of the Fishery is open to fishing unless—
 - (c) the Department has received from the master of that boat a nomination of intention to enter into or fish in the Fishery; and
 - (d) the nomination is current.
- (2) Where the Department receives a nomination pursuant to subclause 1 in any calendar year, that nomination is current for the remainder of the calendar year unless— $\,$
 - (a) the Department receives a nomination from the master of that boat cancelling the nomination; or
 - (b) the boat leaves the waters of the Fishery.
- (3) Where the master of an authorised boat has made a nomination in accordance with subclause 1, the master of that authorised boat must not allow that boat to enter or be underway in closed waters when any part of the Fishery is open to fishing unless the Department has received a nomination to enter or be underway in closed waters, not more than one hour before the boat entered or is underway in those waters.
- (4) A nomination made pursuant to subclause 3 expires when the authorised boat leaves closed waters.
- (5) A nomination to the Department made under this clause must be made using an approved ALC in accordance with the approved directions.
- (6) All nominations specified in the approved directions must be complied with."

8. Clause 11 amended

In Clause 11(2)—

- (a) in paragraph (b) delete "remainder," and insert:
 - "remainder."
- (b) delete "except that an otter trawl net when used in the scallop seasonal area described in item 2(3) of Schedule 1 during the period commencing on 1 July and ending on 30 September in any year shall have meshes not less than 100 millimetres.".

9. Clause 19 amended

In clause 19—

- (a) in paragraph (a) after "10," insert:
 - "10B(1)(a), 10C(3),"
- (b) in paragraph (b) after "10A," insert:
 - "10B(1)(b), 10B(1)(c), 10C(1), 10C(5) or 10C(6),"

10. Schedules 1 and 2 replaced, and Schedule 2A inserted

Delete Schedule 1 and Schedule 2 and insert—

"Schedule 1 Description of the Fishery

1. All waters of the Indian Ocean bounded by a line commencing at the intersection of 31°43.38' south latitude and 115°00.28' east longitude; thence extending generally southerly along the geodesic to the intersection of 31°47.93' south latitude and 115°01.09' east longitude; thence extending generally south easterly along the geodesic to the intersection of 31°57.93' south latitude and 115°13.09' east longitude; thence extending generally south westerly along the geodesic to the intersection of 32°15.93' south latitude and 115°05.09' east longitude; thence extending generally south westerly along the geodesic to the intersection of 32°40.93' south latitude and 114°48.87' east longitude; thence extending generally south westerly along the geodesic to the intersection of 32°52.93' south latitude and 114°41.09' east longitude; thence extending generally south westerly along the geodesic to the intersection of 33°09.93' south latitude and 114°34.09' east longitude; thence extending generally south westerly along the geodesic to the intersection of 33°29.93' south latitude and 114°29.09' east longitude; thence extending generally southerly along the geodesic to the intersection of 33°59.93' south latitude and 114°27.09' east longitude; thence extending generally southerly along the geodesic to the intersection of 34°19.93' south latitude and 114°30.09' east longitude; thence extending generally south easterly along the geodesic to the intersection of 34°40.93' south latitude and 114°40.09' east longitude; thence extending generally south easterly along the geodesic to the intersection of 34°51.93' south latitude and 114°50.09' east longitude; thence extending generally south easterly along the geodesic to the intersection of 34°57.93' south latitude and 115°00.09' east longitude; thence extending generally south easterly along the geodesic to the intersection of 35°00.93' south latitude and 115°08.08' east longitude; thence extending north along the meridian to the intersection of 34°22.57' south latitude and the high water mark at Cape Leeuwin (115°08.08' east longitude); thence extending north westerly, northerly, south easterly, easterly, north easterly along the high water mark to its intersection with 31°52.73' south latitude (115°45.11' east longitude) (south eastern corner of Marmion Marine Park); thence extending west along the parallel to the intersection of 31°52.73' south latitude and 115°41.49' east longitude; thence extending generally north westerly along the geodesic to the intersection of 31°43.38' south latitude and 115°39.09' east longitude; thence extending west along the parallel to the commencement point.

2. The waters within the Fishery shall be divided into zones as follows—

(a) Zone A
