



Local Government (Augusta-Margaret River - New Wards) Order 2009

Made by the Governor in Executive Council on the recommendation of the Minister for Local Government.

1. Citation

This order is the *Local Government (Augusta-Margaret River - New Wards) Order 2009*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Terms used

In this order —

commencement day means the day on which the rest of the order comes into operation under clause 2(b);

continuing councillor means a councillor on the council of the Shire of Augusta-Margaret River whose term of office as councillor continues beyond next election day;

district means the district of Augusta-Margaret River;

Leeuwin Ward, except in clauses 4(2) and 7(2) (first occurrence), means the Leeuwin Ward mentioned in clause 5(1):

Margaret River Ward means the Margaret River Ward mentioned in clause 5(1);

next election means the first ordinary election for the Shire of Augusta-Margaret River held after commencement day;

next election day means the day fixed for the holding of the poll for the next election;

North Ward means the North Ward mentioned in clause 5(1).

4. Abolition of existing wards (s. 2.2(1)(d) of the Act)

- (1) All of the wards into which the district is divided are abolished immediately before next election day.
- (2) Those wards are the Chapman Ward, the Cowaramup Ward, the Leeuwin Ward and the Margaret River Town Ward.

5. Division into new wards (s. 2.2(1)(a) of the Act)

- (1) On and from next election day the district is divided into the following wards
 - (a) the Leeuwin Ward;
 - (b) the Margaret River Ward;
 - (c) the North Ward.
- (2) The Leeuwin Ward consists of the land described in Schedule 1 Division 1.
- (3) The Margaret River Ward consists of the land described in Schedule 1 Division 2.
- (4) The North Ward consists of the land described in Schedule 1 Division 3.

6. Number of councillors for new wards (s. 2.18(3)(b) of the Act)

- (1) The number of offices of councillor for the Leeuwin Ward is 2.
- (2) The number of offices of councillor for the Margaret River Ward is 2.
- (3) The number of offices of councillor for the North Ward is 3.

7. Continuing councillors allocated to new wards (s. 9.62 of the Act)

- (1) A continuing councillor who was a councillor for the Chapman Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the North Ward.
- (2) A continuing councillor who was a councillor for the Leeuwin Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the Leeuwin Ward
- (3) A continuing councillor who was a councillor for the Margaret River Town Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the Margaret River Ward.
- (4) For the avoidance of doubt, it is declared that this clause does not affect the term of office of any continuing councillor.

8. Consequential directions (s. 9.62 of the Act)

In order to give effect to clauses 4, 5 and 6 —

- (a) Part 4 of the Act applies to preparing for and conducting the next election as if the changes effected by those clauses take effect on commencement day; and
- (b) the operation of Part 4 of the Act is modified to the extent necessary for the purposes of paragraph (a).

Division 1 — Leeuwin Ward

All that portion of land bounded by lines starting from the intersection of the low water mark of the Indian Ocean with the prolongation northwesterly of the centreline of Redgate Road, a point on a present western boundary of the Shire of Augusta-Margaret River, and extending southeasterly to and generally southeasterly, generally northeasterly, generally easterly, again generally northeasterly and again generally easterly along that centreline and onwards to the centreline of Bussell Highway; thence generally southeasterly along that centreline to the prolongation westerly of the centreline of Davis Road; thence easterly to and generally easterly along that centreline to the prolongation southerly of the centreline of Rowe Road; thence northerly to and northerly, generally northwesterly, generally northerly and again generally northwesterly along that centreline to the prolongation southwesterly of the centreline of the eastern section of Mill Road; thence northeasterly to and generally northeasterly along that centreline to the prolongation southwesterly of the easternmost southeastern boundary of the southern severance of Lot 4803, as shown on Deposited Plan 187217; thence northeasterly to and along that boundary and onwards to the centreline of Pilgrim Road; thence northwesterly, northerly, again northwesterly and westerly along that centreline and onwards to the centreline of Rowe Road; thence generally northerly and northwesterly along that centreline and onwards to the prolongation southwesterly of the centreline of Wallis Road; thence northeasterly to and generally northeasterly along that centreline and onwards to the centreline of Rosa Brook Road; thence generally northeasterly along that centreline to the prolongation southeasterly of the centreline of Barrett Road; thence northwesterly to and generally northwesterly along that centreline to the prolongation southeasterly of the centreline of Jackson Road; thence northwesterly to and along that centreline and onwards to the centreline of the Margaret River; thence generally northeasterly, generally easterly, again generally northeasterly and generally southeasterly upwards along that centreline to the prolongation northeasterly of the centreline of Watervale Road; thence southwesterly to and along that centreline to the prolongation northwesterly of the westernmost southwestern boundary of Lot 300 (Class 'A' Reserve 45952), as shown on Deposited Plan 43035; thence southeasterly to and southeasterly, easterly, northerly, again easterly, again southeasterly and southerly along boundaries of that lot to a northwestern side of the western section of Mowen Road (unsurveyed and undedicated); thence generally northeasterly along the northwestern sides of that road and onwards to the centreline of Sues Road; thence southwesterly along that centreline to the prolongation southwesterly of the westernmost northwestern side of the eastern section of Mowen Road (unsurveyed and undedicated), a point on a present eastern boundary of the Shire of Augusta-Margaret River; and thence generally southwesterly, generally southerly, generally westerly, southerly, again generally westerly, again generally southwesterly, generally northwesterly and generally northerly along boundaries of that shire to the starting point.

Including islands adjacent.

Division 2 — Margaret River Ward

All that portion of land bounded by lines starting from the intersection of a southwestern side of Darch Road with a northern side of Rosa Brook Road and extending westerly, generally northwesterly and again westerly along sides of Rosa Brook Road to the southern corner of Lot 2000 (Reserve 48184), as shown on Deposited Plan 41569; thence westerly to the southernmost southeastern

corner of that lot; thence westerly along the southernmost southern boundary of that lot and onwards to the southernmost southeastern corner of Lot 106, as shown on Deposited Plan 159762; thence westerly along the southern boundary of that lot and onwards to the northernmost northeastern boundary of Lot 4643 (Reserve 47016), as shown on Deposited Plan 195471; thence northwesterly and southwesterly along boundaries of that lot to the prolongation easterly of the southern boundary of Sussex Location 942, as shown on Deposited Plan 137841; thence westerly to and along that boundary and westerly along the southern boundary of the southernmost southeastern severance of Location 941, as shown on Deposited Plan 137840, and onwards to the easternmost northeastern corner of Lot 2 as shown on Diagram 85101; thence westerly and northerly along northern and eastern boundaries of that lot and onwards to the southeastern corner of the southern severance of Lot 996 (Reserve 18838), as shown on Deposited Plan 231028; thence northerly along the easternmost eastern boundary of that severance to the southwestern corner of Lot 201 (Reserve 37737), as shown on Deposited Plan 186263; thence southeasterly along the southwestern boundary of that lot and onwards to the centreline of Terry Road; thence northeasterly along that centreline and onwards to the centreline of Railway Terrace; thence generally northwesterly, generally northerly, easterly and generally northeasterly along that centreline and onwards to the centreline of the western section of Ashton Street; thence easterly along that centreline and onwards to a southwestern boundary of a central severance of Lot 352 (Class 'A' Reserve 47956), as shown on Deposited Plan 36437; thence generally southeasterly, northeasterly, northwesterly, again northeasterly, easterly, again northeasterly, southeasterly and generally northeasterly along boundaries of that severance to the prolongation westerly of the northernmost northern boundary of the eastern severance of Lot 352; thence easterly to and along that boundary to the prolongation northerly of the eastern boundary of Lot 101 (Reserve 19508), as shown on Deposited Plan 159747; thence southerly to and along that boundary and onwards to the centreline of the Margaret River; thence generally southerly, generally northeasterly and generally southeasterly upwards along that centreline to the prolongation northwesterly of the northernmost southwestern side of Darch Road, and thence southeasterly to and generally southeasterly, generally southwesterly and again generally southeasterly along sides of that road to the starting point.

Division 3 — North Ward

All that portion of land bounded by lines starting from the intersection of the low water mark of the Indian Ocean with the prolongation northwesterly of the centreline of Redgate Road, a point on a present western boundary of the Shire of Augusta-Margaret River, and extending southeasterly to and generally southeasterly, generally northeasterly, generally easterly, again generally northeasterly and again generally easterly along that centreline and onwards to the centreline of Bussell Highway; thence generally southeasterly along that centreline to the prolongation westerly of the centreline of Davis Road; thence easterly to and generally easterly along that centreline to the prolongation southerly of the centreline of Rowe Road; thence northerly to and northerly, generally northwesterly, again generally northerly and again generally northwesterly along that centreline to the prolongation southwesterly of the centreline of the eastern section of Mill Road; thence northeasterly to and generally northeasterly along that centreline to the prolongation southwesterly of the easternmost southeastern boundary of the southern severance of Lot 4803, as shown on Deposited Plan 187217; thence northeasterly to and along that boundary and onwards to the centreline of Pilgrim Road; thence northwesterly, northerly, again northwesterly and westerly along that centreline and onwards to the centreline of Rowe Road; thence generally northerly and northwesterly along that centreline and onwards to the prolongation

southwesterly of the centreline of Wallis Road; thence northeasterly to and generally northeasterly along that centreline and onwards to the centreline of Rosa Brook Road; thence generally northeasterly along that centreline to the prolongation southeasterly of the centreline of Barrett Road; thence northwesterly to and generally northwesterly along that centreline to the prolongation southeasterly of the centreline of Jackson Road; thence northwesterly to and along that centreline and onwards to the centreline of the Margaret River; thence generally northeasterly, generally easterly, again generally northeasterly and generally southeasterly upwards along that centreline to the prolongation northeasterly of the centreline of Watervale Road; thence southwesterly to and along that centreline to the prolongation northwesterly of the westernmost southwestern boundary of Lot 300 (Class 'A' Reserve 45952), as shown on Deposited Plan 43035; thence southeasterly to and southeasterly, easterly, northerly, again easterly, again southeasterly and southerly along boundaries of that lot to a northwestern side of the western section of Mowen Road (unsurveyed and undedicated); thence generally northeasterly along the northwestern sides of that road and onwards to the centreline of Sues Road, thence southwesterly along that centreline to the prolongation southwesterly of the westernmost northwestern side of the eastern section of Mowen Road (unsurveyed and undedicated), a point on a present southern boundary of the Shire of Augusta-Margaret River, and thence generally northeasterly, generally westerly and generally southerly along boundaries of that shire to the starting point.

This order is the *Local Government (Chapman Valley - Ward Boundaries) Order 2009.*

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Change of ward boundaries (s. 2.2(1)(c) of the Act)

- (1) The boundaries of the South West Ward of the district of Chapman Valley are changed by excluding from the area of the ward the land described in Schedule 1.

In this order —

commencement day means the day on which the rest of the order comes into operation under clause 2(b);

district means the district of Gosnells;

next election means the first ordinary election for the City of Gosnells held after commencement day;

next election day means the day fixed for the holding of the poll for the next election.

4. Abolition of wards (s. 2.2(1)(d) of the Act)

All of the wards into which the district is divided are abolished immediately before next election day.

5. Consequential directions (s. 9.62 of the Act)

In order to give effect to clause 4 —

- (a) on and from next election day each councillor on the council of the City of Gosnells whose term expires in 2011 is to be taken to have been elected as if the district had not been divided into wards when the councillor was elected; and
- (b) Part 4 of the Act otherwise applies to preparing for and conducting the next election as if the changes effected by clause 4 take effect on commencement day; and

Made by the Governor in Executive Council on the recommendation of the Minister for Local Government.

1. Citation

This order is the *Local Government (Kalamunda - New Wards) Order 2009*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which the order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Terms used

In this order —

commencement day means the day on which the rest of the order comes into operation under clause 2(b);

continuing councillor means a councillor on the council of the Shire of Kalamunda whose term of office as councillor continues beyond next election day;

district means the district of Kalamunda;

next election means the first ordinary election for the Shire of Kalamunda held after commencement day;

next election day means the day fixed for the holding of the poll for the next election.

4. Abolition of existing wards (s. 2.2(1)(d) of the Act)

- (1) All of the wards into which the district is divided are abolished immediately before next election day.
- (2) Those wards are the East Ward, the North Ward, the North West Ward, the South Ward and the South West Ward.

5. Division into new wards (s. 2.2(1)(a) of the Act)

 - (a) the North Ward;
 - (b) the North West Ward;
 - (c) the South East Ward;

7. Continuing councillors allocated to new wards (s. 9.62 of the Act)

- (1) A continuing councillor who was a councillor for the East Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the South East Ward mentioned in clause 5(1).
- (2) A continuing councillor who was a councillor for the North Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the North Ward mentioned in clause 5(1).
- (3) A continuing councillor who was a councillor for the North West Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the North West Ward mentioned in clause 5(1).
- (4) A continuing councillor who was a councillor for the South Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the South East Ward mentioned in clause 5(1).

- (5) A continuing councillor who was a councillor for the South West Ward immediately before its abolition under clause 4(1) is, on and from next election day, to be taken to have been elected as a councillor for the South West Ward mentioned in clause 5(1).
- (6) For the avoidance of doubt, it is declared that this clause does not affect the term of office of any continuing councillor.

On and from next election day, the number of offices of councillor on the council of the Shire of Merredin is 9.


