Under the *National Gas Access (WA) (Part 3) Regulations 2009* regulation 2, the provisions of those regulations come into operation when the *National Gas Access (WA) Act 2009* Part 3 comes into operation.

Under the *National Gas Access (WA) Adoption of Amendments Order 2009* clause 2, the provisions of that order come into operation when the *National Gas Access (WA) Act 2009* Part 2 comes into operation.

Under the *Economic Regulation Authority (National Gas Access Funding) Regulations 2009* regulation 2(b), the provisions of those regulations, other than regulations 1 and 2, come into operation when the *National Gas Access (WA) Act 2009* Part 2 comes into operation.

Under the *Corporations (Ancillary Provisions) Amendment Regulations 2009* regulation 2, the provisions of those regulations come into operation when the *National Gas Access (WA) Act 2009* Part 7 Division 1 comes into operation.

Under the *Energy Arbitration and Review Repeal Regulations 2009* regulation 2, the provisions of those regulations come into operation when the *National Gas Access (WA) Act 2009* Part 7 Division 1 comes into operation.

Under the *Supreme Court Amendment Rules (No. 3) 2009* rule 2, the provisions of those rules come into operation when the *National Gas Access (WA) Act 2009* Part 2 comes into operation.

Under the *Electricity Industry (Wholesale Electricity Market) Amendment Regulations 2009* regulation 2, the provisions of those regulations come into operation when the *National Gas Access (WA) Act 2009* Part 3 comes into operation.
