### **CONSUMER AFFAIRS ACT 1971**

ORDER PROHIBITING SUPPLY OF GOODS

- I, Anne Marie Driscoll, Commissioner for Consumer Protection in the State of Western Australia-
  - being satisfied that a Consumer Affairs Authority, namely Craig Emerson, Minister for Competition Policy and Consumer Affairs in the Commonwealth Government of Australia,

has, by notice dated 22 January 2010 and published in the *Commonwealth of Australia Gazette* on 25 January 2010, made an Order or similar instrument ("the Corresponding Order") prohibiting the supply of goods described in the Schedule hereto; and

- considering it necessary in the interests of the safety of the public;
- Order pursuant to section 23R(2) of the Consumer Affairs Act 1971 that the supply to consumers of goods described in the Schedule below is banned in this State permanently; and
- Further Order that this Order shall take effect upon the date of gazettal.

## CHARITABLE TRUSTS ACT 1962

THE JOYCE HENDERSON TRUST FUND

Take notice that on Wednesday 17 March 2010 at 10.30 am the Supreme Court of Western Australia will hear an application under section 18 of the *Charitable Trusts Act 1962* to approve a scheme for the variation of the terms of the Joyce Henderson Trust Fund.

The Joyce Henderson Trust Fund was established by the Will of Emily Joyce Brown Henderson (nee Brushfield) who died on 19 December 2001. Pursuant to the terms of the trust, the Fund was to be used for the purposes of—

- 1. research in childhood eye injuries; and
- 2. assisting with the day to day running costs of the northern suburbs branch of the Child Accident Prevention Foundation of Western Australia at Bassendean called "Olive House".

The scheme proposes that the purposes of the trust be varied by providing that the capital and income of the Fund be applied (for a period of at least 30 years from 19 December 2001) for the following purposes in substitution for the purposes referred to above—

- (a) research into childhood injury prevention including eye injuries in Western Australia;
- (b) childhood injury prevention education in Western Australia;
- (c) the promotion of awareness of childhood injury prevention in Western Australia; and
- (d) the provision of financial assistance to Kidsafe Western Australia (Inc).

If you wish to oppose the scheme you must give written notice to the Principal Registrar of the Supreme Court (Stirling Gardens, Barrack Street, Perth, 6000), the Attorney General of Western Australia (c/- State Solicitor's Office, Level 16, 141 St Georges Terrace, Perth, 6000) and the trustee of the Fund (The Joyce Henderson Trustee (Inc), corner of Thomas Street and Roberts Road, Subiaco, 6008) not less than 7 clear days before 17 March 2010. A copy of the proposed scheme can be obtained from the trustee at the above address.
