#### **CONSUMER AFFAIRS ACT 1971**

ORDER PROHIBITING SUPPLY OF GOODS

- I, Anne Driscoll, Commissioner for Consumer Protection in the State of Western Australia—
  - being satisfied that a Consumer Affairs Authority, namely Craig Emerson, Minister for Competition Policy and Consumer Affairs in the Commonwealth Government of Australia, has, by notice dated 26 February 2010 and published in the Commonwealth of Australia Gazette on 2 March 2010, made an Order or similar instrument ("the Corresponding Order") prohibiting the supply of goods described in the Schedule hereto; and
  - considering it necessary in the interests of the safety of the public;
  - Order pursuant to section 23R(2) of the Consumer Affairs Act 1971 that the supply to consumers of goods described in the Schedule below is prohibited in this State; and
  - Further Order that this Order shall take effect upon the date of Gazettal.

that-

- (d) are intended for use by children up to and including 36 months of age;
- (e) contain, or that have a component which contains, more than 1% by weight of the chemical identified by the unique Chemical Abstract Service (CAS) Number 117-81-7 (also known as Diethylhexyl phthalate (DEHP), Di(2-ethylhexyl) phthalate and Bis(2-ethylhexyl)phthalate); and
- (f) are, or have a component containing more than 1% by weight of the chemical identified by the unique Chemical Abstract Service (CAS) Number 117-81-7 that is, readily able to be sucked and/or chewed by children up to and including 36 months of age;

#### but excluding—

- (g) clothing and footwear;
- (h) sporting goods;
- (i) flotation aids and aquatic toys for the specific purpose of assisting a supervised child to float or swim in water; and
- (j) second hand goods.


