#### APPROVAL OF AMENDMENTS TO GAS RETAIL MARKET SCHEME

The Authority, pursuant to Section 11ZOM of the *Energy Coordination Act 1994*, hereby gives notice that the following amendment to the retail market scheme operated by the Retail Energy Market Company Limited ("REMCo") has been approved—Rule Change C03/09R.

On 1 October 2009, REMCo transferred its South Australian ("SA") operations to the Australian Energy Market Operator and became a solely Western Australian ("WA") operational entity. Rule Change C03/09R removes inoperative SA provisions in the Retail Market Rules ("Rules") and amends Chapter 6 of the Rules so that existing compliance provisions align with the new WA-only REMCo Board composition. In addition, Rule Change C03/09R adds clarity on the application of the compliance mechanisms to pipeline operators and prescribed persons.

Rule Change C03/09R is to take effect from 16 April 2010.

PROHIBITION ON RECREATIONAL FISHING (SHOALWATER ISLANDS MARINE PARK) ORDER 2010

Order No. 5 of 2010

FD 1620/98 [959]

Made by the Minister under section 43.

#### 1. Citation

This order is the Prohibition on Recreational Fishing (Shoalwater Islands Marine Park) Order 2010.

#### 2. Interpretation

In this order unless the contrary intention appears—

- "General Use Area" means the area specified in Schedule 5;
- "Sanctuary Area" means all the areas specified in Schedule 2;
- "Saxon Ranger Wreck Site Area" means the area specified in Schedule 4;
- "Shoalwater Islands Marine Park" means the waters of the area specified in Schedule 1;
- "Special Purpose Area" means all the areas specified in Schedule 3.

#### 3. Prohibition on recreational fishing

A person must not engage in recreational fishing by any means in the waters of the Shoalwater Islands Marine Park.

#### 4. Exceptions to prohibition

Clause 3 does not apply to a person engaged in an activity specified in Schedule 6.

#### Schedule 1

#### **Shoalwater Islands Marine Park**

All waters bounded by a line commencing west northwest of Cape Peron at the intersection of 32° 15.660' south latitude and 115° 40.089' east longitude; thence generally north easterly along the geodesic to the intersection with 32° 14.831' south latitude and 115° 42.093' east longitude and the causeway extending from Garden Island to the mainland; thence generally south easterly and south westerly along the western side of the causeway to the intersection with 32° 16.178' south latitude; thence west along the parallel to the intersection with the high water mark on the mainland; thence generally westerly and southerly along the high water mark of Shoalwater Bay, Safety Bay and Warnbro Sound to the intersection with 115° 43.889' east longitude; thence north along the meridian to the intersection with 32° 21.710' south latitude; thence westerly along the geodesic to the intersection with 32° 21.694' south latitude and 115° 43.089' east longitude; thence south along the meridian to the intersection with the high water mark on the mainland; thence generally westerly, southerly and south easterly along the high water mark to the intersection with 32° 22.594' south latitude; thence west along the parallel to the intersection with 115° 40.089' east longitude; thence north along the meridian to the commencement point.

# Schedule 2 Sanctuary Areas

#### **Becher Point Sanctuary Area**

All waters bounded by a line commencing north west of Becher Point at the intersection of  $32^{\circ}$  21.333' south latitude and  $115^{\circ}$  41.400' east longitude; thence east along the parallel to the intersection with  $115^{\circ}$  42.500' east longitude; thence south along the meridian to its intersection with  $32^{\circ}$  22.133' south latitude; thence west along the parallel to the intersection with  $115^{\circ}$  41.400' east longitude; thence north along the meridian to the commencement point.

#### Seal Island Sanctuary Area

All waters bounded by a line commencing north of Penguin Island at the intersection of  $32^{\circ}$  17.483' south latitude and  $115^{\circ}$  41.300' east longitude; thence generally east north-easterly along the geodesic to the intersection with  $32^{\circ}$  17.283' south latitude and  $115^{\circ}$  41.933' east longitude; thence south along the meridian to the intersection with  $32^{\circ}$  17.833' south latitude; thence west along the parallel to the intersection with  $115^{\circ}$  41.300' east longitude; thence north along the meridian to the commencement point.

#### Second Rock Sanctuary Area

All waters bounded by a line commencing south of Penguin Island at the intersection of 32° 18.933' south latitude and 115° 41.400' east longitude; thence east along the parallel to the intersection with 115° 42.000' east longitude; thence south along the meridian to the intersection with 32° 19.233' south latitude; thence west along the parallel to the intersection with 115° 41.400' east longitude; thence north along the meridian to the commencement point.

# Murray Reef Special Purpose Area (Scientific Reference)

#### Schedule 4

#### Saxon Ranger Wreck Site Area

All the waters bounded by a line commencing at the intersection of 32°19.67' south latitude and 115°42.37' east longitude; thence west along the parallel to the intersection of 115°42.25' east longitude; thence north along the meridian to the intersection of 32°19.55' south latitude; thence east along the parallel to the intersection of 115°42.37' east longitude; thence south along the meridian to the commencement point.

#### Schedule 5 General Use Area

All waters of the Shoalwater Islands Marine Park that are not a Sanctuary Area, a Special Purpose Area or a Saxon Ranger Wreck Site Area.

#### **Permitted Recreational Fishing Activities**

- 1. Fishing for abalone, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation);
- 2. Fishing for crab, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation);
- 3. Fishing for mussel, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation);
- 4. Fishing for octopus, by means of pots, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation);
- 5. Fishing for rock lobster, in the waters of the General Use Area, the Shoalwater Bay Special Purpose Area (Wildlife Conservation) and the Murray Reef Special Purpose Area (Scientific Reference);
- 6. Fishing by means of a haul net or throw net, in the waters of the General Use Area;
- 7. Fishing by line, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation);

8. Fishing by means of a pointed instrument, without the use of compressed air breathing apparatus, in the waters of the General Use Area.

Prohibition on Commercial Fishing (Shoalwater Islands Marine Park) Order 2010

Order No. 4 of 2010

FD 1620/98 [959]

Made by the Minister under section 43.

#### 1. Citation

This order is the Prohibition on Commercial Fishing (Shoalwater Islands Marine Park) Order 2010.

#### 2. Interpretation

In this order unless the contrary intention appears—

"coral" has the same meaning as in Schedule 7 to the Fish Resources Management Regulations 1995;

"General Use Area" means the area specified in Schedule 5;

"live rock" has the same meaning as in Schedule 7 to the Fish Resources Management Regulations 1995;

"marine aquarium fish" has the same meaning as in the Marine Aquarium Fish Management Plan 1995:

"Sanctuary Area" means all the areas specified in Schedule 2;

"Saxon Ranger Wreck Site Area" means the area specified in Schedule 4;

"Shoalwater Islands Marine Park" means the waters of the area specified in Schedule 1;

"Special Purpose Area" means all the areas specified in Schedule 3;

"specimen shell" has the same meaning as in the Specimen Shell Management Plan 1995.

#### 3. Prohibition on commercial fishing

A person must not fish for a commercial purpose by any means in the waters of the Shoalwater Islands Marine Park.

#### 4. Exceptions to prohibition

Clause 3 does not apply to a person who—

- 1. holds a commercial fishing licence; and
- 2. engages in an activity specified in Schedule 6.

#### Schedule 1

#### Shoalwater Islands Marine Park

All waters bounded by a line commencing west northwest of Cape Peron at the intersection of 32° 15.660' south latitude and 115° 40.089' east longitude; thence generally north easterly along the geodesic to the intersection with 32° 14.831' south latitude and 115° 42.093' east longitude and the causeway extending from Garden Island to the mainland; thence generally south easterly and south westerly along the western side of the causeway to the intersection with 32° 16.178' south latitude; thence west along the parallel to the intersection with the high water mark on the mainland; thence generally westerly and southerly along the high water mark of Shoalwater Bay, Safety Bay and Warnbro Sound to the intersection with 115° 43.889' east longitude; thence north along the meridian to the intersection with 32° 21.710' south latitude; thence westerly along the geodesic to the meridian to the intersection with latitude and 115° 43.089' east longitude; thence south along the meridian to the intersection with the high water mark on the mainland; thence generally westerly, southerly and south easterly along the high water mark to the intersection with 32° 22.594' south latitude; thence west along the parallel to the intersection with 115° 40.089' east longitude; thence north along the meridian to the commencement point.

## Schedule 2 Sanctuary Areas Becher Point Sanctuary Area

All waters bounded by a line commencing north west of Becher Point at the intersection of  $32^{\circ}$  21.333' south latitude and  $115^{\circ}$  41.400' east longitude; thence east along the parallel to the intersection with  $115^{\circ}$  42.500' east longitude; thence south along the meridian to its intersection with  $32^{\circ}$  22.133' south latitude; thence west along the parallel to the intersection with  $115^{\circ}$  41.400' east longitude; thence north along the meridian to the commencement point.

#### Seal Island Sanctuary Area

All waters bounded by a line commencing north of Penguin Island at the intersection of 32° 17.483' south latitude and 115° 41.300' east longitude; thence generally east north-easterly along the geodesic to the intersection with 32° 17.283' south latitude and 115° 41.933' east longitude; thence south along the meridian to the intersection with 32° 17.833' south latitude; thence west along the parallel to the intersection with 115° 41.300' east longitude; thence north along the meridian to the commencement point.

#### Second Rock Sanctuary Area

All waters bounded by a line commencing south of Penguin Island at the intersection of 32° 18.933' south latitude and 115° 41.400' east longitude; thence east along the parallel to the intersection with 115° 42.000' east longitude; thence south along the meridian to the intersection with 32° 19.233' south latitude; thence west along the parallel to the intersection with 115° 41.400' east longitude; thence north along the meridian to the commencement point.

#### Murray Reef Special Purpose Area (Scientific Reference)

#### Shoalwater Bay Special Purpose Area (Wildlife Conservation)

All waters bounded by a line commencing west of the south western portion of Cape Peron at the intersection of  $32^{\circ}$  16.271' south latitude and  $115^{\circ}$  41.128' east longitude; thence east along the parallel to the intersection with the high water mark on Cape Peron; thence generally easterly and southerly along the high water mark of Shoalwater Bay to the intersection with the geodesic joining the coordinates  $32^{\circ}$  18.317' south latitude and  $115^{\circ}$  42.133' east longitude on Mersey Point and  $32^{\circ}$  18.727' south latitude and  $115^{\circ}$  41.373' east longitude; thence generally south westerly along the geodesic to the intersection of  $32^{\circ}$  18.727' south latitude and  $115^{\circ}$  41.373' east longitude; thence generally northerly along the geodesic to the commencement point.

#### Schedule 4

#### Saxon Ranger Wreck Site Area

All the waters bounded by a line commencing at the intersection of 32°19.67' south latitude and 115°42.37' east longitude; thence west along the parallel to the intersection of 115°42.25' east longitude; thence north along the meridian to the intersection of 32°19.55' south latitude; thence east along the parallel to the intersection of 115°42.37' east longitude; thence south along the meridian to the commencement point.

#### Schedule 5 General Use Area

All waters of the Shoalwater Islands Marine Park that are not a Sanctuary Area, a Special Purpose Area or a Saxon Ranger Wreck Site Area.

#### Schedule 6

#### **Permitted Commercial Fishing Activities**

- Fishing for abalone, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation), in accordance with the Abalone Management Plan 1992;
- 2. Fishing for coral or live rock in the manner specified in clause 4 of the *Prohibition on Fishing* (Coral, 'Live Rock' and Algae) Order 2007;
- 3. Fishing for crab, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation), in accordance with the Warnbro Sound (Crab) Management Plan 1995:
- 4. Fishing for marine aquarium fish, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation), in accordance with the *Marine Aquarium Fish Management Plan 1995*;
- 5. Fishing for rock lobster, in the waters of the General Use Area, the Shoalwater Bay Special Purpose Area (Wildlife Conservation) and the Murray Reef Special Purpose Area (Scientific Reference), in accordance with the West Coast Rock Lobster Management Plan 1993;
- 6. Fishing for specimen shell, in the waters of the General Use Area and the Shoalwater Bay Special Purpose Area (Wildlife Conservation), in accordance with the Specimen Shell Management Plan 1995;
- 7. (a) Fishing by line, from a licensed fishing boat, in the waters of the General Use Area, in accordance with the Mackerel Fishery (Interim) Management Plan 2004, the West Coast Demersal Scalefish (Interim) Management Plan 2007 or the West Coast Demersal Gillnet and Demersal Longline (Interim) Management Plan 1994;
  - (b) Fishing by line, other than by troll line, longline or dropline, from a licensed boat, in the waters of the Shoalwater Bay Special Purpose Area (Wildlife Conservation), in accordance with the Mackerel Fishery (Interim) Management Plan 2004, the West Coast Demersal Scalefish (Interim) Management Plan 2007 or the West Coast Demersal Gillnet and Demersal Longline (Interim) Management Plan 1994;

- 8. Fishing by net, from a licensed fishing boat, in the waters of the General Use Area, in accordance with the West Coast (Beach Bait Fish Net) Management Plan 1995, the West Coast Demersal Scalefish (Interim) Management Plan 2007, the West Coast Demersal Gillnet and Demersal Longline (Interim) Management Plan 1994 or the West Coast Purse Seine Management Plan 1989;
- 9. Fishing by trawling, in the waters of the General Use Area, in accordance with the South West Trawl Management Plan 1989.
