### 5.29 Caretakers' Dwellings

5.29.1 The purpose and intent of the following provisions is to limit the scale of Caretakers' Dwellings in industrial areas.

- $5.29.2\,$  A Caretaker's Dwelling should be incidental to the predominant industrial use of the site.
- 5.29.3 Only one Caretaker's Dwelling is permitted on a lot and that dwelling should be on the same lot as the associated industrial use.
- 5.29.4 In the Fishing Industry Zone, a Caretaker's Dwelling is to have a total floor area that does not exceed 100 square metres measured from the external face of walls. Open verandahs may be permitted in the Fishing Industry Zone but must not be enclosed by any means unless the total floor area remains within 100 square metres.
- 5.29.5 Within the Industrial Zone a Caretakers' Dwelling shall only be permitted if included in Appendix 2 of the scheme as an additional use, with individual proposals to be considered on their merits.
- 5. Inserting into the Zoning Table the following land use permissibility for a Caretaker's Dwelling between Caravan Park and Child Minding Centre—
