WEST COAST ROCK LOBSTER MANAGEMENT PLAN
Amendment (No. 7) 2010

Made by the Minister under section 54.

1. Citation

This instrument is the *West Coast Rock Lobster Management Plan Amendment (No. 7) 2010*.

2. Management plan amended

The amendments in this instrument are to the *West Coast Rock Lobster Management Plan 1993*.

3. Clause 6 amended

In clause 6 after subclause (3) insert—

- (4) Despite subclause (1a), a person must not operate in the waters of Zone A from a Zone A boat at any time during the period commencing on 17 May 2010 and ending on 30 June 2010.

4. Clause 9G amended

In clause 9G delete “in respect of a Zone C boat during the period commencing on 10 May 2010 and ending on 30 June 2010.” and insert—

in respect of—

- (a) a Zone A boat during the period commencing on 17 May 2010 and ending on 30 June 2010; or
- (b) a Zone C boat on or before 30 June 2010.

5. Clause 9H replaced

Delete clause 9H and insert—

Exception to restrictions on the use of boats—transporting pots in Zone A

9H. (1) Subject to subclause (2), subclauses 9A(1), 9E(1) and 9E(4) do not apply on 14, 15 and 16 May 2010 to—

- (a) pulling;
- (b) bringing onto a Zone A boat; or
- (c) transporting on a Zone A boat,

an unbaited pot for the sole purpose of removing the pot from the waters of Zone A of the Fishery and transporting it to within half a nautical mile of the mainland or any of the Abrolhos Islands.

(2) Subclause (1) does not apply unless the master of the boat has, not less than 60 minutes before the commencement of the relevant voyage, provided verbal notice to the CEO by means of a telephone call to 1800 446 801 specifying—

- (a) the master’s full name;
- (b) the name and licensed fishing boat number of the boat;
- (c) the location and intended time of commencement of the voyage;
- (d) the number of persons that will be on board the boat;
- (e) the intended course and duration of the voyage; and
- (f) the location and intended time of termination of the voyage.
