#### **1. Citation**

This notice is the *Electricity Industry (Code of Conduct) (Pre-payment Meter Areas) Notice 2010*.

#### **2. Commencement**

This notice comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice — on 1 July 2010.

#### **3. Terms used**

In this notice —

***code of conduct*** means the code of conduct approved under section 79 of the Act;

#### **4. Pre-payment meter areas**

#### FISH RESOURCES MANAGEMENT ACT 1994

##### PILBARA FISH TRAWL INTERIM MANAGED FISHERY MANAGEMENT PLAN AMENDMENT 2010

FD 2234/99 [974]

Made by the Minister under section 54.

#### 1. Citation

This instrument may be cited as the *Pilbara Fish Trawl Interim Managed Fishery Management Plan Amendment 2010*.

#### 2. Management plan amended

The amendments in this instrument are to the *Pilbara Fish Trawl Interim Managed Fishery Management Plan 1997*.

**3. Clause 4 amended**

In clause 4 delete the definition of "licensing period" and insert—

"licensing period" means the period commencing on 1 July in a year and ending on 30 June in the following year;

**4. Clause 20 amended**

In clause 20 delete subclauses (1) and (1a) and insert—

- (1) At any time during the licensing period the extent of the entitlement arising from the fish trawl unit in—
- (a) Area 1 is 0.24 fish trawl hours, which entitles the holder of a permit that specifies Area 1 fish trawl units to use a fish trawl net for 0.24 hours in that Area for each one of those Area 1 units;
  - (b) Area 2 is 0.95 fish trawl hours, which entitles the holder of a permit that specifies Area 2 fish trawl units to use a fish trawl net for 0.95 hours in that Area for each one of those Area 2 units;
  - (c) Area 4 is 1.01 fish trawl hours, which entitles the holder of a permit that specifies Area 4 fish trawl units to use a fish trawl net for 1.01 hours in that Area for each one of those Area 4 units;
  - (d) Area 5 is 0.90 fish trawl hours, which entitles the holder of a permit that specifies Area 5 fish trawl units to use a fish trawl net for 0.90 hours in that Area for each one of those Area 5 units;
  - (e) Area 6 is 1.00 fish trawl hour, which entitles the holder of a permit that specifies Area 6 fish trawl units to use a fish trawl net for 1.00 hour in that Area for each one of those Area 6 units.

**5. Schedule 9 replaced**

Delete Schedule 9 and insert—

**Schedule 9****Payment by Instalments**

- (a) The first instalment is 25% of the total fee and is due for payment on or before 1 July of the year for which the permit is to be granted or renewed.
- (b) The second instalment is 25% of the total fee and is due for payment on or before 1 October immediately following the period specified in paragraph (a).
- (c) The third instalment is the total fee less the instalments provided for in paragraphs (a) and (b) and is due for payment on or before 1 January immediately following the period specified in paragraph (a).
