## Surveillance Devices Amendment Regulations 2010

Made by the Governor in Executive Council.

#### 1. Citation

These regulations are the Surveillance Devices Amendment Regulations 2010.

#### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

#### 3. Regulations amended

These regulations amend the *Surveillance Devices Regulations 1999*.

#### 4. Regulation 4 replaced

Delete regulation 4 and insert:

#### 4. Law enforcement officers, classes prescribed

For the purposes of paragraph (d) of the definition of *law enforcement officer* in section 3(1) of the Act, each of the following classes of persons is prescribed —

- (a) conservation and land management officers (as defined in the *Conservation and Land Management Act 1984* section 3);
- (b) forest officers (as defined in the *Conservation and Land Management Act 1984* section 3);
- (c) rangers (as defined in the *Conservation and Land Management Act 1984* section 3);
- (d) wildlife officers (as defined in the *Conservation* and Land Management Act 1984 section 3);
- (e) inspectors (as defined in the *Environmental Protection Act 1986* section 3(1)) who are officers or employees of a department, authority or agency of the State;
- (f) fisheries officers (as defined in the *Fish Resources Management Act 1994* section 4(1)) who are employed in the Serious Offences Unit of the Department As defined in section 4(1) of that Act).

# DANGEROUS GOODS SAFETY (ROAD AND RAIL TRANSPORT OF NON-EXPLOSIVES) REGULATIONS 2007

THE DANGEROUS GOODS SAFETY (ROAD AND RAIL TRANSPORT OF NON-EXPLOSIVES) DETERMINATION (NO. 2) 2010

This determination is made by the Chief Dangerous Goods Officer under Regulation 18(b) of the Dangerous Goods Safety (Road and Rail Transport of Non-Explosives) Regulations 2007 and may be cited as the Dangerous Goods Safety (Road and Rail Transport of Non-explosives) Determination (No. 2) 2010.

A person may transport mineral ores and concentrates classified as UN 3077 Environmentally Hazardous Substances, Solids, N.O.S. in sheeted bulk containers (BK1).

In this determination—

"sheeted bulk containers (BK1)" means open top bulk containers with rigid bottom (including hopper-type bottom), side and end walls and a non-rigid covering complying with the general provisions of section 4.3.1 of the Australian Code for the Transport of Dangerous Goods by Road and Rail, seventh edition.

Pursuant to section 6(1)(d) of the Salaries and Allowances Act 1975 the Salaries and Allowances Tribunal determines the remuneration to be paid to the holders of senior legal offices included in the Special Division of the Public Service.

The Tribunal has for a considerable time maintained a structure for senior legal officers which is different from that which applies to other Special Division and Prescribed Office holders. In reviewing its determination of 1 April 2010, the Tribunal has decided at this time to maintain the existing alignment of salaries for senior legal officers.

Accordingly, the Tribunal has determined that from 1 July 2010, senior legal officers in the Special Division of the Public Service are to receive a general increase of 2.5 per cent.

#### Determination

The determination of the Salaries and Allowances Tribunal made on 1 April 2010 under sections 6(1)(d) of the *Salaries and Allowances Act 1975*, as amended from time to time, is hereby varied by a further determination set out below effective from 1 July 2010.
