Made by the Minister under regulation 13(1) of the *Biosecurity and Agriculture Management Industry Funding Scheme (Cattle) Regulations 2010* on the recommendation of the Industry Management Committee.

1. Citation

This notice is the *Cattle Industry Declared Pest Control and Compensation Funding* Scheme (Area of Operation and Rate of Contributions) Notice (No. 2) 2010.

2. Earlier notice revoked

The Cattle Industry Declared Pest Control and Compensation Funding Scheme (Area of Operation and Rate of Contributions) Notice 2010 is revoked.

3. Area of Operations and Rate of Contributions

(1) In respect of the financial year 2010-11 I declare that—

- (a) the Scheme is to operate in the whole of the State; and
- (b) the rate at which contributions are to be paid under regulation 15 is—
 - (i) for the period beginning on 1 July 2010 and ending on 15 August 2010, nil per head of cattle or per carcass comprised in a chargeable sale; and
 - (ii) for the period beginning on 16 August 2010 and ending on 30 June 2011, \$0.20 per head of cattle or per carcass comprised in a chargeable sale.

(2) The estimated proportion of the contributions which the Cattle Industry Funding Scheme Management Committee projects is likely to be applied to fund payments relating to each specified pest is as follows—

- (a) Tuberculosis (*mycobacterium tuberculosis*): nil
- (b) Bovine Johnes disease (mycobacterium paratuberculosis): 40%
- (c) Enzootic bovine leucosis (bovine leucosis virus): 12.5%

This notice is the *Sheep and Goat Industry Declared Pest Control and Compensation Funding Scheme (Area of Operation and Rate of Contributions) Notice (No. 2) 2010.*

2. Earlier notice revoked

The Sheep and Goat Industry Declared Pest Control and Compensation Funding Scheme (Area of Operation and Rate of Contributions) Notice 2010 is revoked.

3. Area of Operations and Rate of Contributions

(1) In respect of the financial year 2010-11 I declare that—

- (a) for the period beginning on 1 July 2010 and ending on 15 August 2010-
 - (i) the Scheme is to operate in the whole of the State; and
 - (ii) the rate at which contributions are to be paid under regulation 15 is nil per head or per carcass comprised in a chargeable sale;

and

- (b) for the period beginning on 16 August 2010 and ending on 30 June 2011—
 - (i) the Scheme is to operate in the agricultural areas of the State, which are defined to include all municipal districts of Western Australia except for those comprising the Kimberley (municipal districts of Broome, Halls Creek, Derby-West Kimberley and Wyndham-East Kimberley) and the pastoral area (municipal districts of Ashburton, Carnarvon, Coolgardie, Cue, Dundas, East Pilbara, Exmouth, Laverton, Leonora, Kalgoorlie-Boulder, Meekatharra, Menzies, Mount Magnet, Murchison, Ngaanyatjarraku, Port Hedland, Roebourne, Sandstone, Shark Bay, Upper Gascoyne, Wiluna and Yalgoo); and
 - (ii) the rates at which contributions are to be paid under regulation 15 is \$0.12 per head or per carcass comprised in a chargeable sale.

(2) The estimated proportion of the contributions which the Sheep and Goat Industry Funding Scheme Management Committee projects is likely to be applied to fund payments relating to each specified pest is as follows—

1. Citation

This notice is the *Grains, Seeds and Hay Industry Declared Pest Control and Compensation Funding Scheme (Area of Operation and Rate of Contributions) Notice (No. 2) 2010.*

2. Earlier notice revoked

The Grains, Seeds and Hay Industry Declared Pest Control and Compensation Funding Scheme (Area of Operation and Rate of Contributions) Notice 2010 is revoked.

3. Area of Operations and Rate of Contributions

(1) In respect of the financial year 2010-11 I declare that—

- (a) for the period beginning on 1 July 2010 and ending on 15 August 2010-
 - (i) the Scheme is to operate in the whole of the State; and
 - (ii) the rate at which contributions are to be paid under regulation 15 is nil;

and

- (b) for the period beginning on 16 August 2010 and ending on 30 June 2011—
 - (i) the Scheme is to operate in the agricultural areas of the State, which are defined to include all municipal districts of Western Australia except for those comprising the Kimberley (municipal districts of Broome, Halls Creek, Derby-West Kimberley and Wyndham-East Kimberley) and the pastoral area (municipal districts of Ashburton, Carnarvon, Coolgardie, Cue, Dundas, East Pilbara, Exmouth, Laverton, Leonora, Kalgoorlie-Boulder, Meekatharra, Menzies, Mount Magnet, Murchison, Ngaanyatjarraku, Port Hedland, Roebourne, Sandstone, Shark Bay, Upper Gascoyne, Wiluna and Yalgoo); and
 - (ii) the rates at which contributions are to be paid under regulation 15 are—
 - (I) in respect of a chargeable transaction, the subject of which is grain or seed: \$0.30 per tonne; and
 - (II) in respect of a chargeable transaction, the subject of which is hay: nil.

(2) The estimated proportion of the contributions which the Grains, Seeds and Hay Industry Funding Scheme Management Committee projects is likely to be applied to fund payments relating to each specified pest is as follows—

- (a) Bedstraw (galium tricornutum): 9%
- (b) Skeleton weed (*chondrilla juncea L*.): 91%

- (b) adequate provision has been made for compensation from that account in relation to grain, seed, crop or bags destroyed in the course of steps taken under that Act to control skeleton weed or any plant diseases in respect of which a designation under the *Plant Pests and Diseases (Eradication funds) Act 1974* section 4(2) was in effect immediately before the coming into operation of section 68.
