LOCAL GOVERNMENT ACT 1995

City of Armadale

STREET NUMBERING LOCAL LAW 2010

Under the powers conferred by the *Local Government Act 1995* as amended from time to time the Council of the City of Armadale resolved on 23 August 2010 to make the City of Armadale Street Numbering Local Law 2010.

1. Title

This Local Law may be referred to as the City of Armadale Street Numbering Local Law 2010.

2. Commencement

This Local Law comes into operation 14 days after the date of its publication in the Government Gazette.

3. Repeal

The Armadale-Kelmscott Road Board Numbering of Housing and Buildings Local Law, prepared under the Road Districts Act 1919 adopted by the Armadale-Kelmscott Road Board at a meeting held on 21 November 1960 and as published in the Government Gazette on 20 December 1960 is repealed on the day this Local Law comes into operation.

4. Application of the Local Law

This Local Law applies to all the land throughout the district.

5. Interpretation

In this Local Law, unless the context requires otherwise—

- "authorised person" means a person authorised by the Local Government under Section 9.10 of the *Local Government Act 1995* to perform any of the functions of an authorised person under this Local Law;
- "notice of breach" means a notice referred to in Clause 9 of this Local Law;
- "street" means a public roadway in a town, city or urban area, especially a sealed thoroughfare with footpaths and buildings along one or both sides;
- "street number" means a number with or without an alphabetical suffix indicating the street address of land as assigned by the Local Government from time to time, in accordance with this Local Law.
- "urban" relates to an area which, by jurisdiction of the Local Government in accordance to the Australian/New Zealand Standards, requires application of urban street addressing. This includes simple (non-complex) address sites; complex (non-simple) address sites; utility addresses and ranged addresses, and includes locations which are defined by Clause 3.4.2 in the Australian/New Zealand Standards—Types of urban address. Industrial and commercial sites are included within the definition of complex address sites.

6. Assignment of street number

The Local Government or an authorised person shall assign a street number to each property in a street, thoroughfare or way in the district in accordance with its policy on street numbering so as to ensure unambiguous and easy identification of every individual property.

The Local Government or an authorised person may from time to time assign another street number to a property instead of that which was previously assigned, including all properties in a street whether previously numbered or not.

7. Street number to be displayed

The owner or occupier of each property shall display and maintain the current street number assigned by the Local Government, in a conspicuous place on the front of the building, letterbox, fence, retained wall, or kerb adjacent to the street fronting the property.

8. Location of number not to be misleading

A person shall not place or display a street number in such a location as to cause confusion or be misleading.

Where in the opinion of an authorised person the location of a street number causes confusion or is misleading, or an unauthorised street number is being used or displayed on a property, the Local Government or an authorised person may serve notice in writing on the owner or occupier of the land.

9. Notices of breach

(1)Where a breach of this Local Law has occurred in relation to street numbering, the Local Government may serve a notice on the owner or occupier of that property as per Section 3.25(1) Schedule 3.1(2) of the *Local Government Act 1995*—

- a. Specifying details of the breach of these Local Laws;
- b. Requiring the owner or occupier to remedy the breach within the time period specified in the notice; and
- c. Advising that where the owner or occupier fails to comply with the requirements of the notice, the local government or an authorised person may enter the property and undertake the required work.
- (2) Where the owner or occupier of the property fails to comply with the requirements of the notice, the local government may by its employees, agents or contractors enter upon the property and carry out all works and do all things necessary to comply with the requirements of the notice, in accordance to Section 3.26(2) of the *Local Government Act 1995*.
 - (i) The Local Government may recover the expenses incurred in carrying out the works in accordance with Section 3.26(3) of the *Local Government Act* 1995 from the owner or occupier of the property in a court of competent jurisdiction.

10. Offences and penalties

- (1) A person who fails to comply with a notice of breach commits an offence and is liable upon conviction to a maximum penalty of \$5000 and, if the offence is a continuing offence, a maximum daily penalty of \$500.
- (2) A person who fails to comply with or who contravenes any provision of this Local Law commits an offence and is liable to a maximum penalty of \$5000 and, if the offence is a continuing offence, a maximum daily penalty of \$500.

11. Modified penalties

- (1) An offence against any provision of this Local Law is a prescribed offence for the purposes of Section 9.16(1) of the *Local Government Act 1995*.
- (2) Unless otherwise specified, the amount of the modified penalty for an offence against any provision of these Local Laws is \$200.

12. Form of Notices

For the purposes of this Local Law—

- (a) the form of the infringement notice referred to in Section 9.17 of the Local Government Act 1995 is to be in or substantially in the form of Form 2 of Schedule 1 of the Local Government (Functions and General) Regulations 1996; and
- (b) the form of the notice referred to in section 9.20 of the Local Government Act 1995 is to be in or substantially in the form of Form 3 in Schedule 1 of the Local Government (Functions and General) Regulations 1996.

ENERGY COORDINATION ACT 1994

APPROVAL OF AMENDMENTS TO GAS RETAIL MARKET SCHEME

The Authority, pursuant to Section 11ZOM of the *Energy Coordination Act 1994*, hereby gives notice that the following amendment to the retail market scheme operated by the Retail Energy Market Company Limited ("REMCo") has been approved—Rule Change C02/10S.

On 1 October 2009, REMCo transferred its South Australian ("SA") operations to the Australian Energy Market Operator and became a solely Western Australian ("WA") operational entity. Rule Change C02/10S establishes a new version of Specification Pack for the WA and SA gas retail markets.

There are no systematic changes in this new version of the Specification Pack for the WA market. None of the existing transactions between the Gas Retail Market System and Market Participants have been changed for WA.

The proposed change will update the Specification Pack documents to promote their interchangeability and to reflect the current regulatory arrangements in the WA and SA gas retail markets.

The systemic changes to the Specification Pack will only have effect in SA, and relate to the commencement of the Short Term Trading Market in SA, which began on 1 September 2010.

Rule Change C02/10S is to take effect on 1 October 2010.

APPLICATION DETAILS

Central to any application made is the program of work proposed for each year of the six year term. Applications are to be made in accordance with Section 31 of the *Petroleum and Geothermal Energy Resources Act 1967*. Consideration of an application for the grant of a Petroleum Exploration Permit shall take into account work programs relative to the whole of the area applied for, the adequacy of the work program, and the applicant's technical and financial ability to undertake the work. Permits are awarded on the understanding that the first two years work commitment will be fulfilled without variation.

Where there is more than one applicant to the application, the percentage participating interests of each party to the application is to be supplied including evidence that a satisfactory settlement has been, or can be, reached on a Joint Operating Agreement (a copy of Heads of Agreement dealing will generally suffice). All applicant parties must provide supportable evidence of adequate financial capabilities to undertake the work bid and/or proven ability to raise funds for exploration purposes.

Applicants' attention is drawn to the provisions of Division 3A of the *Petroleum and Geothermal Energy Resources Act 1967* which provides for Petroleum and Geothermal titles to subsist in respect to the same blocks.

Applicants should also make themselves aware of the existence of any areas which have the potential to restrict exploration activities, e.g., National Parks, Nature Reserves, Marine Parks, World Heritage Areas, Conservation Reserves, Defence Areas and Mining Titles.

Insofar as Reserved Land is concerned, entry for exploration purposes is subject to approval by the Minister. In this regard, it should be noted that Government policy, at least, is such that petroleum extraction from within National Parks and Nature Reserves, and access to Conservation Estates should not be presumed.

In respect to internal waters areas, impacts on fishing activities should also be considered. Applicants should note that they will be required to initiate contact with relevant industry bodies concerning their exploration activities at the earliest possible stage when planning operations.

Any applications over the above on shore areas may be subject to the provisions of the Commonwealth Native Title Act 1993 and applicants should be prepared to negotiate with Native Title parties pursuant to the right to negotiate provisions of the NTA.

Applicants should also be aware that onshore areas available for petroleum application are subject (at least in part) to Native Title claims. Plans showing these claim boundaries are available as part of the release package.

An information package on the release areas detailing the criteria for assessment of applications and the conditions to apply following the award of a permit, and including a plan of the release areas and an application proforma, is available on CD-ROM. Copies of the CD-ROM can be obtained from the **Petroleum Division, Department of Mines and Petroleum** by contacting the Petroleum Applications Receiving Officer on (08) 9222 3269.

Special Notices

Additional environmental assessment is likely to be required for any future petroleum exploration in the following release areas—

AREA L10-6

Significant biodiversity values are associated with the release area, in particular the potential for marine turtle nesting / foraging activity and migratory shorebird habitat to occur within the area.

Successful applicants should note that Eighty Mile Beach, which partially occurs within the release area, is a Ramsar wetland containing significant migratory bird habitat.

AREA L10-11

Successful applicants should note the ecological significance of the Exmouth Gulf ecosystem, in particular the connectivity between the supratidal flats, algal mats, mangrove communities and the marine waters of the Gulf. Also note that the eastern coast of the Exmouth Gulf is considered a nationally important wetland and a candidate area for marine reservation. Significant habitats are located within the Exmouth Gulf for humpback whales, dugong and marine turtles.

The release area overlaps with significant Reserved Lands. Successful applicants should note the biodiversity and social values associated with the Ningaloo Marine Park and Muiron Islands Marine Management Area. The Muiron Islands are considered 'critical habitat' for green turtles. The Islands support the nesting of threatened marine turtles and are considered one of the most significant turtle rookeries in WA. Important conservation and fauna values are associated with Doole Island and Giralia Station.

LODGEMENT OF APPLICATIONS

Applications, together with supporting data, should be submitted in the following manner and accompanied by fee of \$4,788.00 (non-refundable) payable to the Department of Mines and Petroleum through an Australian Bank or by Australian bank cheque.

The following special instructions should be observed—


