BUSH FIRES ACT 1954

NOTICE TO ALL OWNERS AND/OR OCCUPIERS OF LAND IN THE SHIRE OF DANDARAGAN

Fire Break Order

Notice is hereby given to landowners/occupiers within the Shire of Dandaragan that fire breaks must be installed by 1st November and maintained clear of inflammable material up to and including 30th April as per the requirements in relation to Section 33 of the *Bush Fires Act 1954*.

RURAL FARM/FIREBREAKS

Properties 20 hectares (50 acres) or larger

- 1. Clear a firebreak consisting of mineral earth, to a width of no less than 3m, as close as practical, inside the external boundaries of the property.
- 2. Firebreaks must be maintained to provide a vertical clearance of a minimum 3.5m so as to allow adequate access for fire appliances subject to the satisfaction of the Council's appointed officers.
- 3. Construct a 5m mineral earth firebreak immediately surrounding all fuel and chemical storage
- 4. Clear inflammable material within 20m of all dwellings to construct a 20m circle of safety. This can be maintained through domestic grass, mulch or slashed native grasses.
- 5. Areas cleared and piled for burning require a 20m mineral earth firebreak.

- 6. An approved fire fighting appliance is required to be present in any paddock being harvested whilst crop harvesting, straw raking and bailing are being carried out during restricted and prohibited periods. The fire fighting unit must be in a state of readiness and have a minimum of 400 litres of water on board.
- 7. Harvesting is permitted on Sundays and all public holidays, with the exception of Christmas Day, Boxing Day and New Years Day.

ALL OTHER NON URBAN LAND (rural residential, rural development)

Properties 2,023m² (half an acre) to 20 hectares (50 acres)

This category relates to nearly all lots in all industrial estates and the subdivisions of Jurien Bay Heights, Alta Mare, Marine Fields, Kooringal Vale and Hill River.

- 1. Clear a 3m wide mineral earth firebreak (clear of all inflammable material) with a vertical clearance of 4m high, clear of any obstructions (no hanging tree limbs or objects) immediately inside or as close as practical inside all external boundaries of the land to allow for the unobstructed movement of Fire Appliances.
- 2. On heavily vegetated or grassed blocks, implement supplementary fuel reduction for a further 5m inside the firebreak. Subject to the satisfaction of Council's authorised officers.
- 3. Clear all inflammable material within 20m of all buildings to construct a 20m circle of safety. This can be maintained through domestic grass, mulch or slashed native grasses.

URBAN LAND (all townsites)

Land 2,023m2 (half an acre) or less

Clear land of all inflammable material ie debris, dry grass, dry bush etc, subject to the satisfaction of Council's authorised officers.

Land larger than 2,023m² (half an acre)

Clear a 2.5m wide firebreak of all inflammable material, immediately inside the external boundaries of the land, to the satisfaction of Council's authorised officers.

PLANTATIONS

Tree plantations of more than 3 hectares but less than 10 hectares

Construct a 10m wide mineral earth firebreak with a vertical clearance of 4m high; clear of all inflammable material immediately surrounding the plantation (adjacent areas of the same property subject to provisions as for rural areas).

Plantations larger than 10 hectares

Comply with the Code of Practice for Timber Plantations in Western Australia Guidelines for Plantation Fire Protection. A copy is available from the Shire of Dandaragan Administration Centre upon request.

ALTERNATIVE ALIGNMENTS and VARIATIONS TO FIREBREAK NOTICES

If it is impractical to have a firebreak immediately inside a boundary, for environmental or any other reason(s), you are required to apply to the Shire of Dandaragan in writing, before 1st October to obtain permission for firebreaks to be installed in an alternative position or for alternative measures to be put in place. Once approval is granted, there is no need to re-apply each year, unless circumstances change or a duly appointed officer feels that the conditions of the Firebreak Variation notice are not being met.

HARVEST/MOVEMENT OF VEHICLES BANS

A ban on harvesting and the movement of vehicles (except for the watering or movement of stock) is likely to be imposed when the predicted weather conditions are classified by the Bureau of Meteorology as very high or extreme, or when local conditions warrant bans to be applied.

All such bans are at the discretion of the Chief Bush Fire Control Officer or a duly appointed person.

ADDITIONAL RESPONSIBILITIES AND PENALTIES

Persons who fail to comply with the requirements of this Order may be fined up to \$1,000. In addition, Council can arrange for the required work to be carried out at the cost of the owner / occupier.

Gas or electric barbecues ONLY, are permitted during prohibited burning times.

A permit to burn must be obtained during the restricted burning period. Permits are generally subject to a number of conditions but will NOT be issued for burning on Sundays or public holidays, unless approved by the Chief Bush Fire Control Officer.

Prior to any burning you are required to notify your neighbours, Local Fire Control Officer and the Shire of Dandaragan on 9652 0800. If the burn is to be carried out on any land that is joining or adjacent to land that is managed or controlled by the Department of Environment and Conservation your local Department of Environment and Conservation office is to be notified by telephoning 9652 1911.

Besides being responsible for the safety of your own property, if a fire escapes from your property, you may be liable to pay compensation for any damage caused outside of your property—this could be very costly.

Public infrastructure must not be placed in a manner that results in an aboveground encroachment into the firebreak area.

Trees must not be planted in a manner that results in vegetation encroaching into the firebreak area.

RESTRICTED and PROHIBITED BURNING PERIODS

Prohibited burning period 1st November to 28th February—STRICTLY NO BURNING.

Restricted burning period 19th September to 31st October and 1st March to 1st April—Permits are required.

No camp fires are permitted between the 1st November and the 31st March including for the purpose of cooking.

No burning is permitted in Fire Weather Zones—South West or North West (West of the Brand Highway) over the Easter Holiday Period (Good Friday and the 3 days immediately following Good Friday).

Persons who fail to comply with the requirements stated in this Order may incur penalties, either by way of infringements or prosecutions, as defined in the Bush Fires Act 1954 Regulations and Infringements.

In addition should the property owner/occupier fail to comply with this Order, the Shire of Dandaragan can, at any time after the specified dates enter the property to carry out the required work, where the owner / occupiers will then be liable for all penalties and costs incurred.

If the requirements of this Order are carried out by burning, such burning must be carried out in accordance with the relevant provisions of the Bush Fires Act 1954.

The requirements of this Order are considered to be the minimum standards of fire prevention to protect not only individual properties, but also the district generally.

In addition to this Order, the Shire of Dandaragan may issue separate special orders on owners / occupiers if a particular fire hazard removal is deemed necessary.

The Council no longer installs firebreaks for ratepayers, Council recommends that you contact local contractors as soon as possible to ensure the requirements of this notice are carried out.
