#### LOCAL GOVERNMENT ACT 1995

Shire of Ravensthorpe

LOCAL GOVERNMENT PROPERTY AMENDMENT LOCAL LAW 2010

Under the powers conferred by the *Local Government Act 1995*, and under all other powers enabling it, the Council of the Shire of Ravensthorpe resolved on 24 February 2011 to adopt the following local law.

#### 1. Citation

This local law may be cited as the Shire of Ravensthorpe Local Government Property Amendment Local Law 2010.

#### 2. Commencement

This local law will come into operation on the fourteenth day after the day on which it is published in the *Government Gazette*.

#### 3. Principal local law amended

The Shire of Ravensthorpe Local Government Property Local Law 2010, as published in the Government Gazette on 8 June 2010, is referred to as the principal local law. The principal local law is amended.

#### 4. Clause 1.6 amended

In clause 1.6(1), delete paragraph (b) and insert—

(b) from the coastal boundaries of the district into the Southern Ocean to a distance of 200 metres seawards from the low water mark, as approved by the Governor under section 3.6 of the Act, per notice published in the *Government Gazette*, No. 207, on 5 November 2010, page 5578.
