YOORROOYANG DAWANG PROPOSED CONSERVATION PARKS

Draft Management Plan

The Conservation Commission of Western Australia advises that the draft management plan for the Yoorrooyang Dawang proposed conservation parks is available for public comment.

The draft management plan has been prepared by the Yoorrooyang Dawang Regional Park Council in accordance with the Ord Final Agreement 2005.

Under the Ord Final Agreement, the proposed conservation parks of Goomig, Barrbem, Ngamoowalem, Mijing, Jemarnde-wooningim, and Darram will be jointly managed by the Yawoorroong Miriuwung Gajerrong Yirrgeb Noong Dawang Aboriginal Corporation and the Department of Environment and Conservation (DEC).

The draft management plan outlines how the proposed conservation parks, located in the East Kimberley, will be jointly managed, and makes recommendations for adoption in a final management plan.

It is hereby notified for public information, in accordance with section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the City of Albany local planning scheme amendment on  $17 \, \mathrm{March} \, 2011$  for the purpose of—

- 1. Modifying the existing Subdivision Guide Plan for Conservation Zone Area No. 1 accordingly.
- 2. Replacing existing Provision 1.1 with the following—
  - 1.1 Subdivision of Conservation Zone Area No. 1 shall be generally in accordance with the Subdivision Guide Plan endorsed by the Chief Executive Officer and the Western Australian Planning Commission.
- 3. Inserting a new Provision 3.3 with the following and re-numbering existing Provisions 3.3 to 3.4 accordingly—
  - 3.3 The following uses are not permitted with the Conservation Zone Area No. 1—
    - · Holiday Accommodation;
    - Tourist Accommodation;
    - · Relocated Dwelling.
- 4. Inserting a new Provision 3.5 with the following—
  - 3.5 A Development Exclusion Area refers to a location where no use or development shall be permitted.
- 5. Modifying existing Provision 4.1 from "(including sheds, water storage and low fuel areas)" to "(including sheds, water storage, low fuel areas and effluent disposal areas)."
- 6. Replacing existing Provision 4.2 with the following—
  - 4.2 The Development Area may be split to allow the separate development of the main residential house and the caretakers accommodation.
- 7. Modifying existing Provision 4.4 from "a comprehensive professional assessment of the selected Development Area and proposed access way/driveway to determine the presence of rare, endangered and/or threatened flora or fauna species and the presence of any aboriginal sites." to "a comprehensive professional assessment of the selected Development Area and proposed access way/driveway in accordance with the Environmental Protection Authority Guidance Statement No. 51—Terrestrial Flora and Vegetation Surveys for Environmental Impact Assessment in Western Australia to determine the presence of rare, endangered and/or threatened flora or fauna species, as well as an archaeological assessment for the presence of potential aboriginal sites."
- 8. Replacing existing Provision 4.5 with the following—
  - 4.5 The Development Area shall be sited in consultation with Council. Individual Development Areas shall be sited so as to—
    - be setback a minimum of 50 metres from the Wilson Inlet Foreshore Reserve, 200 metres from the coastal foreshore reserve and 20 metres from any other lot boundaries:
    - notwithstanding the above, Council may permit variation to the setback requirements where it can be clearly demonstrated to Council's satisfaction that a lesser setback will be necessary to satisfy the visual and/or environmental objectives of the zone, and where it can be clearly demonstrated that the location of the Development Area at another location is not practical. Council shall require a site specific setback analysis by a qualified coastal engineer which locates the current horizontal setback datum (HSD) and determines the (S1) Distance for Absorbing Acute Erosion (Extreme Storm Sequence), (S2) Distance to all for Historic Trends (Chronic Erosion or Accretion) and (S3) Distance to Allow for Sea Level Change. This is to include a topographic survey extending to the waterline, and exact location of the proposed development and neighbouring building and structure;
    - avoid the sand blowouts and highly exposed steeply sloping sites where low coastal heath does not provide for effective screening of development and where erosion potential is high;
    - be located off significant ridgelines and preferably within sheltered well vegetated swales;
    - be located, where possible, on the calcareous sands or podzols;
    - be located to ensure access roads/access ways can be achieved with minimal disturbance to vegetation and are not visually intrusive from within or outside the area;
    - be located to ensure sites can accommodate fire control measures and low fuel area can be achieved and readily maintained; and

- be located to address the costs of constructing access roads and providing services such as telecommunications and electricity.
- 9. Inserting of new Provision 4.6 with the following—
  - 4.6 Applications for approval of Development Areas shall be accompanied by a photographic assessment demonstrating that the proposed Development Area and the buildings proposed thereon, will blend in with the visual landscape in terms of height and rooflines, colouring/toning and form and scale, and will not dominate a land based view when viewed from Anvil Beach Lookout, a public roadway, a foreshore node or the foreshore, the coastal walk trail and/or the Ocean Beach Lookout.

Council may request the photographic assessment include photographs covering the views to the proposed development area from surrounding roads and other public use nodes/areas within and adjoining the zone and include the identification, by the positioning of posts, markers and/or scaffolds on or above ground, the proposed height and extent of buildings, structures and site works proposed within the development area.

- 10. Inserting of new Provision 4.7 with the following—
  - 4.7 In the case of Lots 101, 103, 105, 111, 115, 116, 119, 120, 127 and 128 as shown in the Subdivision Guide Plan, the photographic assessment shall also be accompanied by details of the overall horizontal and vertical extents of the buildings proposed.
- 11. Inserting of new Provision 4.8 with the following—
  - 4.8 In the instance of Lots 102, 104, 106, 107, 108, 109 and 110, where Development Areas are proposed between the Foreshore Reserve and Nullaki Drive, development shall be designed and/or located such that it is not visually prominent from a foreshore node or the Bibbulmum Track.
- 12. Inserting a new Provision 4.9 with the following—
  - 4.9 With the aim of ensuring any buildings from Anvil Beach, the Anvil Beach lookout, a public roadway, a foreshore node or the foreshore, the costal walk trail and/or the Ocean Beach Lookout do not dominate the visual landscape, Council may apply conditions to the approval of a Development Area that limit or control building height, colouring and materials and site works and/or require landscaping for visual screening purposes.
- 13. Inserting a new Provision 6.2 with the following—
  - 6.2 The minimum boundary setback for all buildings and structures shall be 20m.
- 14. Modifying existing Provision 7.4 from "Council shall prefer the use of natural materials such as stone, rammed earth and/or timber and advocate green to brown tonings/natural hues." to "Council shall prefer the use of natural materials such as stone, rammed earth and/or timber (where such timber can meet the requirements of AS 3959) and advocate green to brown tonings/natural hues."
- 15. Inserting a new Provision 8.1 with the following—
  - 8.1 No clearing of vegetation shall be permitted, expect that which is prescribed in the *Environmental Protection Regulations 2004*, a subdivision and or development approval, fire control legislation and approved fire management plans.
- 16. Inserting a new Provision 9.1 with the following—
  - 9.1 Each residential dwelling house or caretakers accommodation (approved subject to provision 3.1) is to be provided with a potable domestic water supply with a minimum capacity of 92,000 litres. This may be supplied from underground supplies or a rainwater storage system to the satisfaction of Council. Water for fire fighting purposes shall be provided in accordance with Clause 11.0.
- 17. Inserting a new Provision 11.2 with the following—
  - 11.2 The clearing of fire breaks other than for slashed low fuel fire break purposes in accord with Provisions 11.1, 11.10, 11.11 and 11.12, is not permitted.
- 18. Inserting a new Provision 11.3 with the following—
  - 11.3 Building Protection Zones in accordance with the Planning for Bushfire Protection Policy are to be provided around dwellings and shall be maintained in a low fuel conditions by individual landowners.
- 19. Inserting a new Provision 11.4 with the following and re-numbering existing Provisions 11.4 to 11.12 accordingly—
  - 11.4 Where any Development Area is proposed in or adjacent to an area identified as Karri Forest on the Subdivision Guide Plan, Council may require the preparation and implementation of a Bushfire Management Plan as a condition of development approval.
- 20. Adding to the existing Provision 11.6 with the following—
  - Applications for approval of a development shall be accompanied by a sprinkler system plan, which provides details on water supply, sprinkler coverage, materials to be used and the type of generator to be used which shall be independent of the mains power supply.
- 21. Replacing the existing Provision 11.7 with the following—
  - 11.8 Each dwelling shall have a water supply of not less than 30,000 litres available for fire fighting purposes, fitted with a 100 mm Female Camlock Coupling and gate valve to Council's and the Fire and Emergency Services Authority's (FESA) satisfaction. This

may be from underground supplies or roof catchment. Where the fire fighting supply forms part of the domestic supply, the outlet for domestic use shall be located part way up the tank so as to ensure the lower 30,000 litres remain available for fire fighting purposes.

- 22. Deleting in existing Provision 11.8 the following—
  - "The Bush Fires Board will assist in the targeting of supplementary finding and provision of said equipment."
- 23. Inserting a new Provision 11.13 with the following—
  - 11.13 Prior to Council approving a Development Area, or residential dwelling on a proposed lot, a fire audit is to be submitted detailing the following—
    - Assessment of the site and whether proposed building envelope will cater for recommended bushfire protection zone around the proposed dwelling.
    - A determination of fire threat classification (either low, medium, high or extreme) in accordance with AS 3959—Buildings in Bushfire Prone Areas.
- 24. Modifying existing Provision 14.2 from "revegetated as soon" to "revegetated with endemic native species as soon."
- 25. Add to the existing Provision 16.2 the following—
  - "- Identify the requirements of the Environmental Protection (Clearing of Native Vegetation) Regulations 2004."
- 26. Inserting a new Provision 17.1 with the following—
  - 17.1 Within Conservation Zone Area No 1, the siting of Development Areas, the construction of buildings including associated site works and removal of vegetation, shall require Planning Scheme Consent.


