Western Australian Meat Industry Authority Amendment Regulations (No. 2) 2011

Made by the Lieutenant-Governor and Administrator in Executive Council after consultation with the Western Australian Meat Industry Authority.

1. Citation

These regulations are the Western Australian Meat Industry Authority Amendment Regulations (No. 2) 2011.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on 1 July 2011.
