LOCAL GOVERNMENT ACT 1995 AGRICULTURE AND RELATED RESOURCES PROTECTION ACT 1976

Shire of Harvey

PEST PLANTS LOCAL LAW 2011

Under the powers conferred by the *Agriculture and Related Resources Protection Act* 1976 and the *Local Government Act* 1995 and by all other powers enabling it, the Council of the Shire of Harvey resolved on the 2nd August, 2011 to make the following local law.

PART 1—PRELIMINARY

1.1 Citation

This local law may be cited as the Shire of Harvey Pest Plants Local Law 2011.

1.2 Definitions

In this local law, unless the context otherwise requires—

"district" means the district of the Shire of Harvey;

"local government" means the Shire of Harvey;

"pest plant" means a plant described as a pest plant by clause 2.1 of this local law.

1.3 Application

This local law applies throughout the district.

PART 2—DESCRIPTION OF PEST PLANTS

2.1 Description of Pest Plants

Every plant described in the First Schedule of this local law is a pest plant.

PART 3—SERVING OF NOTICES

3.1 Serving of Notices

- (1) The local government may serve on the owner or occupier of private land within the district a duly completed notice in the form of the Second Schedule to this local law requiring that person to destroy, eradicate or otherwise control any pest plant on that land:
- (2) A person served with a notice under sub clause (1) of this clause shall comply with that notice within the time and in the manner specified therein.

PART 4—OFFENCES

4.1 Penalties

Where a person fails to comply with a notice served under clause 3.1 of this local law, the local government may—

- (a) without payment of any compensation in respect thereof, destroy, eradicate or control, as the case may be, any pest plant the destruction, eradication or control of which was required by the notice; and
- (b) recover in a court of competent jurisdiction from the person to whom the notice is directed, the amount of the expense of such destruction, eradication or control.

Firearms Act 1973

Firearms (Licence Exemption) Notice 2011

Made by the Governor in Executive Council under section 8(1)(e) of the Act.

1. Citation

This notice is the *Firearms (Licence Exemption) Notice 2011*.

2. Commencement

This notice comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice on the day after that day.

3. Terms used

In this notice —

member, in relation to the New Zealand Police, means an employee of the New Zealand Police who holds the office of constable;

police force means —

- (a) the police force of another State or of a Territory; or
- (b) the Australian Federal Police; or
- (c) the New Zealand Police.

4. Exemption from licensing requirements: federal, State and Territory police

Each police force (other than the New Zealand Police) is specified for the purposes of section 8 of the Act in respect of the possession by a member of that police force of a firearm or ammunition for use in the performance of the member's duties as —

- (a) a special constable appointed under the *Police Act 1892* section 35; or
- (b) a special officer appointed under the *Terrorism* (Extraordinary Powers) Act 2005 section 17.

5. Exemption from licensing requirements: New Zealand Police

(1) The New Zealand Police is specified for the purposes of section 8 of the Act in respect of the possession by a member of

that police force of a firearm or ammunition for use in the performance of the member's duties as a special constable appointed under the *Police Act 1892* section 35.

(2) The New Zealand Police is specified for the purposes of section 8 of the Act in respect of the possession by a member of that police force of a firearm or ammunition for use during counter-terrorism training in which the member is participating.

6. Temporary exemption from licensing requirements: CHOGM (Perth) 2011

- (1) Each police force is specified for the purposes of section 8 of the Act in respect of the possession by a member of that police force of a firearm or ammunition for use in the performance of the member's duties as a recognised law enforcement officer appointed under the *Commonwealth Heads of Government Meeting (Special Powers) Act 2011* section 50.
- (2) This clause expires at the end of 5 November 2011.

7. Firearms (Licence Exemption) Notice 1985 not limited

Nothing in this notice limits the *Firearms (Licence Exemption) Notice 1985*.

8. Notices repealed

The following are repealed —

- (a) the Firearms (Licence Exemption) Notice 2006;
- (b) the Firearms (Licence Exemption) Notice 2007.

Acting Attorney General Designation Order (No. 2) 2011

1. Citation

This order is the *Acting Attorney General Designation Order* (No. 2) 2011.

2. Minister designated

Under the *Supreme Court Act 1935* section 154, the Honourable Robert Frank Johnson MLA, the Minister for Police; Emergency Services; Road Safety, is designated as the Minister of the State —

- (a) who may exercise the powers referred to in section 154(3) of that Act; and
- (b) by, to or with reference to whom acts may be done under section 154(4) of that Act,

during the period 27 September to 2 October 2011 (both dates inclusive).

Gaming and Wagering Commission Act 1987

Gaming and Wagering Commission Amendment Regulations 2011

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Gaming and Wagering Commission Amendment Regulations 2011*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Regulations amended

These regulations amend the *Gaming and Wagering Commission Regulations 1988*.

4. Regulation 4A inserted

After regulation 3 insert:

4A. Notes in the text

A note included in these regulations (other than in a Form in Schedule 3) is explanatory and is not part of these regulations.

5. Regulation 8A inserted

At the beginning of Part 4 Division 1 insert:

8A. Gaming on cruise ships

(1) In this regulation —

baseline has the meaning given in the Crimes at Sea Act 2000 Schedule 1 clause 1(1);

cruise ship means any vessel that —

- (a) has a minimum capacity of 100 passengers; and
- (b) is conducting a scheduled deep water cruise; and
- (c) is transiting through Western Australian ports from and to locations overseas or interstate.
- (2) For the purposes of section 46(2A), gaming on a cruise ship outside a distance of 12 nautical miles from the Western Australian baseline is prescribed.

6. Regulation 18C inserted

At the end of Part 4 Division 4 insert:

18C. Possession of certain gaming machines on cruise ships

(1) In this regulation —

cruise ship means any vessel that —

- (a) has a minimum capacity of 100 passengers; and
- (b) is conducting a scheduled deep water cruise.
- (2) For the purposes of section 85(6A), on board a cruise ship in waters in an area to which section 85(4) applies is a prescribed circumstance.

Note: The substantive criminal law of the State applies throughout the inner adjacent area for the State under the *Crimes at Sea Act 2000* (Western Australia) and throughout the outer adjacent area for the State under the *Crimes at Sea Act 2000* (Commonwealth).
