Fish Resources Management Act 1994

Fish Resources Management Amendment Regulations (No. 10) 2011

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Fish Resources Management Amendment Regulations (No. 10) 2011*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. Regulations amended

These regulations amend the *Fish Resources Management Regulations 1995*.

4. Regulation 124B amended

In regulation 124B(2):

- (a) in paragraph (d) delete “Act.” and insert:
