DECLARATION UNDER SECTION 4(2)

Pigeon Paramyxovirus Type 1 is declared to be a disease to which the *Exotic Disease of Animals Act* 1993 applies.

DISEASE CONTROL ORDER

Made by the Minister for Agriculture and Food under section 41(1) of the Exotic Diseases of Animals Act 1993.

I certify that an outbreak of the exotic disease Pigeon Paramyxovirus Type 1 has occurred in the town of Shepparton, in the State of Victoria.

EXOTIC DISEASES OF ANIMALS ACT 1993

IMPORT RESTRICTION ORDER NO. 1/2011

Made by the Minister for Agriculture and Food under section 24 of the Exotic Diseases of Animals Act 1993.

Pigeon Paramyxovirus Type 1 has been diagnosed in the state of Victoria.

The entry or importation into Western Australia of the following things is prohibited except under and in accordance with the conditions of a permit—

| Item restricted | Place of origin |

| All pigeons and doves (family <i>Columbidae</i>) and all products derived from pigeons and doves | All states and territories outside of Western Australia |
| All equipment and transport items used with pigeons and doves | All states and territories outside of Western Australia |

Unless sooner revoked, this order has effect for a period of 30 days from publication.

EXOTIC DISEASES OF ANIMALS ACT 1993

CONTROLLED AREA ORDER NO. 1/2011

Made by the Minister for Agriculture and Food under section 40 of the *Exotic Diseases of Animals Act* 1993.

For the purposes of prevention of infection and control of the spread of Pigeon Paramyxovirus Type 1 the whole of the state of Western Australia is declared to be an area in relation to which a Control Order may be made.

A Control Order may be made in relation to the following species of animals and classes or description of animals and animal products—

Live Pigeons and doves (family *Columbidae*), products derived from pigeons and doves, equipment and transport items used with pigeons and doves.
