Commonwealth Heads of Government Meeting (Special Powers)
Act 2011

**Commonwealth Heads of Government Meeting
(Special Powers) (Additional Security Area)
Order 2011**

Made by the Commissioner of Police under section 8 of the Act with the approval of the Minister.

1. Citation

This order is the *Commonwealth Heads of Government Meeting (Special Powers) (Additional Security Area) Order 2011*.

Note: Under the *Commonwealth Heads of Government Meeting (Special Powers) Act 2011* section 8(2), this order has effect when it is published in the *Gazette*.

2. Application

In Schedule 1, where an area of land is described by reference to a road (however described), the road includes a carriageway, footpath, median strip, traffic island or verge on the road reserve.

3. Additional security area: Indiana's Cottesloe Beach

- (1) The area of land described in Schedule 1 is an additional security area (called the "Indiana's Cottesloe Beach additional security area") for 28 October 2011.
- (2) The area is an additional security area at all times.

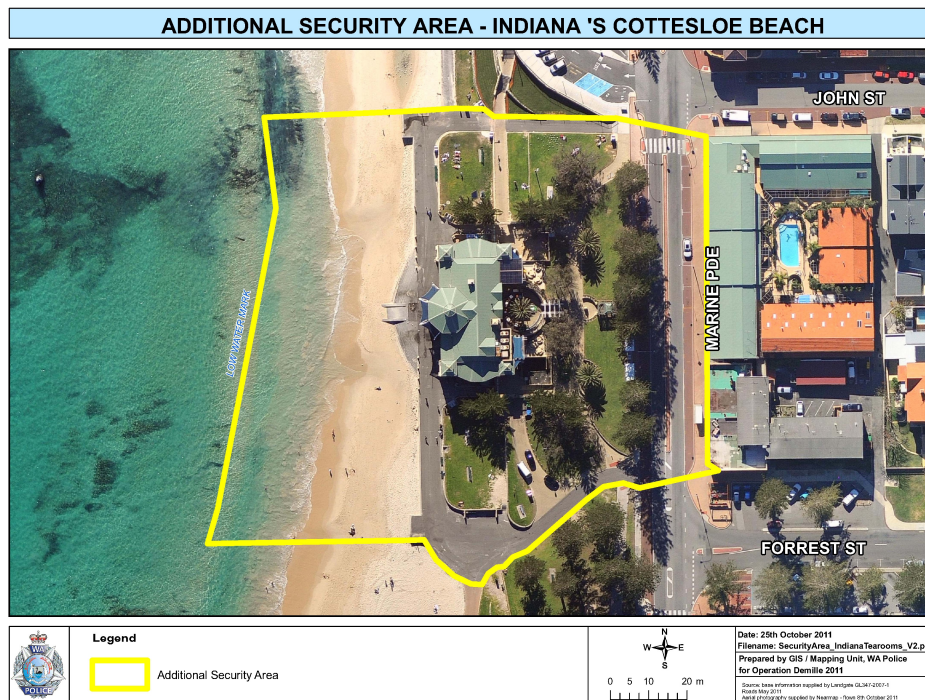

- (1) The area of land in the Town of Cottesloe contained within a line that —
 - (a) starts at the western end of the pedestrian walkway that runs between Cottesloe Beach and Marine Parade immediately to the south of the car park located immediately to the north of Indiana's Cottesloe Beach at 99 Marine Parade (*Indiana's*), at the north-western corner of the part of the walkway that protrudes onto Cottesloe Beach (the *start point*); and
 - (b) then continues in a generally easterly direction along the northern edge of that walkway to the point where the wall at the north-eastern corner of the walkway intersects with the footpath that runs to the west of Marine Parade; and
 - (c) then continues in a generally south-easterly direction, across that footpath and Marine Parade, directly to the north-western corner of the building located at Number 94 Marine Parade (being the building on the south-eastern corner of the intersection of Marine Parade and John Street); and
 - (d) then continues in a southerly direction, along the street frontages of the buildings at Number 94 Marine Parade and Number 2 Forrest Street, to the south-western corner of the building at Number 2 Forrest Street (being the corner immediately to the south of the door on the south-western corner of that building); and
 - (e) then continues in a generally south-westerly direction across Marine Parade directly to the north-eastern corner of the larger of the 2 grassed areas that are located immediately to the south of the pedestrian walkway (the *walkway*) that runs between Cottesloe Beach and Marine Parade immediately to the south of Indiana's; and
 - (f) then continues in a generally south-westerly then generally north-westerly direction along the southern edge of the walkway to the south-western corner of the part of the walkway that protrudes onto Cottesloe Beach; and

- (g) then continues due west across Cottesloe Beach to the point where the line intersects with mean low water of the Indian Ocean; and
- (h) then continues in a generally northerly direction along mean low water of the Indian Ocean to the point on mean low water that is due west of the start point; and
- (i) then continues due east to the start point.
- (2) For information purposes, the area described above is shown bordered in yellow on the following map.
