Lotteries Commission (Monday and Wednesday Lotto) Amendment Rules 2011

Made by the Lotteries Commission under section 28(1) of the Act.

1. Citation

These rules are the Lotteries Commission (Monday and Wednesday Lotto) Amendment Rules 2011.

2. Commencement

These rules come into operation on 21 February 2012 and apply to —

- (a) the Monday draws conducted on or after 27 February 2012 (draw No. 3116); and
- (b) the Wednesday draws conducted on or after 29 February 2012 (draw No. 3117).

3. Rules amended

These rules amend the *Lotteries Commission (Monday and Wednesday Lotto) Rules 2006.*

4. Rule 3 amended

In rule 3(1) delete the definition of *total prize pool*.

5. Rule 17 amended

In rule 17:

- (3) If there are 2 or more winners of a division 1 prize in a particular lotto draw, the prize reserve fund is to be used to pay each division 1 winner an equal share of \$2 000 000.
