Electricity Act 1945

Electricity Notice (No. 2) 2012

Made by the Director of Energy Safety under section 33B(1)(a) of the Act.

1. Citation

This notice is the *Electricity Notice (No. 2) 2012*.

2. Commencement

This notice comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice — on the day after that day.

3. Power of Director to prescribe classes or types of electrical apparatus, etc., which shall not be sold, etc., unless approved by the Director

(1) For the purposes of section 33B(1)(a) —

- (a) The Director may by notice published in the *Gazette* prescribe any class or type of electrical appliance which shall not after a date specified in the notice be sold, hired or exposed for sale or hire or advertised for sale or hire; and
- (b) The date specified is the date on which this clause comes into operation.

(2) In this clause —

an electrical appliance of the class or type described as an inverter that converts direct current into alternating current at 240 volts (nominal) that is available via one or more plug outlets fixed to the body of the inverter or alternatively via one or more cords attached internally to the body of the inverter and that has a plug outlet at the end of the cord, or a combination of these arrangements, is prescribed as being a class or type of electrical apparatus that may not be sold, hired or exposed for sale or hire or advertised for sale or hire. Inverters with a combination of plug outlets and socket outlets are included in this class or type of inverter.

- (3) This notice does not apply to an inverter of the class or type described above that incorporates one or more socket outlets fixed to the body of the inverter or alternatively fitted with a cord or cords attached internally to the body of the inverter and that has a socket outlet at the end of the cord.

Fish Resources Management Act 1994

Fish Resources Management Amendment Regulations (No. 4) 2012

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Fish Resources Management Amendment Regulations (No. 4) 2012*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. Regulations amended

These regulations amend the *Fish Resources Management Regulations 1995*.

4. Regulation 10 replaced

Delete regulation 10 and insert:

10. Classes of fish prescribed (Act s. 45)

For the purposes of the Act —

- (a) the classes of fish listed in Schedule 2 Part 1 are commercially protected fish; and

- (b) the classes of fish listed in Schedule 2 Part 2 are totally protected fish; and
- (c) the classes of fish listed in Schedule 2 Part 3 are recreationally protected fish.

5. Regulation 124 amended

After regulation 124(2) insert:

- (3) The CEO must issue a receipt to a person who has applied for the grant or renewal of a recreational fishing licence.
- (4) A receipt issued under subregulation (3) is to —
 - (a) be in a form approved by the CEO; and
 - (b) specify the following —
 - (i) the date on which the receipt was issued;
 - (ii) the activity referred to in subregulation (2)(a) in respect of which the application is made;
 - (iii) any letters and numbers that may be allocated in respect of a licence to which the application relates under subregulation (2)(b).

6. Regulation 124A replaced

Delete regulation 124A and insert:

124A. Recreational fishing licence receipt may have effect as a recreational fishing licence

- (1) In this regulation —
 - applicant* means a person who has applied for the grant or renewal of a recreational fishing licence;
 - recreational fishing licence receipt* means a receipt issued under regulation 124(3).
- (2) A recreational fishing licence receipt issued to an applicant has effect as if it was a recreational fishing licence granted to the applicant until —
 - (a) the CEO gives notice to the applicant of the outcome of the application; or
 - (b) the expiration of one month after the date on which the receipt was issued,

whichever occurs first.

- (3) Despite subregulation (2), a recreational fishing licence receipt does not have effect as if it was a recreational fishing licence if the applicant to whom it was issued —
 - (a) was the holder of a recreational fishing licence or a recreational (boat) fishing licence which was cancelled, or not renewed by the CEO; or
 - (b) has been convicted of an offence against the Act; or
 - (c) is not in possession of the receipt when engaging in an activity specified in the receipt.

7. Regulation 124C replaced

Delete regulation 124C and insert:

124C. Recreational (boat) fishing licences, grant of

- (1) If a person applies to the CEO, the CEO may grant to the person a recreational (boat) fishing licence.
- (2) The CEO must issue a receipt to a person who has applied for the grant or renewal of a recreational (boat) fishing licence.
- (3) A receipt issued under subregulation (2) is to —
 - (a) be in a form approved by the CEO; and
 - (b) specify the date on which the receipt was issued.

8. Regulation 124D inserted

After regulation 124C insert:

124D. Recreational fishing (boat) licence receipt may have effect as a recreational (boat) fishing licence

- (1) In this regulation —

applicant means a person who has applied for the grant or renewal of a recreational (boat) fishing licence;

recreational (boat) fishing licence receipt means a receipt issued under regulation 124C(2).
- (2) A recreational (boat) fishing licence receipt issued to an applicant has effect as if it was a recreational (boat) fishing licence granted to the applicant until —
 - (a) the CEO gives notice to the applicant of the outcome of the application; or

- (b) the expiration of one month after the date on which the receipt was issued,
- whichever occurs first.
- (3) Despite subregulation (2), a recreational (boat) fishing licence receipt does not have effect as a recreational (boat) fishing licence if the applicant to whom it was issued —
- (a) was the holder of a recreational fishing licence or a recreational (boat) fishing licence which was cancelled or not renewed by the CEO; or
- (b) has been convicted of an offence against the Act; or
- (c) is not in possession of the receipt when engaging in an activity specified in the receipt.

9. Schedule 2 heading replaced

Delete the heading to Schedule 2 and the reference after it and insert:

Schedule 2 — Protected fish

[s. 46, 47 and 48A and r. 10]

10. Schedule 2 Part 3 inserted

At the end of Schedule 2 insert:

Part 3 — Recreationally protected fish

Estuary cod in excess of 30 kg weight or 1000 mm in length.

Malabar cod in excess of 30 kg weight or 1000 mm in length.

11. Schedule 3 amended

In the provisions listed in the Table delete the item referring to Cod classified as *Epinephelus* spp.

City of Vincent

DOGS AMENDMENT LOCAL LAW NO. 2, 2012

Under the powers conferred by the *Local Government Act 1995*, the *Dog Act 1976* and by all other powers enabling it, the Council of the City of Vincent resolved on 28 August 2012 to make the following local law.

1. Citation

This local law may be cited as the *City of Vincent Dogs Amendment Local Law No. 2, 2012*.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

3. Principal local law

In this local law the *Town of Vincent Dogs Local Law 2007* published in the *Government Gazette* on 21 November 2007 and amended as published in the *Government Gazette* 24 February 2012, is referred to as the principal local law. The principal local law is amended.

4. Clause 1.6 amended

Clause 1.6 be amended to add the following definitions in alphabetical order—

“**assistance animal**” means an animal referred to in section 9 of the *Disability Discrimination Act 1992* of the Commonwealth;

“**companion dog**” means a dog which accompanies a person as a pet;

“**enclosed area**” means an area that, except for doorways and passageways, is completely closed on a permanent basis, by—

- (a) a ceiling or roof; and
- (b) walls or windows or both walls and windows;

“**food premises**” shall have the same meaning referred to as a “food business” in section 8 of the *Food Act 2008* and the Australian and New Zealand Food Standard Code, Standard 3.2.2;

“**outdoor eating area**” means an area that—

- (a) is used for dining, drinking or both drinking and dining; and
- (b) is not used for the preparation of food; and
- (c) is not an enclosed area; and
- (d) can be entered by the public without passing through an enclosed area;

5. Clause 5.1 amended

Subclause (1) (c) be deleted and substituted with the follows—

- (c) (i) all premises classified as a food business, under the *Food Act 2008* and the Australian and New Zealand Food Standard Code, Standard 3.2.2, except within an approved Outdoor Eating Area, where specific approval has been given for companion dogs to be allowed; and
- (ii) all vehicles classified as a food business, under the *Food Act 2008* and the Australian and New Zealand Food Standard Code, Standard 3.2.2.

6. Clause 5.1 amended

New subclauses (3) and (4) be inserted as follows—

- (3) The Proprietor of a food premises must permit an assistance animal in areas used by customers; and
- (4) The Proprietor of a food premises may permit a companion dog that is not an assistance animal to be present in an outdoor eating area.

FIREBREAK NOTICE

All owners and occupiers of land within the City of Armadale

All property owners are required to have mineral earth trafficable firebreaks constructed in accordance with this notice by 30 November 2012 and maintained until 14 March 2013

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, you are hereby required on or before the 30th day of November 2012 or within fourteen days of you becoming the owner or

occupier of land should this be after the 30th day of November 2012 to clear firebreaks and remove flammable materials from the land owned or occupied by you as specified hereunder and to maintain the specified land and firebreaks clear of all flammable materials up to and including the 14th day of March 2013.

Definitions

“FIREBREAK” means a strip of land that has been cleared of all trees, bushes, grasses and any other object or thing or flammable material leaving clear bare mineral earth. This includes the trimming back of all overhanging trees, bushes, shrubs and any other object or thing over the fire break area.

“FLAMMABLE” means any bush, plant, tree, grass, mineral, vegetable, substance, object thing or material that may or is likely to catch fire and burn.

“TRAFFICABLE” means to be able to travel from one point to another in a 4X4 fire vehicle on a firm and stable surface, unhindered without any obstruction or getting stuck bogged or trapped.

“VERTICAL AXIS” means a continuous vertical uninterrupted line at a right angle to the horizontal line of the firebreak

All Areas of Land (within the City of Armadale) less than 5000m²

Have the entire land clear of all flammable material by mowing, slashing or other means. All grasses are to be maintained below 5 centimetres in height and all trees, bushes, shrubs are to be trimmed back over driveways and access ways to all buildings to three (3) metres wide with a clear vertical axis over it to afford access for emergency services to all structures and points of the property

On any lot having an area of less than 5,000m², the keeping of grass on the lot at all times covered by this notice to a height less than 5 centimetres will be accepted in lieu of clearing a firebreak.

All Areas of Land (within the City of Armadale) over 5000m²

Install bare mineral earth trafficable firebreaks clear of all flammable material to a minimum of three (3) metres wide immediately inside all external boundaries of the land with all overhanging branches, trees, limbs etc. to be trimmed back to four (4) metres wide with a clear vertical axis over the firebreak area. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

- MOWED FIREBREAKS ARE NOT PERMITTED

Hazard Reduction

In addition to the provisions of this notice you may be required to carry out further works which are considered necessary by Council or an Authorised Officer of the City and specified by way of a separate written notice forwarded to the address as shown on the City of Armadale rates record for the relevant land.

Application to Vary Firebreak Requirements

If it is considered impracticable for any reason whatsoever to clear firebreaks or establish other arrangements as required by this notice, you may apply in writing to the Council of the City of Armadale, or its duly Authorised Officers no later than the 1st day of November 2012 for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council or its duly Authorised Officers you must comply with the requirements of this notice.

Except when specifically authorised to do so for purpose of fuel reduction by a Bush Fire Control Officer (BFCO) appointed by Council under the provisions of the Bush Fires Act 1954, an owner or occupier of land shall not set fire to, or cause or allow to be set on fire, any bush, rubbish or refuse whatsoever on a Sunday or a day that is a Public Holiday.
