#### 1. Citation

This notice is the *Electricity (Prescribed Appliances - Inverters) Notice 2012.* 

#### 2. Commencement

This notice comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice on the day after that day.

#### 3. Prescribed electrical appliances — inverters

- (1) For the purposes of section 33B(1A) of the Act
  - (a) inverters, as described in subclause (2), are prescribed; and
  - (b) the day after the day on which this notice is published in the *Gazette* is specified.
- (2) For the purposes of subclause (1), the type of inverter is an inverter that
  - (a) converts direct current (typically at a voltage that is less than 120V (nominal)) into alternating current at 240V (nominal); and
  - (b) has at least one output point consisting of, or including, bare metal pins that are live when the inverter is in operation.

#### **BUSH FIRES ACT 1954**

City of Bayswater Firebreak Notice

Notice to all landowners and occupiers of land in the City of Bayswater.

In accordance with section 33 of the *Bush Fires Act 1954* you are hereby required on or before the 30 November 2012, or within 14 days of the date of you becoming owner or occupier should this occur after 30 November 2012, to remove from the land owned or occupied by you, all inflammable material or to clear firebreaks in accordance with such positions and to such dimensions as specified in the following requirements. All work required by this Notice shall be maintained until 30 April 2013—

- 1. Where the area of land is 2,000m² or less remove all inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm.
- 2. Where the land is more than 2,000m² firebreaks of a minimum width of 3 metres are to be cleared immediately inside and along all external boundaries of the land.
- 3. Firebreaks of a minimum width of 3 metres are to be cleared immediately surrounding all buildings with all with all overhanging branches, trees, limbs etc to be trimmed back clear of all firebreaks and removed from the land. This includes any location where inflammable liquids and gas products are kept.

If for any reason it is considered impractical to clear firebreaks or comply with other fire protection measures in accordance with this Notice, a written application for a variation may be made in writing to the Chief Executive Officer no later than 15 November 2012. If permission for a variation is not granted you are required to comply with this Notice in its entirety.

#### Penalty
