FIRE BREAKS NOTICE 2012/2013

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954 (as amended)* you are hereby required to comply with the requirements set out in this notice. The works outlined in the following as applicable must be completed before the 1st December 2012 and maintained until the 31st March 2013 inclusive.

1. Area—3001m² or greater

Before the 1st December 2012 up to and including 31st March 2013, you are required to—

- 1.1. Construct firebreaks not less than 3 metres wide immediately inside and along all boundaries of land including that land abutting road, rail and drain reserves and all public open space reserves, with all overhanging branches, trees, limbs etc to be trimmed back clear of the firebreak area, to a minimum height of 4 metres.
- 1.2. Remove all flammable matter except living trees, shrubs, plants under cultivation and lawns, of not less than 3 metres wide and minimum height of 4 metres immediately surrounding all buildings situated on the land;
- 1.3. Firebreaks no less than 3 metres in width and minimum height of 4 metres are to be cleared immediately surrounding any place where wood or timber piles, hay stacks, tyres, vehicles, flammable liquids, chemicals and gas products are kept on the land.
- 1.4. It is recommended that where possible a 20 metre low ground fuel area is established around all habitable buildings.

Maintained living lawns are acceptable in conjunction with or in lieu of mineral earth firebreaks, provided that the same minimum width and height requirements for a firebreak are maintained.

In addition to the requirements above where the area of land exceeds 10 hectares, Council may require additional firebreaks of a minimum of 3 metres in width and minimum height of 4 metres to be installed and maintained to ensure that no area of land within the property boundary exceeds 10 hectares in area or where in the opinion that Council or its duly authorised officer determines it appropriate.

2. Area—3000m² or less

For all land which is 3,000 square metres or less in area or which is zoned under the Town of Kwinana Town Planning Scheme as "Residential" or "Special Residential", before the 1st December 2012 and maintained until and including the 31 March 2013, you are hereby required to—

- 2.1. Have all flammable material where the area of land is less than 3,000 m² by slashing, mowing or other means to a height no greater than 50mm.
- 2.2. Burning of garden refuse on the ground or in incinerators in residential and special residential zoned areas is strictly prohibited.

3. Fire Break Variations

All previously approved fire break variations are hereby cancelled as of the 1st July 2012. The Community Emergency Services Officer will make contact with previously approved applicants to discuss your individual requirements for the coming fire season.

If you have not had a previous variation or have not been contacted please contact the Community Emergency Services Officer on 9439 0200 prior to the 1st November 2012 to avoid your property being deemed non-compliant.

4. Fire Management Plans

All subdivisions or developments within the Town of Kwinana shall comply with the Fire Management Plans for their estates to the satisfaction of Council or its duly authorised officer.

DETERMINATION (No. 2) 2012

This determination is made by the Chief Dangerous Goods Officer under Regulation 18 (b) of the Dangerous Goods Safety (Road and Rail Transport of Non-Explosives) Regulations 2007. The equivalent provision in the Model Subordinate Law from the National Transport Commission is Regulation 1.6.1(2).

On 14 November 2012 the 42nd meeting of the Competent Authorities Panel (CAP) agreed for this determination to have national validity except for jurisdictions where the safe transport of UN 3375 is regulated under explosives legislation and not under a law that corresponds to the Model Subordinate Law.

The transport of UN 3375—"Ammonium Nitrate Emulsion or Suspension or Gel, intermediate for blasting explosives" is permitted in Intermediate Bulk Containers of packing instruction "IBC02" instead of the current packing instruction "IBC99" with the exception that IBCs of type 31A and 31N are not permitted.

Clause 4.1.3.7 (d) of Australian Code for the Transport of Dangerous Goods by Road and Rail, seventh edition (ADG7), regarding documentation for each consignment, does not apply to the transport of UN 3375 in accordance with this determination.

In this determination—

"packing instruction" means the code entered in column 8 "Packing Instruction" in chapter 3.2—Dangerous Goods List of ADG7;

This determination will expire when it becomes obsolete due to an amendment to ADG7 applying packing instruction IBC02 for UN 3375.


