CURTIN UNIVERSITY OF TECHNOLOGY LAND AND TRAFFIC AMENDMENT BY-LAWS 2013

These By-laws are made by the Council of the University, with the approval of the Governor, under the powers conferred on the University by section 20A of the Curtin University of Technology Act

1. Citation

These By-laws may be cited as the Land and Traffic Amendment By-laws 2013.

2. Commencement

These By-laws take effect on the date that they are published in the Government Gazette.

3. By-laws amended

These By-laws amend the Land and Traffic By-laws 2008.

4. By-law 1.3 amended

Insert after the definition of 'authorised person'—

" "cigarette", "smoke" and "tobacco product" have the meanings given to those terms respectively in the Tobacco Products Control Act 2006."

5. By-law 2.1 amended

Delete by-law 2.1(2)(a) in its entirety.

6. By-law 2.16A amended

Delete by-law 2.16A(1) and (2) and replace with—

"A person must not smoke cigarettes or tobacco products on University lands."

7. By-law 3.1 amended

- (i) Delete by-laws 3.1(1)(a) and 3.1(1)(b);
- (ii) In by-law 3.1(1)(c), insert at the end of the clause—

"or other place indicated by a traffic sign for a particular purpose in accordance with that purpose".

(iii) In by-law 3.20(2)(b) insert at the end of the clause—

"which relates to that parking bay or parking area".

(iv) In by-law 3.20(3) delete "on or in" and replace with—

"and clearly visible to and be able to be read from outside the front of".

 - ", permit or parking ticket".

ELECTRICITY INDUSTRY ACT 2004

CODE OF CONDUCT FOR THE SUPPLY OF ELECTRICITY TO SMALL USE CUSTOMERS AMENDMENT INSTRUMENT 2013

1. Citation

This is the Code of Conduct for the Supply of Electricity to Small Use Customers Amendment Instrument 2013.

2. Commencement

This instrument comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this instrument is published in the Gazette;
- (b) the rest of the instrument—on 1 July 2013.

3. Code amended

This instrument amends the $\it Code$ of $\it Conduct$ for the $\it Supply$ of $\it Electricity$ to $\it Small$ $\it Use$ $\it Customers$ $\it 2012.*$

[*Published in Gazette 205 9 November 2012, p.5323—5365]

4. Clause 1.5 amended

In clause 1.5 insert in alphabetical order—

""appropriately qualified medical practitioner" means—

- (a) within the Perth Metropolitan Area, a specialist medical practitioner or practitioner working in a specialist department of a hospital or hospite doctor; or
- (b) outside of the Perth Metropolitan Area, a doctor or general practitioner if he/she also works on an occasional basis from a local hospital or rural health service, or hospice doctor."
- ""re-certification" means confirmation from an appropriately qualified medical practitioner that a person residing at the customer's supply address continues to require life support equipment."

5. Clause 4.7 amended
