I, Stuart Smith, Chief Executive Officer of the Department of Fisheries Western Australia, in accordance with clause 26A of the *West Coast Demersal Gillnet and Demersal Longline (Interim) Managed Fishery Management Plan 1997*, having taken into account advice received from the Department's Director of Fisheries Research and consulted with the permit holders in the West Coast Demersal Gillnet and Demersal Longline (Interim) Managed Fishery (the Fishery), do hereby prohibit fishing by the use of a demersal gillnet or demersal longline at any time during the period commencing on 1 September 2013 and ending on 30 September 2013 in that area of the Fishery specified in the Schedule, for the purposes of protecting breeding stocks of whiskery shark.

General description

The Minister for Planning has granted approval to the declaration of a planning control area over portions of Lot 38 Hopkinson Road, Cardup as shown on Western Australian Planning Commission (WAPC) plan numbered 3.2555.

Purpose

The purpose of the planning control area is to allow the future reservation of the land as a Primary Regional Road. The WAPC considers that the planning control area is required over portions of the property to ensure that no development occurs on this land which might prejudice this purpose until it may be reserved as Primary Regional Roads in the Metropolitan Region Scheme.

Duration and effects

The declaration remains in effect for a period of five years from the date of publication of this notice in the *Government Gazette* or until revoked by the WAPC with approval by the Minister, whichever is the sooner.

A person shall not commence and carry out development in a planning control area without the prior approval of the WAPC. The penalty for failure to comply with this requirement is \$200,000 and, in the case of a continuing offence, a further fine of \$25,000 for each day during which the offence continues.

Compensation is payable in respect of land injuriously affected by this declaration, and land so affected may be acquired by the WAPC in the same circumstances and in the same manner as if the land had been reserved in the Metropolitan Region Scheme for a public purpose.

General description

The Minister for Planning has granted approval to the declaration of a Planning Control Area over Lot 11943 Lord Street, Caversham, Lot 4 and portion of Lot 88 Altone Road, Kiara, as shown on Western Australian Planning Commission plan number 1.7303.

Purpose

The purpose of the Planning Control Area is to allow the possible future reservation of the lands for Public Purposes-Special Uses. The land has been identified for the location of residential disability justice centres.

The Commission considers that the planning control area is required to ensure that no development occurs on this land which might prejudice this purpose until it may be reserved for Public Purposes-Special Uses in the Metropolitan Region Scheme.

Duration and effects

The declaration remains in effect for a period of five years from the date of publication of this notice in the *Government Gazette* or until revoked by the Commission with approval by the Minister, whichever is the sooner.

A person shall not commence and carry out development in a planning control area without the prior approval of the Commission. The penalty for failure to comply with this requirement is \$200,000 and, in the case of a continuing offence, a further fine of \$25,000 for each day during which the offence continues.

Compensation is payable in respect of land injuriously affected by this declaration, and land so affected may be acquired by the Commission in the same circumstances and in the same manner as if the land had been reserved in the Metropolitan Region Scheme for a public purpose.

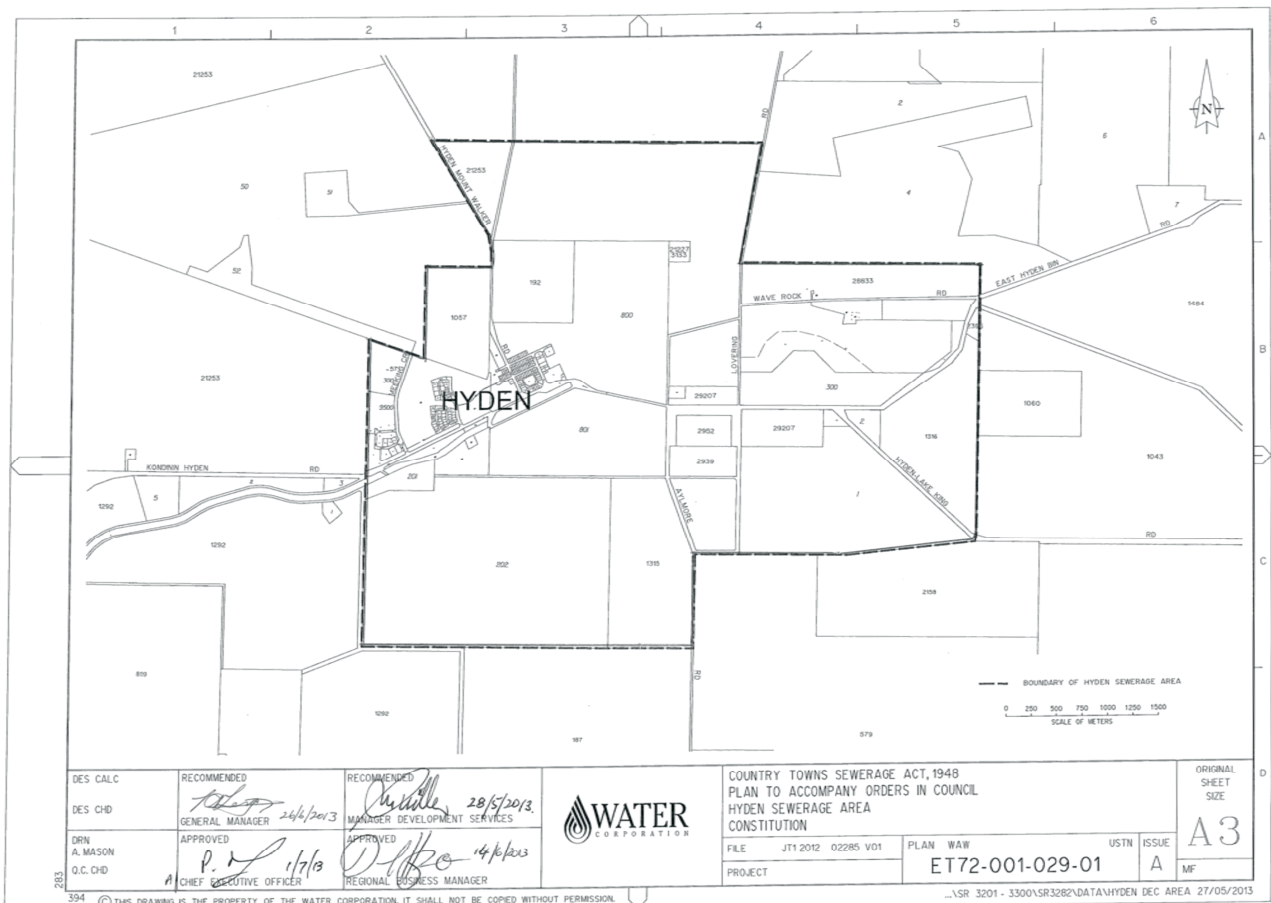
