FIRE BREAK AND FUEL HAZARD REDUCTION NOTICE 2013/2014

Notice to all landowners, important information relating to your responsibility as a land owner in the City of Mandurah

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, you are required to carry out fire prevention work on land owned or owned and occupied by you in accordance with the provisions of this Notice, to the satisfaction of Council or its duly authorised officers.

This work must be carried out by 17 November 2013 or within 14 days of becoming the owner or owner occupier, should this be after that date and kept maintained throughout the summer months until 31 May 2014.

Persons who fail to comply with the requisitions of this notice may be issued with an infringement notice or prosecuted. Where the owner fails to comply with the requisitions of the Notice, Council or it's duly Authorised Officers or contractors will carry out the required work at the cost of the owner or owner occupier.

In addition, you may be required to carry out further works which may be deemed necessary and specified by way of a separate written notice forwarded to the address shown on the City of Mandurah rate records for that land.

If it is considered for any reason impractical to clear firebreaks as required by this Notice, or if natural features render firebreaks unnecessary, you may apply in writing to the City of Mandurah or its duly authorised officers, not later than 1 November 2013, for alternative positions, or other methods of fire prevention on your land. If permission is not granted, you must comply with the requirements of the Notice.

WHAT YOU ARE REQUIRED TO DO

OCCUPIED OR UNOCCUPIED LAND LESS THAN 2023m²

Where the area of the land is less than $2023m^2$ remove all flammable material on the land except living standing trees and shrubs from the whole of the land. If mowing or slashing is carried out, then the height of the vegetation must not exceed, as far as reasonably practicable, 40mm over the entire area of land. A four metre firebreak is not acceptable.

OCCUPIED OR UNOCCUPIED LAND 2023m² AND OVER

When the area of land is 2023m² and over, provide a trafficable mineral earth firebreak at least four metres wide, with a vertical height clearance of 4.2 metres;

- 1. Immediately inside all external boundaries of the said land.
- 2. Immediately surrounding all outbuildings erected on the said land.

TEMPORARY SUSPENSION OF REGULATIONS

A Road Cycling Race—JW Smith Cup Handicap by members/entrants of the Albany Cycling Club Inc. on 24 August 2013 between the hours of 13:00 Hrs and 17:00 Hrs do hereby approve the temporary suspension of the Regulations made under such act on the carriageway(s) mentioned hereunder.

Racing to be confined to the left of the carriageway on: Frenchman Bay Road, Quaranup Road and Frenchman Bay Road, in the City of Albany. Temporary suspension of regulations applies to Regulation 130 (2) of the Road Traffic Code 2000 (overtaking other cyclists and riding in a peloton) in respect to cycling event competitors along the event route. Cyclists must keep left of the centre of the road, unless overtaking a slow moving vehicle where safe to do so, in accordance with the approved traffic management plan.

All participants to wear approved head protection at all times.

An Annual Foot Race—King of the Mountain by members/entrants of the West Australian Marathon Club (Inc) on 30 June 2013 between the hours of 08:00 Hrs and 10:00 Hrs do hereby approve the temporary suspension of the Regulations made under such act on the carriageway(s) mentioned hereunder.

Racing to be confined to the left of the carriageway on: Helena Valley Road (from Helena Valley Primary School to park land) and Mundaring Weir Road—from the end of Victor Road (opposite Mundaring Weir Museum entrance road) to Jacoby Park—in accordance with the approved traffic management plan and in compliance with local council requirements, in the Shire of Mundaring.

A Cycle Handicap Road Race by members/entrants of the Peel District Cycling Club (Inc) on 6 July 2013 between the hours of 13:00 Hrs and 16:30 Hrs do hereby approve the temporary suspension of the Regulations made under such act on the carriageway(s) mentioned hereunder.

Racing to be confined to the left of the carriageway on: Del Park Road to Dwellingup Caravan Park, then turn and retrace to start, in the Shire of Murray. Temporary suspension of regulations applies to Regulation 130 (2) of the Road Traffic Code 2000 (overtaking other cyclists and riding in a peloton) in respect to cycling event competitors along the event route. Cyclists must keep left of the centre of the road, unless overtaking a slow moving vehicle where safe to do so, in accordance with the approved traffic management plan.

All participants to wear approved head protection at all times.

A Cycling Road Race by members/entrants of the Collie Cycle Club Inc on 17 August 2013 between the hours of 09:00 Hrs and 17:00 Hrs do hereby approve the temporary suspension of the Regulations made under such act on the carriageway(s) mentioned hereunder.

Racing to be confined to the left of the carriageway on: Throssell Street, Patterson Street, Preston Road, Donnybrook/Boyup Brook Road and South Western Highway to Donnybrook and return to Collie via the same route, (Collie to Donnybrook and return). Temporary suspension of regulations applies to Regulation 50 of the Road Traffic Code 2000 (to allow cyclists to contravene a stop sign/white stop line), where opposing traffic at those locations is stopped and held by accredited traffic controllers with stop/slow bats in accordance with the approved traffic management plan and Regulation 130 (2) of the Road Traffic Code (to allow cyclists to ride in a peloton and overtake each her more than two or three abreast). Cyclists must keep left of the centre of the road unless overtaking a slow moving vehicle where safe to do so, or competing in a sprint finish where accredited traffic controllers with stop/slow bats are stopping and holding opposing traffic, in accordance with the approved traffic management plan.

All participants to wear approved head protection at all times.

A Cycle Road Race by members/entrants of the Eastern Goldfields Cycling Club Inc on 14 July 2013 between the hours of 07:30 Hrs and 12:30 Hrs do hereby approve the temporary suspension of the Regulations made under such act on the carriageway(s) mentioned hereunder.
