## **Conservation and Land Management Amendment Regulations (No. 3) 2013**

Made by the Governor in Executive Council.

### 1. Citation

These regulations are the *Conservation and Land Management Amendment Regulations (No. 3) 2013.* 

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on 1 October 2013.

### **3.** Regulations amended

These regulations amend the *Conservation and Land Management Regulations* 2002.

### 4. Regulation 56 amended

Delete regulation 56(5)(a) and (b) and insert:

## WESTERN AUSTRALIAN MARINE ACT 1982 NAVIGABLE WATERS REGULATIONS 1958

EXEMPTION

Australian Jet Sports Boating Association

I, David Harrod, General Manager Marine Safety, Department of Transport, delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act* 1982 (the Act) and regulation 47F of the *Navigable Waters Regulations* 1958 (the Regulations), hereby

exempt bona fide affiliated club members (bona fide club members) of the Australian Jet Sports Boating Association (the Association) from compliance with regulations 47A(3), 47A(4) and 48(c) when operating RST vessels that are *personal watercraft*.

In this instrument the terms "personal watercraft" (PWC) and "RST vessel" (hereafter vessel) have the same meaning as defined in regulations 46(2) and 47(1) respectively.

In addition, in accordance with regulation 48(a) of the Regulations, I also hereby grant approval to bona fide club members to exceed the speed limit in regulation 48(a).

This exemption and approval are subject to the following conditions-

Conditions-

- 1. This exemption and approval only has effect in relation to aquatic events and to circumstances where training is being undertaken for such events, which have been assessed and approved under regulation 51C of the Regulations and if all conditions attached to that approval are adhered to at all times.
- 2. Any PWC operated by an exempt person must be
  - a. currently registered in accordance with Part VA of the regulations; and
  - b. operated in accordance with the applicable Association Racing Rules as well as the International Jet Sports Boating Association Rulebook, and any other Association safety management protocols.
- 3. An exempt person must
  - a. be at least ten (10) years of age;
  - b. have been comprehensively briefed by the Association on all safety and emergency procedures prior to the commencement of any aquatic event or training related to the event;
  - c. not operate their vessel so as to endanger any person nor impede the safe passage of any other craft operating in the area; and
  - d. not operate their vessel at a speed exceeding eight (8) knots within fifteen (15) metres of a vessel underway unless that vessel is also subject to this exemption.
- 4. An exempt person must only operate a PWC in an event which
  - a. is conducted with no less than two (2) power driven vessels acting as recovery and rescue craft;
  - b. is conducted only between the hours of sunrise and sunset;
  - c. occurs only in PWC freestyling areas, or in waters that are closed to all other vessels and swimming, pursuant to section 66 of the Act and regulation 10A(b) of the Regulations; and

d. is free from all other vessels and persons not involved with the event.

This exemption is valid 1 October 2013 until 30 September 2014 unless otherwise revoked.
