#### **BUSH FIRES ACT 1954**

 $City\ of\ Melville$  FIRE BREAK NOTICE

Notice to all owner and / or occupiers of land situated in the City of Melville.

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before the 15th day of November 2013 or within 14 days of the date of you becoming the owner or occupier, should this be after the 15th day of November 2013 and thereafter up to and including the 30th day of April 2014 to clear flammable matter from that land in accordance with the following requirements—

- A As to land which is 1,500 square metres or less in area, or which is zoned "residential" to clear all flammable matter from the whole of the land except living trees, shrubs and plants under cultivation and lawns.
- B As to all other land within the district the owner or occupier shall—
  - (i) Clear firebreaks of a minimum width of three (3) metres inside all external boundaries of the land; and
  - (ii) Clear firebreaks of a minimum width of five (5) metres around all buildings situated on the land; and
  - (iii) Where that area of land exceeds ten (10) hectares, clear firebreaks of a minimum width of five (5) metres so as to ensure that no area of land within the firebreaks exceeds ten hectares in land; and
  - (iv) In any event, clear the firebreaks to the satisfaction of Council's duly authorised officer.

If for any reason an owner or occupier considers it to be impracticable to clear firebreaks or comply with other fire protection measures in accordance with this requirement, the owner or occupier may

apply in writing to the Council's duly authorised officer no later than 31 October 2013 for an exemption or partial exemption from compliance with the requirement of this notice.

The penalty for failing to comply with this notice is a fine of not more than \$5,000 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

#### SALARIES AND ALLOWANCES ACT 1975

DETERMINATION VARIATION
Parliament of Western Australia

#### Preamble

Section 4(2) of the Salaries and Allowances Act 1975 provides for remuneration to be paid to various officers of the Parliament including "the person who is the Whip in the Legislative Council or the Legislative Assembly of a party of at least 7 members other than a party whose leader is the Premier or the Leader of the Opposition and the first mentioned party in the case of the Whip in the Legislative Council has 7 members or more in that House or in the case of the Whip in the Legislative Assembly has 7 or more members in that House".

This determination provides for the remuneration of the recently appointed National Party Whip in the Legislative Assembly.

The determination also adds the holder of this new office to the list of office holders who continue to receive the salary of the office during the care taker period prior to an election—that is, where the Legislative Assembly is dissolved or expires by the effluxion of time until such time as the office holder ceases to be a Member by reason of an event other than the dissolution or expiry by the effluxion of time of the Legislative Assembly or another person is elected or appointed to the office held by that person.

#### **Determination**

The determination of the Salaries and Allowances Tribunal made on the 9th day of August 2013 under sections 6(1)(a), (ab), (b) and 6AA of the *Salaries and Allowances Act 1975*, as amended from time to time, is hereby varied by a further determination set out below.

The variation is effective from 13 August 2013.

Remove Part 1 Section 1.3.

Include in Part 1, Section 1.3 the following—

- 1.3 Where the Legislative Assembly is dissolved or expires by the effluxion of time, a person who is the Parliamentary Secretary of the Cabinet or immediately before the dissolution or expiry by the effluxion of time was the Chairman of Committees in the House (Deputy Speaker) or is the holder of the office of—
  - 1.3.1 Leader of the Opposition in that House;
  - 1.3.2 Leader of a recognised non-Government party (as defined in Section 2 of Part 2 of this determination);
  - 1.3.3 Deputy Leader of the Opposition in that House;
  - 1.3.4 Government Whip in that House;
  - 1.3.5 Opposition Whip in that House; or

whichever event shall first occur.

1.3.6 Recognised minor party Whip (as defined in Section 2 of Part 2 of this determination) in that House;

is entitled to receive the remuneration payable to that office holder by virtue of Section 2 of Part 2 of this determination until—  $\,$ 

- 1.3.7 that person ceases to be a Member by reason of an event other than the dissolution or expiry by the effluxion of time of the Legislative Assembly; or
- 1.3.8 another person is elected or appointed to the office held by that person;
