CEMETERIES ACT 1986 LOCAL GOVERNMENT ACT 1995

Shire of Broome

CEMETERIES AMENDMENT LOCAL LAW 2013

Under the powers conferred by the *Cemeteries Act 1986* and the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Broome resolved on 19 December 2013 to make the following local law.

1. Citation

This local law may be cited as the Shire of Broome Cemeteries Amendment Local Law 2013.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the Government Gazette.

3. Local law amended

The Shire of Broome Cemeteries Local Law 2012 as published in the Government Gazette on 19 February 2013 is referred to as the principal local law. The principal local law is amended.

4. Clause 3.3 amended

Delete clause 3.3(2) and insert—

- (2) A Funeral Director shall complete a certificate in the form determined by the Board from time to time, where—
 - (a) in the opinion of the Funeral Director, the dead body is not in a fit state to be viewed: or
 - (b) after reasonable effort the Funeral Director is unable to arrange for a person to identify the dead body.

5. Clause 7.13 amended

Delete subclause 7.13(1)(a)(i) and insert—

(i) unless a greater height is approved in writing by the CEO, the overall height
of a monument above the original surface of the grave shall not exceed
1.05m;

6. Part 7 amended

In the correct sequence of Part 7 insert the following—

Division 3—Licensing of Monumental Masons

7.16 Monumental mason's licence

- (1) The Board may upon receipt of an application in writing by any person and upon payment of the set fee issue to the applicant a monumental mason's licence.
- (2) A licence issued under subclause (1) authorises the holder to carry out monumental works within the cemetery subject to the provisions of this local law and such conditions as the Board shall specify upon the issue of that licence.

7.17 Expiry date, non-transferability

A monumental mason's licence—

- (a) shall be valid from the date specified therein until 30 June next following; and
- (b) is not transferable.

7.18 Carrying out monumental work

A person shall not carry out monumental work within the cemetery unless that person

- (a) is the holder of a current monumental mason's licence issued pursuant to clause 7.16; or
- (b) is an employee of a person who holds such a licence; or
- (c) is authorised by the Board to do so.

7.19 Responsibilities of the holder of a monumental mason's licence

The holder of a monumental mason's licence shall be responsible for the compliance by every person purporting to be authorised to carry out monumental works within the cemetery pursuant to that licence with all the requirements and conditions of the licence, this local law, the Act and any other written law which may affect the carrying out of monumental works.

7.20 Cancellation of a monumental mason's licence

- (1) The Board may by notice in writing to the holder of a monumental mason's licence terminate the licence on any of the following grounds—
 - (a) that the holder of the licence has committed a breach of the requirements and conditions of the licence, this local law, the Act or any other written law which may affect the carrying out of monumental works:
 - (b) that, in the opinion of the Board, the conduct of the holder of the licence or any person in the employ of that holder in carrying out or attempting to carry out any works within the cemetery, is inappropriate or unbecoming; or
 - (c) that the holder of the licence has purported to transfer the licence issued to that holder.
- (2) Upon the termination of a monumental mason's licence under this clause no part of any fee paid for the issue of that licence is refundable by the Board.

7. Clause 9.2 amended

Delete clause 9.2(2) and insert-

(2) The modified penalty payable in respect of an offence specified in Schedule 1 is set out in the fourth column of Schedule 1.

8. Schedule 1 amended

Delete Schedule 1 and insert—

Schedule 1—Modified Penalties
