The Environmental Protection Authority (“the Authority”), acting pursuant to section 19 of the *Environmental Protection Act 1986* (“the Act”), has resolved to hereby delegate to Mr Glen McLeod, Mr Gerard Early and Dr Tom Hatton, acting jointly, all of its powers and duties under Part IV, Division 1 of the Act in respect of—

1. the strategic proposal for a Common User LNG Hub Precinct in the Kimberley Region, which was referred to the Authority by the Minister for State Development by letter dated 25 March 2008, as changed from time to time.
2. any referred proposal which the proponent requests be declared to be a derived proposal if the referred proposal is, or is claimed by the proponent to be, identified in the strategic proposal referred to in paragraph 1 of this instrument of delegation.
