Glen Mervyn Dam

Acting pursuant to the powers conferred by Regulation 48A of the *Navigable Waters Regulations* 1958, I hereby cancel Notice MA 401 as published in the *Government Gazette* on 16 September 2011 and hereby set aside the following area of water for the purpose of water skiing—

Glen Mervyn Dam

Whilst the official Glen Mervyn Dam water level is equal to or higher that 200 metres above the Australian Height Datum as published by the Water Corporation of Western Australia—

All those waters of Glen Mervyn Dam north of a line from position 116°5.853'E, 33°30.070'S (on the western shore approximately 230 metres north of the dam wall) to 116°6.030'E, 33°30.018'S (on the eastern shore approximately 280 metres north of the dam wall) and west of a line from 116°6.030'E, 33°30.018'S to 116°6.051'E, 33°29.903'S across the entrance to the eastern arm. All coordinates based on GDA94.

Providing however that the direction of all water skiing shall be in an anti-clockwise direction and that skiing is only permitted within the hours of sunrise and sunset only.

This dam is 'Closed to Water Skiing' when the official water level is below 200 metres above Australian Height Datum, as published by the Water Corporation of Western Australia.
