SCHOOL EDUCATION ACT 1999**DECLARATION OF LOCAL-INTAKE AREAS FOR SCHOOLS WITH SECONDARY STUDENTS**

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education has declared that the local-intake areas for the secondary schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local-intake areas of the following secondary schools shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

ALBANY SENIOR HIGH SCHOOL (Jun14)

The following defines the local-intake of this school—

From Melville Point (UBD Country Link Street Directory) on Princess Royal Harbour, north to Princess Royal Drive, north west along Princess Royal Drive (north side included) to Hanrahan Road, north along Hanrahan Road (east side included) to Serpentine Road, south along Serpentine Road (both sides excluded) to the south west extension of Wellington Street, north east along this extension and continuing along Wellington Street (both sides excluded) to Centennial Park, north east through Centennial Park to the junction of Sanford Road and North Road, south east along North Road from this junction to the western boundary of the of the Amity Retirement Village, north along this boundary and its northern extension to Range Road, north along Range Road (east side included) to Bond Road, east along Bond Road (south side included) to Curtiss Road, north along Curtiss Road (east side included) and the northern extension of Curtiss Road to the junction of Chester Pass Road and Willyung Road, north east along Chester Pass Road (both sides excluded) to King River, generally north west along King River to Hazzard Road, west along Hazzard Road (both sides included) to the junction with the southern extension of Bailey Road, north along this extension to Bailey Road, north along Bailey Road (both sides excluded) and its northern extension to the local government boundary between the City of Albany and the Shire of Plantagenet, east and then north along this local government boundary to the intersection with Armstrong Road, east along Armstrong Road (south side included), to the junction of Takenup Road, south east along Takenup Road (south west side included) to Mindijup Road, south east along Mindijup Road (south side included) to the intersection with Palmdale Road, north along Palmdale Road (east side included) to Lake Warburton Road, east along Lake Warburton Road (south side included) to the intersection with Pfeiffer Road, north along Pfeiffer Road (east side included) to the intersection with Drawbin Road, east then south east along Drawbin Road (south side included) to South Coast Highway, north then north west along South West Highway (south side included) to the intersection with Spring Road, from this point due south to the Cordinup River, south along the river to the Southern Ocean, then south west along the coastline to Melville Point on Princess Royal Harbour.

APPLECROSS SENIOR HIGH SCHOOL (Jun14)

The following defines the local-intake of this school—

From the intersection of Leach Highway and North Lake Road, east along Leach Highway (north side included) to Riseley Street, north along Riseley Street (west side included) to Karoonda Road, east along Karoonda Road (both sides included) to Canning Avenue, north east along Canning Avenue (both sides included) and its extension to the foreshore of the Canning River, north along the foreshore of the Canning River and continuing west and south west along the foreshore of the Swan River to the northern extension of North Lake Road, south along this extension and North Lake Road (east side included) to the intersection with Leach Highway.

Students resident within the following area have the entitlement of attending either Applecross Senior High School or Rossmoyne Senior High School—

From the junction of Leach Highway and Riseley Street, north along Riseley Street (east side included) to Karoonda Road, east along Karoonda Road (both sides excluded) to Canning Avenue, north east along Canning Avenue (both sides excluded) and its extension to the Canning River foreshore, south along the Canning River and Bull Creek foreshores to Bateman Park, south through Bateman Park to the junction of Leach Highway and Bull Creek Drive, west along Leach Highway (north side included) to the junction with Riseley Street.

Students resident within the following area have the entitlement of attending either Applecross Senior High School or Melville Senior High School—

From the junction of Leach Highway and Winthrop Drive, south along Winthrop Drive (east side included) to Somerville Boulevard, east along Somerville Boulevard (north side included) to Prescott Drive, south along Prescott Drive (both sides included) to South Street, east along South Street (north side included) to Murdoch Drive, north along Murdoch Drive (west side included) to Leach Highway and west along Leach Highway (south side included) to the junction with Winthrop Drive.

ASHDALE SECONDARY COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the intersection of Wanneroo Road and Hepburn Avenue, east along Hepburn Avenue (north side included) to Alexander Drive, north along Alexander Drive (west side included) to

Park Street, east along Park Street (both sides included) and its extension to the north-south alignment of the locality boundary between Cullacabardee and Landsdale, north along this locality boundary to the junction of Gngangara Road and Cecil Road, west along Gngangara Road (south side included) to the proposed alignment of Ocean Reef Road, north west and west along the proposed alignment of Ocean Reef Road, and continuing west along the existing section of Ocean Reef Road (south side included) to Wanneroo Road, and south along Wanneroo Road (east side included) to Hepburn Avenue.

Students residing within the locality of Gngangara have the option of attending either Ashdale Secondary College or Wanneroo Senior High School.

ATWELL COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the junction of Armadale Road and Liddelow Road, south along Liddelow Road (west side included) to Rowley Road, east along Rowley Road (south side included) to De Haer Road, south along De Haer Road (north side included) to the more southern of the two junctions with Leslie Road, south from this point on De Haer Road to the locality boundary between Anketell and Oakford on Anketell Road, west along Anketell Road (north side included) to the Kwinana Freeway, north along the Kwinana Freeway (east side included) to Rowley Road, west along Rowley Road (north side included), and continuing west along the local government boundary between the City of Cockburn and the Town of Kwinana to Mandogalup Road, north along Mandogalup Road (east side included) and its northern extension to Russell Road, east along Russell Road (south side included) to a point due south of the centre of Kogolup Lake, north from this point on Russell Road through Thompsons Lake and Kogolup Lake to Beeliar Drive, east along Beeliar Drive (south side included) to a point due south of the junction of North Lake Road and Osprey Drive, north to a point on the western extension of Yangebup Road (eastern section), east along this extension to Yangebup Road, east along Yangebup Road (south side included) to Cooper Road, east and south east along Cooper Road (south side included) to Poletti Road, south along Poletti Road (west side included) to Beeliar Drive, east along Beeliar Drive (south side included) to the Kwinana Freeway, and continuing east along Armadale Road (south side included) to Solomon Road, north east along Solomon Road (east side included) to Jandakot Road, and continuing north east along Solomon Road and its extension to the north west/south east runway of Jandakot airport, south east along the south east extension of the runway to Fraser Road, south west along Fraser Road (west side included) to Jandakot Road and south to the junction of Armadale Road and Liddelow Road.

The following defines an optional area for Atwell College and Armadale Senior High School—

From the junction of Armadale Road and Liddelow Road, south along Liddelow Road (east side included), to Rowley Road, east along Rowley Road (north side included) to De Haer Road, south along De Haer Road (south side included) to the more southern of the two junctions with Leslie Road, south from this point on De Haer Road to the locality boundary between Anketell and Oakford on Anketell Road, west along Anketell Road (north side included) to a point due south of the junction of Foxton Drive and Craddon Road, north from this point to the junction of Foxton Drive and Craddon Road, generally north along Craddon Drive (both sides excluded) to the junction of Craddon Drive and Ditton Road, north along Ditton Road (both sides excluded) to Rowley Road, west along Rowley Road (south side included) to Taylor Road, north along Taylor Road (both sides included) to Armadale Road, north west along Armadale Road (south side included) to Warton Road, north east along Warton Road (both sides excluded) to Jandakot Road, north west along Jandakot Road to Fraser Road, and south to the junction of Armadale Road and Liddelow Road.

The following defines an optional area for Atwell College and Gilmore College—

From the intersection of the Kwinana Freeway and Rowley Road, south along the Kwinana Freeway (west side included) to Anketell Road, west along Anketell Road (north side included) to Clementi Road, north from this junction to Madogolup Road, north west along Madogolup Road (east side included) to the local government boundary between the City of Cockburn and the Town of Kwinana, east along this local government boundary to Rowley Road, and continuing east along Rowley Road (south side included) to the Kwinana Freeway.

AUSTRALIND SENIOR HIGH SCHOOL (Jun14)

The following defines the local-intake area of this school—

From the intersection of the westerly extension of Pead Road with the coastline, east along the aforesaid extension of Pead Road, east along Pead Road (south side included) and the easterly extension of Pead Road to the gas pipeline corridor, south along the gas pipeline corridor to a point due west from the confluence of the Mornington River and Wellesley River, east to the aforesaid confluence, south along the Wellesley River to the Brunswick River, south west along the Brunswick River to the Australind Bypass, south and south west along the Australind Bypass (west side included) to the Collie River, generally west along the Collie River to the Leschenault Inlet, west across the Leschenault Inlet to The Cut on the coastline of the Indian Ocean and north along the coastline to the western extension of Pead Road.

The following defines the boundary for an optional area between Australind Senior High School and Harvey Senior High School—

From the junction of the Collie River and the Australind Bypass, north along the Australind Bypass (east side included) to the Brunswick River, north east along the Brunswick River to the confluence of the Wellesley River, north and east along the Wellesley River to the confluence of the Wellesley and Mornington River, east along the Mornington River to the bridge at Campbell

Road, east from the bridge to the junction of the South West Highway and Sandalwood Road, east along Sandalwood Drive to Robinson Road, south along Robinson Road (south side included) to Hill Road, south east along Hill Road to the railway line, south east along the railway line to the locality boundary of Harvey and Collie, south along the locality boundary to the Collie River, and generally north west along the Collie River to the Australind Bypass.

BALGA SENIOR HIGH SCHOOL (Jun14)

The following defines the local-intake area of this school—

From the intersection of Reid Highway and Wanneroo Road, north along Wanneroo Road (east side included) to Treen Street west along Treen Street (both sides included) to the intersection with Muswell Street, north west along Muswell Street (both sides included) to Beach Road, south east then east along Beach Road (south side included) to the intersection with Mirrabooka Avenue, north along Mirrabooka Avenue (east side included) to the northern boundary of the Mercy College and Mercy Primary School site, east along this boundary and its extension to the western arm of Brinckley Crescent, north along Brinckley Crescent (east side included) to Whitehouse Drive, east and northeast along Whitehouse Drive (south side included) to Hollingsworth Avenue, southeast along Hollingsworth Avenue (south side included) to Durack Place, north east through Butterworth Park to the junction of Burlinson Crescent and Butterworth Avenue, northeast from this point between Gabell Way to the north and Waddington Crescent to the south to the southern corner of the reservoir, east from this point to Alexander Drive and south along Alexander Drive (west side included) to the intersection with Reid Highway, west along Reid Highway (north side included) to the intersection with Wanneroo Road.

BALLAJURA COMMUNITY COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the intersection of Alexander Drive and Marangaroo Drive, south along Alexander Drive (east side included) to Beach Road, east along Beach Road (north side included) Marshall Road, east along Marshall Road (north side included) to Hepburn Avenue, north and north west along Hepburn Avenue (south west and south sides included) to the locality boundary between Ballajura and Cullacabardee, north and west along this boundary (west and south sides included) to Hepburn Avenue, north west and west along Hepburn Avenue (south west and south sides included) to the northern extension of Axford Road, south along Axford Road (both sides included) and its extension to Derbi Road, south along Derbi Road (both sides included) to Hillcrest Road, south west along Hillcrest Road (both sides included) to Gerosa Place, south along Gerosa Place (both sides included) to Marangaroo Drive and east along Marangaroo Drive (north side included) to Alexander Drive.

BELMONT CITY COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the overpass of Victoria Park Drive and the Graham Farmer Freeway, south east along the Graham Farmer Freeway (north east side included) to Orrong Road, continuing south east along Orrong Road (north east side included) to Kewdale Road, north east along Kewdale Road (north west side included) to Tonkin Highway, continuing north along Horrie Miller Drive (west side included) and its extension to the local government authority boundary (City of Belmont and Shire of Swan), north-west along the local government boundary to Great Eastern Highway, south-west along Great Eastern Highway (east side) to Ivy Street, north-west along Ivy Street (both sides included) to the Swan River foreshore, south, south-west and west along the Swan River foreshore to a point due east of the overpass at Victoria Park Drive and the Graham Farmer Freeway and west to this overpass.

The following defines an optional area between Belmont City College and Kent Street Senior High School—

From the overpass of Victoria Park Drive and the Graham Farmer Freeway, south east along the Graham Farmer Freeway (south west side included) to Orrong Road, continuing south east along Orrong Road (south west side included) to Kewdale Road, south along Kewdale Road (west side included) to Welshpool Road, west along Welshpool Road (north side included) to the railway line, north west along the railway line to the Belmont Park railway station, and north east to the overpass of Victoria Park Drive and the Graham Farmer Freeway.

BUSSELTON SENIOR HIGH SCHOOL (Jun14)

The following defines the local intake of this school—

From the intersection of Vasse Highway and Sabina Road, north east along Sabina Road (north side included) to Williamson Road, east along Williamson Road (north side included) to Evan Road, north on Evan Road (west side included) to the local government boundary between the Shire of Busselton and the Shire of Capel, generally west along this local government boundary to near the junction of Armstrong Road and Tutunup Road, north along the local government boundary to the eastern extension of Downes Road, west along this extension and west along Downes Road (north side included) to Colyoolup Road, north along Colyoolup Road (east side included) to Hutton Road, north along Hutton Road (east side included) to Bussell Highway, north west from Bussell Highway through the Tuart Forest National Park to the Indian Ocean coastline, south west along the coastline to Queen Street, south along Queen Street (east side included) to Albert Street, west along Albert Street (south side included) to Bussell Highway, continuing west along Bussell Highway (south side included) to the drainage channel adjacent to Queen Elizabeth Avenue, south along the drainage channel (east side included) to the New

(Broadwater) River, west along the New River to Fairway Drive, south along Fairway Drive (east side included) to the Busselton Bypass, east along the Busselton Bypass (north side included) to Queen Elizabeth Avenue, south along Queen Elizabeth Avenue (east side included) to Don Road, south on Don Road (east side included) to Evans Road, west along Evans Road (south side included) to its intersection with the Vasse River, south along the Vasse River (east side included) to the intersection with Cane Brake Road, north on Cane Brake Road (west side included) to Sabina Road (western section), north east on Sabina Road, (north west side included) to Sues Road, north along Sues Road (west side included) to Sabina Road (eastern section), and north east along Sabina Road (eastern section, north west side included) to the intersection with the Vasse Highway.

The following defines an optional area between Cape Naturaliste College and Busselton Senior High School—

From the coastline of Geographe Bay, south along Holgate Road (both sides included) and its extension to and along the eastern north-south boundary of Lot 219 (excluded) on the Busselton Bypass, east along the Busselton Bypass (north side included) to Fairway Drive, north along Fairway Drive (west side included) to the New (Broadwater) River, east along the New (Broadwater) River to the drainage channel, north along the drainage channel (west side included) to Bussell Highway, east along the Bussell Highway (north side included) and continuing east along Albert Street (north side included) to Queen Street, north along Queen Street (west side included) to Geographe Bay, and west along the coastline of Geographe Bay to the northern extension of Holgate Road.

CANNINGTON COMMUNITY COLLEGE (Jun14)

The following defines the local-intake area of this school for lower secondary school: students.

From the junction of Albany Highway and Leach Highway, south west along Leach Highway (south east side included) to the Shelley Bridge, generally east and south east along the Canning River to the Roe Highway, north east and north along the Roe Highway (west side included) to the Tonkin Highway, north west along the Tonkin Highway (south west side included) to Kewdale Road, south west along Kewdale Road (south east side included) to Welshpool Road, west along Welshpool Road (south side included) to the railway line, south east along the railway line to Leach Highway and south west along Leach Highway (south east side included) to Albany Highway.

The following defines an optional area between Cannington Community College and Kent Street Senior High School—

From the intersection of Albany Highway and Leach Highway, north east along Leach Highway (north west side included) to the railway line, north west along the railway line to Welshpool Road, west along Welshpool Road (south side included) to Albany Highway, and south east along Albany Highway (north east side included) to Leach Highway.

CANNING VALE COLLEGE (Jun14)

The following defines the local intake of this school—

From the junction of Garden Street and Warton Road, south west along Warton Road (west side included) to Nicholson Road, north along Nicholson Road (east side included) to Acourt Road, north west along Acourt Road (north east side included) to Johnston Road, north along Johnston Road (east side included) to Clifton Road, north and north west along Clifton Road (east side included) and its extension to the railway line, north east along the railway line to Nicholson Road, south east along Nicholson Road (south west side included) to Garden Street, and continuing south and south east along Garden Street (south west side included) to Warton Road.

The following defines an optional area between Canning Vale College, Southern River College and Thornlie Senior High School—

From the junction of Warton Road and Holmes Street, east along Holmes Street (south side included) to Lakey Street, south west along Lakey Street (both sides) to Barrett Street, south east along Barrett Street (south west side included) to Balfour Street, south west along Balfour Street (north west side included) to Ranford Road, north west along Ranford Road (north east side included) to Wright Road, south west along Wright Road (north west side included) to the main entrance of Carey College, north west from the main entrance of Carey College through Harrisdale Swamp to Warton Road and north east along Warton Road (south east side included) to Holmes Street. (Note: It is anticipated that this optional area will eventually become part of the local-intake area of a future secondary school in Southern River or Forrestdale, and will cease to be part of the local-intake area of Canning Vale College.)

The following defines an optional area between Canning Vale College and Armadale Senior High School—

From the intersection of Nicholson Road and Warton Road, north along Nicholson Road (both sides excluded) to Acourt Road, north west along Acourt Road (both sides excluded) to Fraser Road, south west along Fraser Road (east side included) to Jandakot Road, south east along Jandakot Road (north side included) to Warton Road, and north east along Warton Road (both sides excluded) to Nicholson Road. (Note: It is anticipated that this optional area will eventually become part of the local-intake area of a future secondary school in Forrestdale, and will cease to be part of the local-intake area of Canning Vale College.)

CAPE NATURALISTE COLLEGE (Jun14)

The following defines the local intake of this school—

From a point on the western extension of Woodlands Road and the coast, north along the coast to Cape Naturalist, south east along the coast of Geographe Bay to Holgate Road, south along Holgate Road (both sides excluded) and south along the extension of Holgate Roads to the eastern north-south boundary of Lot 219, south along the eastern boundary of Lot 219 (included) to the Busselton Bypass, east along the Busselton Bypass (south side included) to Queen Elizabeth Avenue, south along Queen Elizabeth Avenue (west side included) to Don Road, south on Don Road (west side included), to Evans Road, west on Evans Road to the intersection with the Vasse River, south along the Vasse River (west side included) to the local government boundary between the Shires of Busselton and Augusta-Margaret River, west along this local government boundary to Jacka Road, north on Jacka Road (east side included) to Price Road, west on Price Road (north side included) to Gale Road, north west on Gale Road (north side included) to the junction with Bussell Highway and Metricup Road, west along Metricup Road (north side included) to Woodlands Road, west along Woodlands Road (north side included) and west along its extension to the coast.

The following defines an optional area between Cape Naturaliste College and Busselton Senior High School—

From the coastline of Geographe Bay, south along Holgate Road (both sides included) and its extension to and along the eastern north-south boundary of Lot 219 (excluded) on the Busselton Bypass, east along the Busselton Bypass (north side included) to Fairway Drive, north along Fairway Drive (west side included) to the New (Broadwater) River, east along the New (Broadwater) River to the drainage channel, north along the drainage channel (west side included) to Bussell Highway, east along the Bussell Highway (north side included) and continuing east along Albert Street (north side included) to Queen Street, north along Queen Street (west side included) to Geographe Bay, and west along the coastline of Geographe Bay to the northern extension of Holgate Road.

COMET BAY COLLEGE (Jun14)

The following will define the local-intake area of this school—

From the junction of Mandurah Road and the locality boundary between Secret Harbour and Port Kennedy, north along Mandurah Road (east side included) to Stakehill Road, east along Stakehill Road (south side included) to the junction of Stakehill Road, Baldivis Road and the locality boundary between Baldivis and Karnup, east along this locality boundary to the Serpentine River, south along the Serpentine River to the southern boundary of the locality of Karnup, west along the southern boundary of the locality of Karnup to Mandurah Road, continuing west across Mandurah Road and along the locality boundary between Madora Bay and Singleton to the Indian Ocean coastline, north along the coastline to a point on the locality boundary between Secret Harbour and Port Kennedy and east along this locality boundary to Mandurah Road.

The following defines an optional area between Comet Bay College and John Tonkin College—

From the coastline of the Indian Ocean, east along the locality boundary between Madora Bay and Singleton to Mandurah Road, south along Mandurah Road (west side included) to a point on the easterly extension of Chieftan Pass, west along this extension to Chieftan Pass and west along Chieftan Pass (north side included) to Victor Drive, south along Victor Drive (west side included) to George Hibbert Road, west along George Hibbert Road (both sides excluded), and west along its westerly extension to the coastline and north along the coastline to the locality boundary of Madora Bay and Singleton.

COMO SECONDARY COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the Shelley Bridge, north east along Leach Highway (north west side included) to Manning Road, east along Manning Road (south side included) to a point due south of the southern extension of Hill View Terrace, north along this extension and Hill View Terrace (west side included) to Walpole Street, north east along Walpole Street (north west side included) to Holder Street, west along Holder Street (south side included) to Marquis Street, south west along Marquis Street (south east side included) to Hayman Road, generally north west along Hayman Road (south west side included) to South Terrace, west along South Terrace (south side included) to the Swan River foreshore, south along the Swan River foreshore and continuing south along the Canning River foreshore, and east along the Canning River foreshore to the Shelley bridge

The following defines an optional area between Como Secondary College and Kent Street Senior High School—

From the junction of Douglas Avenue and South Terrace, north west along Douglas Avenue (south west side included) and its north westerly extension to the Swan River foreshore, north west and south along the Swan River foreshore to a point on the westerly extension of South Terrace, east along this extension and east along South Terrace (north side included) to Douglas Avenue.

COODANUP COMMUNITY COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the 'old' Mandurah Bridge, east along Pinjarra Road (south side included) to the intersection with Mandurah Road, north along Mandurah Road (east side included) to Murdoch Drive, east along Murdoch Drive (south side included) to Bortolo Drive, north east along Bortolo

Drive (east side included) to the intersection with Exchequer Avenue, east along Exchequer Avenue (south side included) to Lakes Road, north and east along Lakes Road (east and south sides included) to the Serpentine River, south along the Serpentine River to Goegrup Lake, south across Goegrup lake to the Serpentine River and south from Goegrup Lake along the Serpentine River to the Peel Inlet, north west, west and north along the shore of the Peel Inlet to the 'old' Mandurah Bridge.

The following defines an optional area between Coodanup Community College and John Tonkin College—

From the intersection of Mandurah Road and Murdoch Drive, east along Murdoch Drive (north side included) to Bortolo Drive, north along Bortolo Drive (west side included) to Exchequer Avenue, east along Exchequer Avenue (north side included) to Lakes Road, north along Lakes Road (west side included) to Gordon Road, west along Gordon Road (south side included) to Mandurah Road and south along Mandurah Road (east side included) to Murdoch Drive.

Students residing in the localities of Barragup or Furnissdale have the option of attending either Coodanup Community College, John Tonkin College or Pinjarra Senior High School.

DARLING RANGE SPORTS COLLEGE (Jun14)

The following defines the local-intake area of this school—

The following defines an optional area between Churchlands SHS and Mount Lawley SHS—

From the intersection of Rae Road and Read Street, south-southeast along Read Street (east side included) to a point adjacent to the northern arm of Frome Way, in an east-north-easterly direction from this point to and along Frome Way (both sides excluded) to Broaden Drive, south along Broaden Drive (both sides included) to Norring Street, in an east-north-easterly direction between Raby Court, Lara Court, Greta Court and Rydal Court to the north and Tanby Place, Windale Place and Toora Place to the south to and across Linville Avenue and Wilmott Drive to Grange Drive, continuing in a general north-easterly direction along Grange Drive (north side included) to Ennis Avenue, northwest along Ennis Avenue (west side included) to Rae Road and in a west-south-westerly direction along Rae Road (south side included) to Read Street.

The following defines an optional area for Rockingham Senior High School and Safety Bay Senior High School—

From the intersection of Rae Road and Read Street, south-southeast along Read Street (east side included) to a point adjacent to the northern arm of Frome Way, in an east-north-easterly direction from this point to and along Frome Way (both sides excluded) to Broaden Drive, south along Broaden Drive (both sides included) to Norring Street, in an east-north-easterly direction between Raby Court, Lara Court, Greta Court and Rydal Court to the north and Tanby Place, Windale Place and Toora Place to the south to and across Linville Avenue and Wilmott Drive to Grange Drive, continuing in a general north-easterly direction along Grange Drive (north side included) to Ennis Avenue, northwest along Ennis Avenue (west side included) to Rae Road and in a west-south-westerly direction along Rae Road (south side included) to Read Street.

The following defines the boundary of an optional area between Kelmscott Senior High School and Southern River College—

From the junction of Mills Road East and Tonkin Highway, south along Tonkin Highway (east side included) to the bridge over the Canning River, south along the Canning River to the local government boundary between the City of Armadale and the City of Gosnells, east south and east along the local government boundary to the western boundary of the Cohunu Wildlife Sanctuary site and continuing north to a point east of the junction of Mills Road East and Pages Way, west from this point to the junction of Mills Road East and Pages Way (both sides included) and in a generally westerly direction along Mills Road East (both sides included) to the junction with Tonkin Highway.

The following defines an optional area between Hamilton Senior High School and South Fremantle Senior High School—

From the junction of Rockingham Road and Healy Road, east along Healy Road (both sides excluded) to Carrington Street, south along Carrington Street (west side included) to Rockingham Road and north west along Rockingham Road (north side included) to Healy Road.

The following defines an optional area between South Fremantle Senior High School and Hamilton Senior High School—

From the western extension of Rollinson Road on the coastline of the Indian Ocean, east along this extension, and east along Rollinson Road (both sides included) to Cockburn Road, north along Cockburn Road (west side included) to the junction with Island Street, west along Island Street (south side included) and its extension to the Indian Ocean, and south along the coastline to the western extension of Rollinson Road.

The following defines an optional area between John Curtin College of the Arts, Melville Senior High School, Shenton College and South Fremantle Senior High School—

From the Stirling Bridge, north along the Swan River western foreshore to the local government boundary between the City of Fremantle and the Town of Mosman Park, north and west along this local government boundary to the coastline of the Indian Ocean, south along the coastline to North Mole, east and north east along the north wharf of Fremantle Harbour and the northern foreshore of the Swan River to the Stirling Bridge.

From the intersection of Toodyay Road and Roe Highway, south along the Roe Highway (west side excluded) to Great Eastern Highway, west along Great Eastern Highway (south side included) to Lloyd Street, south along Lloyd Street (both sides excluded) to Clayton Street, south east along Clayton Street (north east side included) to Military Road, south along Military Road (both sides included) to Bushmead Road, east along Bushmead Road and Helena Valley Road to the local government boundary between the City of Swan and the Shire of Mundaring, south east, east and north east along this boundary to the local government boundary between the Shire of Kalamunda and the Shire of Mundaring, east, north east and south east along this boundary to the southern extension of Victor Road, north along this extension and Victor Road (west side included) to the locality boundary between Boya and Darlington, north along this locality boundary to the locality boundary between Darlington and Greenmount, north along this locality boundary to Pitterson Road, west along Pitterson Road (south side included) to a point on the southern extension of Stirling Road, north along this extension to Great Eastern Highway, east along Great Eastern highway to the intersection with the locality boundary between Greenmount and Hovea, north then west along this boundary to the locality boundary between Swan View and Hovea, generally north along this boundary to the intersection with the local government boundary between the City of Swan and the Shire of Mundaring, north east and north along this local government boundary to the intersection with Toodyay Road, and generally southwest along Toodyay Road (south side included) to the intersection with Roe Highway.

The following defines an optional area between Swan View Senior High School and Governor Stirling Senior High School—

From the intersection of Great Eastern Highway and Roe Highway, west along Great Eastern Highway (both sides included) to Bushby Street, north along Bushby Street (both sides included) and its extension northwards along the locality boundary to Eddie Barron Drive, east along the locality boundary between Middle Swan and Midvale to the Roe Highway, and south along the Roe Highway (west side included) to Great Eastern Highway.

The following defines an optional area for Swan View Senior High School, Eastern Hills Senior High School, and Kalamunda Senior High School—

From the junction of Darlington Road and the Great Eastern Highway, west along Great Eastern Highway (south side included) to the point where the southern extension of Stirling Road meets Great Eastern Highway, due south from this point to Pitterson Road, east along Pitterson Road (north side included) to the north-south alignment of the locality boundary between Darlington and Greenmount and its extension due south to Victor Road, south along Victor Road to the Helena River, generally east along the Helena River to the locality boundary between Mahogany Creek and Mundaring at the confluence of Helena River and Old Mill Gully, north along this locality boundary to Phillips Road east along Phillips Road (both sides included) to Coppin Road, north along Coppin Road (both sides excluded) to Jacoby Street, west along Jacoby Street (both sides included) to Craven Road, north along Craven Road (both sides included) to Great Eastern Highway, west along Great Eastern Highway (south side included) to Brooking Road, north along Brooking Road (both sides included) to Hedges Road, west along Hedges Road (both sides included) to the junction with Oxley Road, west along Oxley Road (both sides included) to the junction with Park Road, south along Park Road (both sides included) to Great Eastern Highway, west along Great Eastern Highway (south side included) to the junction with Darlington Road.

THORNLIE SENIOR HIGH SCHOOL (Jun14)

The following defines the local-intake area of this school—

From the intersection of Nicholson Road and the railway line, north east along the railway line to Albany Highway, south east along Albany Highway (south west side included) to Austin Avenue, south west along the locality boundary between Kenwick and Maddington to the Canning River, generally south along the Canning River to the confluence of the Canning River and the Southern River, south along the Southern River to Corfield Street, north east along Corfield Street (north side included) to Warton Road, south west along Warton Road (north west side included) to Garden Street, north west along Garden Street (east side included) to Nicholson Road, and north along Nicholson Road (north east side included) to the railway line.

The following is an optional area between Lynwood Senior High School and Thornlie Senior High School—

From the intersection of the Canning River and the railway line, south west along the railway line to Cameron Street, north west along Cameron Street (north east side included) to the Roe Highway, north east along the Roe Highway (south east side included) to the Canning River, and generally south east along the Canning River to the railway line.

The following defines the boundary of an optional area between Southern River College and Thornlie Senior High School—

From the junction of Barrett Street and Balfour Street, north east along Balfour Street (north east side) to Gay Street, north west along Gay Street (both sides included) to Warton Road, south west along Warton Road (south east side) to Holmes Street, east along Holmes Street (south side included) to Lakey Street, south west along Lakey Street (both sides included) to Barrett Street and south east along Barrett Street (north east side included) to Balfour Street.

The following defines an optional area between Canning Vale College, Southern River College and Thornlie Senior High School—

From the junction of Warton Road and Holmes Street, east along Holmes Street (south side included) to Lacey Street, south west along Lacey Street (both sides included) to Barrett Street, south east along Barrett Street (south west side included) to Balfour Street, south west along Balfour Street (north west side included) to Ranford Road, north west along Ranford Road (north east side included) to Wright Road, south west along Wright Road (north west side included) to the main entrance of Carey College, north west from the main entrance of Carey College through Harrisdale Swamp to Warton Road and north east along Warton Road (south east side included) to Barrett Street.

Note: It is anticipated that this optional area will eventually become part of the local-intake area of a future secondary school in Southern River or Forrestdale, and will cease to be part of the local-intake area of Canning Vale College.

WILLETTON SENIOR HIGH SCHOOL (Jun14)

The following defines the local-intake area of this school—

From the junction of High Road and Augusta Street, south along Augusta Street (both sides excluded) to Acanthus Road, west along Acanthus Road (both sides excluded) to Darvell Road, south along Darvell Road (both sides excluded) to Rhonda Avenue, west along Rhonda Avenue (south side included) to the northern extension of Donald Street, south along this extension and Donald Street (both sides excluded) to Apsley Road, west along Apsley Road (south side included) to Eagles Walk, south along the north-south alignment of Eagles Walk (both sides excluded) and its extension to Flamingo Way, south along the north-south alignment of Flamingo Way (both sides excluded) and its extension to Albatross Pass, west along Albatross Pass (both sides included) and its extension between Wren Close (both sides excluded) and Cormorant Cross (both sides included), and continuing north east between Brolga Promenade (both sides excluded) and both The Taffrail (both sides included) and The Quarterdeck (both sides included) to the junction of The Quarterdeck and The Escarpment, west from this junction to Karel Avenue, south along Karel Avenue (east side included) to Parry Avenue, west along Parry Avenue (south side included) to Wheatley Drive, south along Wheatley Drive (both sides excluded) to Vagg Street, continuing south along Wheatley Drive (both sides included) to the southern arm of Oberthur Crescent, east between Oberthur Crescent (both sides included) and Weeks Way (both sides

excluded) to the walkway linking Weeks Way and Anstie Way, east along this walkway to Anstie Way, north then east along the northern part of Anstie Way (both sides excluded) to Hetherington Drive, north-east along Hetherington Drive (both sides included) to Owgan Place, south-east along Owgan Place (both sides excluded) to Karel Avenue, south along Karel Avenue (east side included) to South Street, east along South Street (north side included) to Roe Highway, north east along Roe Highway (north west side included) to Willeri Drive, north along Willeri Drive (west side included) to High Road and west along High Road (south side included) to Augusta Street.

The following defines an optional area between Leeming Senior High School and Willetton Senior High School—

From the junction of South Street and Wheatley Drive, north along Wheatley Drive (both sides included) to the southern arm of Oberthur Crescent, east between Oberthur Crescent (both sides excluded) and Weeks Way (both sides included) to the walkway linking Weeks Way and Anstie Way, east along this walkway to Anstie Way, north then east along the northern part of Anstie Way (both sides included) to Hetherington Drive, north-east along Hetherington Drive (both sides excluded) to Owgan Place, south-east along Owgan Place (both sides included) to Karel Avenue, south along Karel Avenue (west side included) to South Street and west along South Street (north side included) to Wheatley Drive.

The following defines an optional area between Willetton Senior High School and Leeming Senior High School—

From the intersection of Parry Avenue and the Kwinana Freeway, south along the Kwinana Freeway (east side included) to a point opposite the western extension of Windich Road, in an easterly direction to and along Windich Road (both sides excluded) and its eastward extension to Benningfield Road, south along Benningfield Road (both sides excluded) to Henry Bull Drive, east then south-east along Henry Bull Drive (both sides excluded) to James Street, east along James Street (both sides excluded) to Hardy Street, south-east along Hardy Street (both sides excluded) to Darley Circle, south-east along Darley Circle (both sides excluded) to More Crescent, north-east along More Crescent (both sides excluded) to Back Close, east along Back Close (both sides excluded) and the walkway linking Back Close and Darley Circle, south along Darley Circle (both sides excluded) to Vagg Street, east along Vagg Street (both sides excluded) to Wheatley Drive, north along Wheatley Drive (both sides included) to Parry Avenue and west along Parry Avenue (south side included) to the Kwinana Freeway.

WOODVALE SECONDARY COLLEGE (Jun14)

The following defines the local-intake area of this school—

From the junction of Wanneroo Road and Ocean Reef Road, west along Ocean Reef Road (south side included) to the Mitchell Freeway, south along the Mitchell Freeway (east side included) to Whitfords Avenue, east along Whitfords Avenue (north side included) to Wanneroo Road, and north along Wanneroo Road (west side included) to Ocean Reef Road.

The following defines an optional area between Woodvale Secondary College and Greenwood College—

From the intersection of Whitfords Avenue and the Mitchell Freeway, east along Whitfords Avenue (south side included) to Wanneroo Road, south along Wanneroo Road (west side included) to a point due east of the east-west alignment of Montessori Place, west from this point to and along Montessori Place (both sides included) and its extension along the bike path to the Mitchell Freeway, and north along the Mitchell Freeway (east side included) to Whitfords Avenue.
