Local Government (Joondalup - Change of Boundaries) Order 2014

Made by the Administrator in Executive Council under sections 2.2(1) and 9.62 of the Act, on the recommendation of the Minister for Local Government.

1. Citation

This order is the *Local Government (Joondalup - Change of Boundaries) Order 2014.*

2. Commencement

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Terms used

In this order —

commencement day means the day on which the rest of the order comes into operation under clause 2(b);

next election means the next ordinary local government election for the City of Joondalup;

next election day means the day fixed for holding the next election.

4. Ward boundary changes — City of Joondalup (s. 2.2(1)(c) of the Act)

On and from the next election day, the boundaries of the North Ward and the North-Central Ward of the City of Joondalup are changed by transferring the suburb of Connolly (as described in Schedule 1) from the North Ward to the North-Central Ward.

5. Consequential directions (s. 9.62 of the Act)

In order to give effect to this order —

- (a) Part 4 of the Act applies to preparing for and conducting the next election as if the changes effected by this order take effect on commencement day; and
- (b) the operation of Part 4 of the Act is modified to the extent necessary for the purposes of paragraph (a).

BUSH FIRES ACT 1954

City of Gosnells

ANNUAL FIRE HAZARD REDUCTION NOTICE

To prevent bush fires and to minimise the spread of a bush fire, all owners and occupiers of land within the City's district are required to comply with the requirements of this Annual Fire Hazard Reduction Notice.

1. OWNERS AND OCCUPIERS OF LAND ZONED 'GENERAL RURAL' OR 'SPECIAL RURAL'

On or before 30 November in each year, all owners or occupiers of land zoned 'General Rural' or 'Special Rural' under the City of Gosnells Town Planning Scheme No. 6 are required to—

- (a) Clear and maintain the land free of all flammable matter to a height no greater than 10cm; or
 - (b) Maintain a mineral earth firebreak immediately inside all external boundaries of each lot on the land; and maintain a mineral earth firebreak within 20m of all haystacks and stockpiled flammable matter.

Mineral earth firebreaks must be continuous (no dead ends) and maintained to a minimum standard of three metres wide by four metres high (vertical clearance) so as to provide unimpeded access for emergency vehicles. Driveways must also be maintained to these standards.

Firebreaks are intended to provide safe access on your property for emergency vehicles and to ensure fire does not travel under the vehicles or underfoot.

NOTE: The firebreaks and requirements set out above must be maintained up to and including 30 April in the following year.

2. OWNERS AND OCCUPIERS OF ALL OTHER LAND WHICH IS NOT ZONED 'GENERAL RURAL' OR 'SPECIAL RURAL'

At all times throughout the year, all owners or occupiers of land zoned other than 'General Rural' or 'Special Rural' under the Scheme are required to clear and maintain the land free of all flammable matter to a height no greater than 10cm.

NOTE: For the purposes of this Notice, flammable matter includes, but is not limited to, vegetation (except for living trees, shrubs, plants and lawns under cultivation), prunings, cardboard, wood, paper, general rubbish and any other combustible material.

PERMISSION NEEDED TO VARY REQUIREMENTS

If, due to the topography of your land, you are unable to adhere to the requirements set out in this Notice, you may apply in writing to the City for permission to provide firebreaks in alternative locations or take alternative measures.

Unless and until permission in writing is granted by the City, you shall comply with the requirements of this Notice.

ALL LAND OWNERS

Further to the above minimum requirements, the landowner may receive a separate written notice, sent to the address shown on the City of Gosnells rates record, requiring additional works which may be considered necessary by Council or an Authorised Officer of the City.

PENALTY FOR NON-COMPLIANCE

Failing to comply with the requirements of this Notice is an offence under the *Bush Fires Act 1954* (Act), which carries a penalty of up to \$5,000. In addition, where the owner or occupier of the land fails to comply with a Notice given pursuant to Section 33(1), the City may enter the land to carry out the work required to comply with the Notice and also recover any costs and expenses incurred in carrying out that work from the owner or occupier of the land.


