This order is the Retail Trading Hours (Perth Metropolitan Area) Variation Order 2015.

6. Gas appliance not to be sold or hired

The sale or hire of a portable butane canister 'lunchbox' cooker Class 2 gas appliance to which this Order applies is prohibited.

FISH RESOURCES MANAGEMENT ACT 1994

KIMBERLEY PRAWN MANAGED FISHERY MANAGEMENT PLAN 1993

Areas Closed to Fishing for Prawns in the Kimberley Prawn Managed Fishery for 2015 Notice No. 1 of 2015

I, Heather Brayford, Chief Executive Officer of the Department of Fisheries, in accordance with clause 17 of the Kimberley Prawn Managed Fishery Management Plan 1993 (the Plan) and being of the opinion that the prohibition is required in the better interests of the Kimberley Prawn Managed Fishery, do hereby—

- 1. Cancel Notice of Areas Closed to Fishing for Prawns: *Notice No. 2 of 2014*, dated 23 July 2014; and
- 2. Prohibit fishing for prawns in those parts of the Kimberley Prawn Managed Fishery (the Fishery), between the times and dates provided for in items (a) to (c) below—
 - (a) Fishing for prawns is prohibited in the waters described in Schedule 1 of the Plan from the date of the gazettal of *Notice No. 1 of 2015*, until 0600 hours WST on 1 April 2015;
 - (b) Fishing for prawns is prohibited in the waters described in (i) to (vi) below from the date of the gazettal of this Notice until 0800 hours WST on 27 May 2015—

(i) Collier Bay Prawn Size Management Fish Ground

Waters bounded by a line commencing at the intersection of 16°15.34' south latitude and 124°00.00' east longitude; thence due north along the geodesic to the intersection of 15°50.00' south latitude and 124°00.00' east longitude; thence due east along the parallel to the intersection of 15°50.00' south latitude and 124°24.50' east longitude; thence in a south westerly direction following HWM on the mainland to and along the Collier Bay closure to the commencement point;

(ii) Collier Bay Inshore Closure

Waters inshore of a line commencing at the intersection of $15^{\circ}52.09'$ south latitude and $124^{\circ}26.2'$ east longitude; thence generally south to 16° 04.2' south latitude and $124^{\circ}26.3'$ east longitude; thence generally south west to $16^{\circ}17.00'$ south latitude and $124^{\circ}18.1'$ east longitude; thence generally east to $16^{\circ}17.195'$ south latitude and $124^{\circ}07.861'$ east longitude;

(iii) Brunswick Bay-York Sound Inshore Closure

Waters inshore of a line commencing at the intersection of 15°15.40′ south latitude and 124°40.57′ east longitude; thence generally north east to 15°09.50′ south latitude and 124°50′ east longitude; thence generally north east to 15°00.45′ south latitude and 124°54.20′ east longitude; thence generally east to

14°57.90′ south latitude and 125°01.20′ east longitude; thence generally north east to 14°45.30′ south latitude and 125°08.10′ east longitude; thence generally north east to 14°43.95′ south latitude and 125°09.45′ east longitude (Cape Pond);

(iv) Admiralty Gulf Inshore Closure

Waters inshore of a line commencing at the intersection of $14^{\circ}19.50'$ south latitude and $125^{\circ}43.50'$ east longitude; thence generally south east to $14^{\circ}26.17'$ south latitude and $125^{\circ}48.79'$ east longitude; thence due east to $14^{\circ}26.17'$ south latitude and $125^{\circ}54.54'$ east longitude; thence generally north east to $14^{\circ}19.40'$ south latitude and $125^{\circ}57.60'$ east longitude; thence due east to $14^{\circ}19.40'$ south latitude and $126^{\circ}05.31'$ east longitude;

(v) Napier Broome Bay Prawn Size Management Fish Ground

Waters inshore of a line commencing at the intersection of 13°56.84′ south latitude and 126°33.88′ east longitude; thence generally easterly to 13°56.26′ south latitude and 126°41.12′ east longitude; thence due east to 13°55.75′ south latitude and 126°48.38′ east longitude;

(vi) Napier Broome Bay Inshore Closure

Waters inshore of a line commencing at the intersection $14^{\circ}02.63'$ south latitude and $126^{\circ}29.57'$ east longitude; thence generally south east to $14^{\circ}05.2'$ south latitude and $126^{\circ}31.3'$ east longitude; thence generally south east to $14^{\circ}06.35'$ south latitude and $126^{\circ}35.51'$; thence generally north east to $13^{\circ}58.3'$ south latitude and $126^{\circ}42.2'$ east longitude; thence generally north east to $13^{\circ}55.75'$ south latitude and $126^{\circ}48.38'$ east longitude.

(c) Fishing for prawns is prohibited in the waters described in Schedule 1 of the Plan during the period commencing at 0800 hours WST on 27 May 2015 and ending at 0600 hours WST on 1 May 2016.

It is hereby notified for public information, in accordance with section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the Shire of Capel local planning scheme amendment on 4 March 2015 for the purpose of—

- 1. Modifying the provisions of Appendix 4 of the Scheme Text as it applies to Lot 900 Loretta Avenue and portion of Lots 2 and 901 Bussell Highway, Gelorup (formerly described in Appendix 4 as Lot 30, Portion of 71 Loretta Avenue and Portion of Lots 2 and 3 Bussell Highway, Gelorup (as Follows)—
 - (i) Deleting the following land particulars "Lot 30 Portion of 71 Loretta Avenue and Portion of Lots 2 and 3 Bussell Highway, Gelorup" and replacing the land particulars with "Lot 900 Loretta Avenue and portion of Lots 2 and 901 Bussell Highway, Gelorup".
 - (ii) Deleting reference to "Service Station" from the list of Permitted Uses.
 - (iii) Modifying Development Standards/Conditions No. 2 to read as follows—

"the total Net Lettable Area (NLA) for the Local Centre is 1171 sqm and the maximum NLA shall apply to the following land uses—

- Liquor Store—830sqm
- Takeaway Food Outlet and Restaurant—141sqm
- Convenience Store—200sqm
- Other alternative uses, as per the Local Structure Plan, should the above uses cease to operate"
- (iv) Deleting Development Standards/Conditions No. 5 and 16 in their entirety and renumber Development Standard/Conditions accordingly.

- (v) Modifying Development Standard/Conditions No. 7 (formerly No. 8) by deleting "Lot 30, Portion of Lot 71 Loretta Avenue and Portion of Lots 2 and 3 Bussell Highway" and inserting a new land description and wording "Lot 900 Loretta Avenue, portion of Lots 2 and 901 Bussell Highway" shall be amalgamated and new titles issued "in accordance with the Local Structure Plan" prior to the consideration of any development proposals by Council and is subject to construction of the new access road.
- (vi) Modify Development Standard/Condition No. 9 (formerly Condition No. 10) by deleting the existing provision and replacing it with the following—
 - "9. Car parking shall be implemented at each stage as specified on the Local Structure Plan and the number and location of parking bays shall be determined at the Development Application stage".
- (vii) Modify Development Standard/Condition No. 15 (formerly Condition No. 17) by deleting the wording and replacing it with the following—
 - "15. Design and implementation of a dual use path along Bussell Highway, Loretta Avenue and Road A as depicted on the Local Structure Plan as part of Stage 2".
- (viii) Modify Development Standard/Condition No. 17 (formerly Condition No. 19) by deleting the condition and replacing it with the following—
 - "17. Council shall refer any development application to the Environmental Protection Authority under Section 38(5) of the Environmental Protection Act 1986 for its endorsement prior to any formal consideration or granting of development approval under a Town Planning Scheme which entails the operation of a convenience store outside the hours of 07:00 to 19:00 hours".
- (ix) Inserting a new Development Standard/Condition No. 20 as follows—
 - "20. Council may consider and adopt a modification to the Local Structure Plan via a plan of modification which shall—
 - (i) Prior to adoption by Council be advertised for public comment for a minimum period of twenty eight (28) days;
 - (ii) Be adopted and endorsed by the Council, the Chief Executive Officer and the Western Australian Planning Commission;
 - (iii) Comply with the procedure contained in Clauses 5.10.6, 5.10.7 and 5.10.8 for any modifications".
- (x) Insert a new Development Standard/Condition No. 21 as follows—
 - "21. A Traffic Report by a certified engineer shall be prepared and approved to address the traffic circulation, internal and external to the convenience store prior to any development application associated with Stage 2".
- (xi) Insert a new Development Standard/Condition No. 22 as follows—
 - "22. All stormwater from impervious areas are to be contained on site to the satisfaction of Council and any relevant authority. Details are to be submitted and approved prior to each development application".
