This order is the Public Firewood Areas Order 2015.

2. Commencement

Legal Profession Amendment Regulations (No. 2) 2015

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Legal Profession Amendment Regulations (No. 2) 2015.*

2. Commencement

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Regulations amended

These regulations amend the *Legal Profession Regulations 2009*.

4. **Regulation 3 amended**

(1) In regulation 3 insert in alphabetical order:

Legal Aid Commission has the meaning given in section 388(1) of the Act.

(2) In regulation 3 in the definition of *entity* delete "body." and insert:

body;

5. **Regulation 5A inserted**

At the beginning of Part 2 insert:

5A. Exceptions to prohibition on engaging in legal practice when not entitled (Act s. 12(3)(h))

For the purposes of section 12(3)(h) of the Act, section 12(2) of the Act does not apply to a person doing legal work under the supervision of an Australian legal practitioner as a paid employee of —

- (a) the Legal Aid Commission; or
- (b) a community legal centre; or
- (c) a corporation other than an incorporated legal practice.

6. **Regulation 73A inserted**

At the end of Part 7 Division 7 insert:

73A. Board may grant exemptions from s. 237(1)

The Board may by written notice exempt a law practice from the requirement to have trust records examined under section 237(1) of the Act to the extent that is specified in the notice.

7. Regulation 97 amended

In regulation 97(1):

(a) in paragraph (g)(iii) delete "insurance." and insert:

insurance;

- (b) after paragraph (g) insert:
 - (h) a practitioner who
 - (i) holds a local practising certificate with a condition imposed that the holder only engages in the provision of legal services on a not-for-profit basis and does not charge any person nor seek to

recover a fee from any person, except for any fee arrangements that are specified in that condition; and

 (ii) holds or is covered by professional indemnity insurance issued in accordance with the National Pro Bono Resource Centre's professional indemnity insurance arrangement.

Town Planning Scheme No. 1-Amendment No. 68

Ref: TPS/1560

It is hereby notified for public information, in accordance with section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the Town of Victoria Park local planning scheme amendment on 15 July 2015 for the purpose of—

- 1. Delete Clause 46 of the Scheme Text and replace as follows-
 - 46. LOCAL PLANNING POLICIES
 - (1) The local government may prepare a local planning policy in respect of any matter related to the planning and development of the Scheme area.
 - (2) A local planning policy—
 - (a) may apply generally or in respect of a particular class or classes of matters specified in the policy; and
 - (b) may apply to the whole of the Scheme area or to part or parts of the Scheme area specified in the policy;
 - (3) A local planning policy must be based on sound town planning principles and may address either strategic or operational considerations in relation to the matters to which the policy applies.
 - (4) The local government may amend or repeal a local planning policy.
 - (5) In making a determination under this Scheme the local government must have regard to each relevant local planning policy to the extent that the policy is consistent with this Scheme.

46A. PROCEDURES FOR MAKING OR AMENDING A LOCAL PLANNING POLICY

- (1) If the local government resolves to prepare a local planning policy, the local government must advertise the proposed policy as follows—
 - (a) publish a notice of the proposed policy once a week for 2 consecutive weeks in a newspaper circulating in the Scheme area, giving details of—
 - (i) the subject and nature of the proposed policy; and
 - (ii) the objectives of the proposed policy; and
 - (iii) where the proposed policy may be inspected; and
 - (iv) to whom, in what form and during what period submissions in relation to the proposed policy may be made;
 - (b) If, in the opinion of the local government, the policy is inconsistent with any State planning policy, give notice of the proposed policy to the Commission;
 - (c) give notice of the proposed policy in any other way and carry out any other consultation the local government considers appropriate.
- (2) The period for making submissions in relation to a local planning policy must not be less than a period of 21 days commencing on the last day the notice of the policy is published under subclause (1)(a).
- (3) After the expiry of the period within which submissions may be made, the local government must—
 - (a) review the proposed policy in the light of any submissions made; and
 - (b) resolve to—
 - (i) adopt the policy with or without modification;
 - or
 - (ii) not to proceed with the policy.
- (4) If the local government resolves to adopt the policy, the local government must publish notice of the policy once in a newspaper circulating in the Scheme area.
- (5) A Policy has effect on publication of a notice under subclause (4).
- (6) The local government must ensure that an up-to-date copy of each local planning policy made under this Scheme is kept and made available for public inspection during business hours at the offices of the local government.
- (7) Subclauses (1) to (6), with any necessary changes, apply to the amendment of a local planning policy.

46B. REVOCATION OF LOCAL PLANNING POLICY

A local planning policy may be revoked-

- (a) by a subsequent local planning policy that—
 - (i) is prepared in accordance with this Part; and
 - (ii) expressly revokes the local planning policy;
 - or
- (b) by a notice of revocation—
 - (i) prepared by the local government; and
 - (ii) published once a week for 2 consecutive weeks in a newspaper circulating in the Scheme area.
- 2. Modify the definition of 'planning policy' in Schedule 1 of the Scheme Text to read "planning policy" means a local planning policy made by the Council under clause 46.

The Registrar of Titles be directed to remove the Registrar's Caveat from the certificate of title for the land.

The Trustees be at liberty to dispose of the said land unencumbered by the Trust.

The Trustees and the Attorney General's reasonable costs of and incidental to preparing, advertising and obtaining approval of the scheme be paid out of and a charge on the trust Land.
