Made by the Commissioner for Consumer Protection under section 12 of the Act.

1. Citation

This order is the *Petroleum Products Pricing (Maximum Terminal Gate Price) Amendment Order 2015.*

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Order amended

This order amends the *Petroleum Products Pricing (Maximum Terminal Gate Price) Order 2013*.

4. Clause 3 amended

In clause 3 insert in alphabetical order:

notification day has the meaning given in clause 4(1); rate replacement day means the day on which a CPI indexed rate is replaced under the Excise Tariff Act 1921 (Commonwealth) section 6A;

Temporary Notice to Mariners CLOSURE OF WATERS TO BOATING Thomson Bay, Rottnest Island

New Year's Eve 2015

Acting pursuant to the powers conferred by Regulation 38B of the *Rottnest Island Regulations 1988*, the Rottnest Island Authority hereby closes the following waters to all vessels, excluding bona fide emergency and authorised vessels as set out below.

New Year's Eve: Closure of waters Thomson Bay

Closure of waters between 6:00am on Thursday 31 December 2015 and 12:00 midday on Friday 1 January 2016.

All the waters within 40 metres of the shoreline, from a point on the foreshore 400 metres southeast of the Hotel Jetty and extending in a north-westerly direction to the Rottnest Main Jetty.

Tenders (max vessel length 3.75m) are permitted to access the beach from the Rottnest Main Jetty south to the northern side of the Hotel Jetty, excluding designated swimming areas.

This has been introduced to assist in achieving public safety and appropriate signage will be placed on site.

Fire Works Display: Closure of waters Thomson Bay

Closure of waters between 12:00 midday on Thursday 31 December 2015 to 12:00 midday on Friday 1 January 2016.

All waters with 250 metres from a point 115 33.241E and 31 59.845N and all waters within 150 metres from a point 115 33.288E and 32 0.08N. A firing barge loaded with explosive materials will be anchored at the firing point.

These restrictions have been put in place to minimise risk and ensure the safety of all visitors and event staff together with their vessels. Appropriate signage will be placed on site and a map showing these restrictions is available for viewing at www.rottnestisland.com.

Mariners are advised that a floating buoy will identify the centre points of each area and patrol vessels will be operating to ensure compliance. The firing barge may move between the two locations depending on weather conditions.

EXEMPTION

Exemption of Robe River Mining Co Pty Ltd for the provision of a non-potable water service in Wickham

In accordance with section 7 of the *Water Services Act 2012*, the Hon Mia Davies MLA, Minister for Water, has granted an exemption from the application of section 5(1) of the Act to Robe River Mining Co Pty Ltd for the provision of a non-potable water service in Wickham.

The Water Corporation will supply Robe River Mining Co Pty Ltd with tertiary treated wastewater produced at the Wickham Wastewater Treatment Plant, which includes the Tertiary Treatment Plant, which is owned by the Water Corporation. This arrangement will be governed by a commercial agreement.

The exempted water service involves the on-supply of treated wastewater by Robe River Mining Co Pty Ltd to third parties located in the Wickham township. The quantity supplied will equate to the amount (if any) that is surplus to Robe River Mining Co Pty Ltd's own requirements. The wastewater will be provided to third parties for the purpose of non-agricultural irrigation only.

The exemption will come into effect on the day it is published in the *Government Gazette* and is valid for an indefinite period.

Summary of the reasons for the decision

Granting this exemption is not contrary to the public interest. It is considered that—

- The risk of Robe River Mining Co Pty Ltd exploiting its monopoly power, in respect to the provision of this service, is low. The service is operated on a not-for-profit basis, for the benefit of the community.
- The regulatory burden imposed by the licensing of this water service would be disproportionately high given the small scale of the service.
- The service will reduce reliance on scheme water.
- The public health and environmental aspects of this service are regulated under the *Health Act 1911* and the *Environmental Protection Act 1986*, respectively.
