CONSERVATION AND LAND MANAGEMENT ACT 1984

CONSERVATION AND LAND MANAGEMENT (RESERVATION OF TIMBER RESERVE) ORDER (NO. 1) 2016

Made by the Governor in Executive Council under section 10 of the Conservation and Land Management Act 1984.

1. Citation

This order may be cited as the Conservation and Land Management (Reservation of Timber Reserve) Order (No. 1) 2016.

2. Background to this order

- (1) Two areas of Crown land (former road reserve and lease) have been identified as being suitable for inclusion into the adjoining Timber Reserves.
- (2) The lands referred to in subclause (1) are described in Schedules 1-2.

3. Addition to Timber Reserve Nos. 163/25 and 170/25

The land described in Schedule 1-2 are reserved as additions to the respective Timber Reserves.

TEMPORARY NOTICE TO MARINERS

Closure of Waters to Boating Thomson Bay

Rottnest Channel Swim and Swim Champs of the Bay Race

Acting pursuant to the powers conferred by Regulation 38B of the *Rottnest Island Regulations 1988*, the Rottnest Island Authority hereby closes the following waters to all vessels, excluding bona fide emergency and authorised vessels, as set out below.

ROTTNEST CHANNEL SWIM: 26 AND 27 FEBRUARY 2016

Closure of waters at Thomson Bay from 12:00hrs on Friday 26 February 2016 to 18:00hrs on Saturday 27 February 2016.

Between Ferry Jetty and Fuel Jetty

All waters with 25 metres of the shoreline.

 $Authorised\ Vessel$: Powered support vessel displaying a 2016 Karma Resort Rottnest Channel Swim sticker.

Between Fuel Jetty and Hotel Jetty (Swim Channel)

All waters to a point 38 metres on the southern side of the Fuel Jetty extending in an easterly direction encompassing the following moorings—

Ranger; TB063; TB062; TB072; RIA015 Hire; TB078; RIA016 Hire; TB056; TB100; TB319; TB053; RIA005 Hire; TB051; TB081; RIA017 Hire; TB200; South Cardinal Marker (115° 32.836′E 31° 59.79′S); TB091; RIA028 Hire; RIA009 Hire; TB077; TB322; TB058; TB060.

Authorised Vessel: Bona fide emergency vessels.

South of Swim Channel

All waters starting 38 metres south of the Fuel Jetty extending 110 metres in a southerly direction following the foreshore and 25 metres east.

Authorised Vessel: Bona fide emergency vessels.

North of Hotel Jetty

All waters north of the Hotel Jetty extending 51 meters in a northerly direction and 25 metres east. *Authorised Vessel*: Bona fide emergency vessels and competitor's support paddle craft displaying a 2016 Karma Resort Rottnest Channel Swim sticker.

South of Hotel Jetty

All waters south of the Hotel Jetty extending 51 metres following the foreshore in a southerly direction and 25 metres east.

Authorised Vessel: Bona fide emergency vessels and tenders less than 3.75 metres in length.

These restrictions have been put in place due to the unusually large number of vessels and people entering the Reserve and the need achieve public safety. Appropriate signage will be placed on site and a map showing these restrictions is available for viewing at www.rottnestisland.com.

Mariners are further advised that due to the close proximity of the swim channel to fuel dispensing facilities, supplies will not be available between 10.00hrs to 17.00hrs on Saturday 27 February 2016.

SWIM CHAMPS OF THE BAY RACE: 28 FEBRUARY 2016

Closure of waters to boating at Thomson Bay (north) between 09:00hrs and 10:30hrs on Sunday 28 February 2016

Between Ferry Jetty and Stark Jetty

All waters between the Start Jetty and Ferry Jetty extending eastwards from the foreshore following a line along the southern side of Stark Jetty to a position 31° 59.675E and 115° 59.675S, then head south to a position 31° 59.705E and 115° 32.526S and finishing at a point on the Ferry Jetty at 31° 59.710E 115° 32.528S.

Authorised vessel: Authorised support craft and bona fide emergency response vessels.
