TRANSFER ORDER

Made by the Treasurer under Section 21(2)

- I, The Hon Dr. Mike Nahan, Treasurer (being the Minister responsible for the Act), order that—
 - (a) 8.50am on the day that completion occurs under the Market City Sale Agreement for the sale and purchase of the market assets dated 12 February 2016, is to be the transfer time for this order (**Transfer Time**);
 - (b) at the Transfer Time, each asset of the Authority specified in Column 1 of Part 1 of Table B, and all rights and liabilities of the Authority arising from or in connection with each such asset, but—
 - (1) not any asset specified in Part 2 of Table B or any right or liability of the Authority from or in connection with each such asset; and
 - (2) not any liability specified in Part 3 of Table B,
 - is, by operation of sections 22 and 23, to be transferred to the person specified or referred to opposite that asset in Column 2 of Part 1 of Table B;
 - (c) with respect to liabilities other than those dealt with pursuant to clause (b), at the Transfer Time, each Liability of the Authority is, by operation of sections 22 and 23, to be transferred to Market City Operator Co Pty Ltd ACN 610 129 149;
 - (d) subject to paragraphs (b) and (c) of this order, each contract and instrument specified or referred to in Column 1 of Part 1 of Table B is, by operation of sections 22 and 23, to have effect, at the Transfer Time, as if references to the person specified or referred to in Column 2 of Part 1 of Table B were substituted for references to the Authority, in its capacity as the holder of rights in the assets the subject of this order, or in the relevant contract or instrument; and
 - (e) the proceedings in which the Authority is to be substituted by Market City Operator Co Pty Ltd ACN 610 129 149 as a party at the Transfer Time are specified in Table C.

Unless the contrary intention appears, words and expressions used in this order have the meaning given in the Act or specified in Table A.
