# BUSH FIRES ACT 1954 <br> Shire of Coolgardie <br> Bush Fires (SECTION 24E) Notice 2016 

Correspondence No 00109-05

## 1. Citation

This notice may be cited as the Bush Fires (Section 24E) Notice 2016—Shire of Coolgardie.
2. Permission to burn garden refuse or rubbish in rubbish tip during restricted burning times
(1) Permission is given for the use of fire in the open air for the purpose of burning the garden refuse and rubbish specified in clause 1 of Schedule 1.
(2) This permission applies to Shire of Coolgardie employees and contractors.
(3) This permission has effect for the period of 5 years from the day on which this Notice is published in the Government Gazette.

## 3. Land to which Permission applies

This notice only applies in respect of the Kambalda Refuse Sites situated at Lot 301 Dump Rd in Kambalda, located within the Shire of Coolgardie.

## 4. Conditions applying during the permission-Schedule 1

During the period of permission, the conditions specified in the attached schedule (Schedule 1) apply to a fire which is to be lit, or which is lit, for the purpose of burning garden refuse or rubbish or for any like purpose in a rubbish tip during the restricted burning times.

## Bush Fires (Section 24E) Notice 2016 <br> Shire of Coolgardie <br> SCHEDULE 1— SPECIFIED CONDITIONS

1. Only dry untreated wood, timber and garden refuse may be burnt under this permission.
2. A firebreak of a minimum ten (10) metres width, cleared of all inflammable material, is to be established and maintained around the piles that are to be burnt.
3. A separation zone of a minimum of twenty five (25) metres must be maintained between the waste to be burnt and any other domestic or commercial waste.
4. Prior to the lighting of any fire under this permission the Shire of Coolgardie will place a notice within a newspaper circulating in their District and upon their website, advising the public of the intention to burn, the purpose for which the burning is being undertaken and the expected periods of burning.
5. Before any fires are lit the following notifications must be made-

- Shire of Coolgardie Chief Bush Fire Control Officer;
- DFES Communications Centre; and
- Department of Parks and Wildlife (P\&W) District Officers prior to any fire being lit within five (5) kilometres of $\mathrm{P} \& \mathrm{~W}$ land.

6. No fires are to be lit on the site subject to this permission on a day or part of a day for which the fire danger forecast issued by the Bureau of Meteorology in respect of that locality is Catastrophic, Extreme, Severe or Very High.
7. Fires are only to be lit under the following conditions-

- the fire is lit by personnel specifically authorised to do by the Local Government;
- the fire is lit after a local forecast for the day has been obtained from the Bureau of Meteorology; and
- the Chief Bush Fire Control Officer or his designated deputies have been consulted and agreed to the burn taking place.

8. Burning shall take place in designated areas of the rubbish tip. The designated areas shall be cleared of all inflammable material, save minor grasses, for a radius of 50 metres minimum. The burning site will be located a minimum of 50 metres from the rubbish tip boundary.
9. Materials for burning shall be arranged in trenches or windrows, as directed by the Local Government. This area should not be sited over a site which has been previously land filled.
10. All materials burnt shall be regularly heaped and stoked throughout the duration of the burn to ensure, as far as possible, a rapid and complete burn.
11. The volume of waste to be burnt shall not exceed that which can be safely burnt and declared safe within the hours of 12 Midday and 12 Midnight on any one day.
12. Until the fire is declared safe, by the Shire of Coolgardie's Chief Bush Fire Control Officer or his designated deputy, the fire must be attended by-

- at least three able bodied personnel who have successfully undertaken the minimum of Bush Fire Training, as defined by DFES; and
- A fire fighting appliance, fitted with a two-way radio, with a minimum water carrying capacity of 2000 litres fitted with a minimum of 30 metres of 19 millimetre diameter rubber hose and a pump capable of delivering a minimum of 1000 litres of water per minute at a minimum of 700 Kpa through an adjustable nozzle capable of projecting water in spray and jet configurations.

13. The personnel referred to in Condition 12 are to be provided a mobile telephone and contact numbers for those persons described in Condition 5.
14. All burns are to be declared "SAFE" by the Chief Bush Fire Control Officer or his designated deputies prior to any fire fighter personnel or equipment being permitted to depart the area.

6. Removing all Buildings and Places of Heritage Significance from Schedule 1-Buildings and Places of Heritage Significance being items numbered 1-14 (Inclusive) and 16-23 (Inclusive) and their associated locations and descriptions.
7. Removing references to Buildings and Places of Heritage Significance numbered 1-14 (Inclusive) and 16-23 (Inclusive), as identified in Schedule 1, from the Scheme Maps.
8. Amending the Scheme Maps to identify L1-L5 as indicated in revised Schedule 1 on the Scheme Maps.
9. Amending Schedule 1 by Changing the Title of Schedule 1 from "Buildings and Places of Heritage Significance to "Places of Landscape Value" and inserting Details for Places L1—L5 as follows-

WATER SERVICES ACT 2012
Class Exemption for Small Local Government Sewerage and/or Non-Potable Water Services Providers

## Exemption Notice

In accordance with section 7 of the Water Services Act 2012, the Hon Mia Davies MLA, Minister for Water, has granted a class exemption from section 5(1) of the Act to local government water services providers with less than 1000 customer connections whose water services are limited to the provision of sewerage services and/or non-potable water supply services.

The Act defines the terms 'water service', 'water supply service', 'sewerage service' and 'wastewater'.
The class exemption does not apply to potable water supply services (i.e. 'drinking water').
'Drinking water' is defined as water that is intended for human consumption or for purposes connected with human consumption such as the preparation of food, or the making of ice for consumption or for the preservation of unpackaged food, whether or not the water is used for other purposes.
The exemption will come into effect on the day it is published in the Government Gazette and will apply for a duration of five years.
The exemption will apply to the following local government authorities-

## Summary of reasons for the decision

Granting the exemption is not contrary to the public interest. It is considered that-

- the risk of the abuse of monopoly power in the provision of water services is low;
- the public health and environmental aspects of these water services are regulated under the Health Act 1911 and the Environmental Protection Act 1986, respectively; and
- the exemption will reduce the regulatory and compliance costs associated with water services licensing, including-
o administrative costs to the service provider of licensing i.e. licence fees, annual regulatory reporting costs, the costs of operational audits and asset management system reviews every two to three years; and
o costs to Government for enforcing and administering water service licences.
