APPROVED LOCAL PLANNING SCHEME AMENDMENT

Town of Cambridge

Local Planning Scheme No. 1—Amendment No. 32

Ref: TPS/1665

It is hereby notified for public information, in accordance with section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the Town of Cambridge Local Planning Scheme amendment on 19 July 2016 for the purpose of—

- (1) Zone the Perry Lakes Redevelopment Area, which includes the lots north of Underwood Avenue, east of Meagher Drive, south of Hurdles Drive, south of Steeplechase Green and the lots fronting the eastern side of Destiny Lane, "Residential Zone" as depicted on the proposed Scheme Map;
- (2) Classify Lot 8001 and 8013 (Reserve 50836) Hurdles Drive, and Lot 8002 (Reserve 51285) Steeplechase Green, Lot 8003 (Reserve 51633) Brookdale Street and the portion of road reserve at the eastern end of Dynevor Rise and south of Lot 8003 (Reserve 51633) Brookdale Street, "Local Reserve—Parks and Recreation" as depicted on the proposed Scheme Map;

- (3) Introduce "Special Control Area No. 4" over the Perry Lakes Redevelopment Area by amending the Scheme Text as follows—
 - (i) modify clause 56 by inserting after clause (1) (c)—
 - "(d) SCA No. 4—Perry Lakes Redevelopment Area"; and
 - (ii) inserting a new clause 60 as follows—
 - 60. SPECIAL CONTROL AREA NO. 4
 - (1) Name of Special Control Area— Perry Lakes Redevelopment Area
 - (2) Purpose of the Special Control Area—

To facilitate detailed site planning for the subdivision and development of the Perry Lakes Redevelopment Area which includes land that previously contained various sporting facilities including a basketball stadium, athletics track, grandstand and associated facilities that were built for the 1962 British Empire and Commonwealth Games and was known as "Perry Lakes Stadium".

(3) Objectives—

The objectives for development and planning decision making within SCA No. 4 are to—

- (a) provide pleasant and safe walkable neighbourhoods by way of an interconnected street pattern and a road layout that is legible, interconnected and well treed;
- (b) foster a sense of community and strong sense of place in neighbourhoods by integrating new residential development with the existing surrounding residential development;
- (c) provide a variety of lot sizes and housing types to cater for the diverse housing needs of the community at a density that can ultimately support the provision of local services and public transport;
- (d) become a sustainable development in its own right and contribute to the improved social, environmental and economic sustainability of the broader area;
- (e) build on the historical use of the site and create a unique urban environment which recognises and acknowledges the site's sporting history:
- (f) ensure the provision of public open space to both integrate the proposed development and to reflect the existing residential character of the surrounding area, including the retention of mature trees and the provision of strong connections to the adjoining Perry Lakes Reserve;
- (g) ensure a high level of accessibility to the surrounding area and an even distribution of traffic from the proposed development and provide a movement network that is not solely dependent upon validle movement; and
- (h) provide additional community infrastructure which also benefits the broader community.
- (4) Additional provisions—
 - (a) For the purpose of this clause 60—
 - (i) "Detailed Area Plans" means the detailed area plans prepared in accordance with the Redevelopment Plan and approved by the Western Australian Planning Commission on 17 September 2009;
 - (ii) "Design Guidelines" means design guidelines prepared in accordance with the Redevelopment Plan and approved by the Western Australian Planning Commission on 17 September 2009, as amended;
 - (iii) "Redevelopment Plan" means the redevelopment plan approved by the Minister for Planning under section 27 of the Perry Lakes Redevelopment Act 2005 on 10 July 2008 and gazetted on 18 July 2008; and
 - (b) When determining an application for development approval or making a recommendation on an application for subdivision approval, on or in relation to land within SCA No. 4, the Council shall, in addition to the matters referred to in clause 67 of the deemed provisions, have due regard to—
 - (i) the objectives set out in the preceding subclause (3);
 - (ii) the Redevelopment Plan;
 - (iii) any applicable Detailed Area Plan; and
 - (iv) the Design Guidelines.
 - (c) Where a provision of this clause 60 is inconsistent with any other provision of the Scheme (excluding the deemed provisions), the provisions of this clause shall prevail to the extent of the inconsistency.

(d) For the purposes of the *Planning and Development (Local Planning Schemes)*Regulations 2015 a planning instrument referred to in column 1 of the following table is to be taken to be a planning instrument of the type referred to in column 2 of the table.

- (e) Residential density within SCA No. 4 shall be as set out in the Detailed Area Plans.
- (f) Land use permissibility within SCA No. 4 shall be as designated for the Residential Zone in the Zoning Table, with the following exceptions—
 - (i) Dwelling (single)—'D'; and
 - (ii) A restaurant/café with a maximum total plot ratio area of 200m² is an additional permitted use on Lot 232 Meagher Drive, Floreat.
- (g) In accordance with clause 61(3) of the deemed provisions, development approval is required for the erection of a single house and/or ancillary dwelling on a lot in SCA No. 4, irrespective of whether the development satisfies the deemed-to-comply requirements of the R-Codes or requirements applicable under an approved structure plan or local development plan.
- (5) Amend the Scheme Map accordingly.

- 5. Rezoning 181 St Marks Drive, Hillarys from 'Private Clubs/Recreation' to 'Centre'.
- 6. Reclassifying Reserve 32789, Hillarys from 'Parks and Recreation' to 'Centre'.
- 7. Removing Additional Uses 1-15, 1-16, 1-17 and 1-18 from Schedule 2—Section 1 (Clause 3.15)—Additional Uses.
- 8. Inserting a new Schedule as follows—

SCHEDULE NO. 10—ADDITIONAL REQUIREMENTS THAT APPLY TO LAND COVERED BY A STRUCTURE PLAN, ACTIVITY CENTRE PLAN OR LOCAL DEVELOPMENT PLAN

- 1. Whitfords Activity Centre
 - 1.1 Land zoned 'Centre' within the Whitfords Activity Centre is separated into four 'Centre Districts' (C) as shown on the scheme map and detailed as follows—
 - (a) Endeavour District (C-1);
 - (b) Retail District (C-2);
 - (c) Banks District (C-3); and
 - (d) Education and Civic District (C-4).
 - 1.2 The RAC-0 density code applies to land zoned 'Centre' within the Endeavour District.
 - 1.3 The R80 density code applies to land zoned 'Centre' within the Retail, Banks, and Education and Civic Districts.
 - 1.4 The total net lettable area of all existing and future shop retail development for land within the 'Centre' zone shall be consistent with an Activity Centre Plan approved pursuant to State Planning Policy 4.2—Activity Centres for Perth and Peel.

- 1.5 If an application for development approval is made to the local government to increase the floor space for shop/retail uses within the Retail District where the net lettable area is, or would be increased beyond 55,000m², the application must demonstrate—
 - (a) residential development in the Retail and/or Endeavour District/s at a minimum rate of one dwelling for every 500m² of additional shop/retail NLA in the Retail District;
 - (b) shop/retail uses within the Endeavour District with a net lettable area of at least 10% of the additional shop/retail net lettable area in the Retail District; and
 - (c) the mix of land use floor space, upon completion of the development subject of the application, is at least 40%.
- 1.6 Land use permissibility for land zoned 'Centre' within the Whitfords Activity Centre shall be in accordance with Table 3—Whitfords Activity Centre Zoning Table. The symbols used in Table 3 have the same meaning as Clause 3.2.2 of the scheme
- 1.7 Subject to sub-clause 1.6 and Table 3, where a land use is not listed, it shall be treated as an unlisted use, pursuant to Clause 3.3 of the scheme.
