Biosecurity and Agriculture Management Act 2007

# **Biosecurity and Agriculture Management** (Newcastle Disease) Management Plan 2016

Issued by the Minister under section 45 of the Act.

### 1. Citation

This management plan is the *Biosecurity and Agriculture* Management (Newcastle Disease) Management Plan 2016.

# 2. Commencement

- (a) clauses 1 and 2 on the day on which this management plan is published in the *Gazette*;
- (b) the rest of the management plan on the day after that day.

# 3. Terms used

In this management plan —

*Code of practice* means the "Code of practice: managing the risk of Newcastle disease in Western Australia" issued by the Minister under section 191(1) of the Act and published on the Department of Agriculture and Food website, as amended from time to time;

*commercial chicken farming* means farming of domestic chickens on premises where 1 000 or more chickens are kept;

*disease event* means an event that meets the case definition for Newcastle disease set out in the Code of practice;

*domestic chickens* means chickens with the scientific name *Gallus gallus domesticus*;

*Newcastle disease virus* means Newcastle disease virus (non-virulent) and Newcastle disease virus (virulent).

# 4. Purpose of management plan

The purpose of this management plan is to provide for the control of Newcastle disease virus in the State.

Note for this section:

By virtue of the declaration made under section 22 of the Act notice of which was published in the *Gazette* on 7 May 2013 p. 1925, Newcastle disease virus (non-virulent) is a declared pest for the whole of the State.

By virtue of the declaration made under section 12 of the Act notice of which was published in the *Gazette* on 26 July 2013 p. 3360, Newcastle disease virus (virulent) is a prohibited organism. Under section 22(1) of the Act a prohibited organism is a declared pest for the whole of the State.

## 5. Measures to be followed under management plan

The measures set out in clauses 6 to 8 are the prescribed measures to control Newcastle disease virus to be taken under section 30(3) of the Act by a person who is conducting commercial chicken farming on land in the State.

## 6. Vaccination of commercially farmed domestic chickens

- (1) A person who conducts commercial chicken farming must ensure that the chickens being farmed are vaccinated against Newcastle disease as required under the Code of practice.
- (2) A person who conducts commercial chicken farming must ensure that a written record of any vaccination of chickens that are in the possession of the person is kept in accordance with the Code of practice.

### 7. Reporting of Newcastle disease virus

A person who conducts commercial chicken farming must ensure that a report is made in accordance with the Code of practice if a disease event occurs in relation to the commercial chicken farming.

### 8. Testing of commercially farmed domestic chickens

- (1) A person who conducts commercial chicken farming must ensure that sample collection in accordance with the Newcastle disease sample collection procedures set out in the Code of practice is carried out if a disease event occurs in relation to the commercial chicken farming.
- (2) A person who conducts commercial chicken farming must ensure that samples collected by or on behalf of the person under subclause (1) are provided to the Department of Agriculture and Food in accordance with the Code of practice.

City of Bayswater FIREBREAK NOTICE

Notice to all landowners and occupiers of land in the City of Bayswater

All landowners and occupiers of land within the City of Bayswater are advised that, on or before the 30 November 2016 or within fourteen days of the date of becoming an owner or occupier up to and including 30 April 2017, they must ensure compliance with the following firebreak conditions-

All land which is 2000 square metres or less in area-

Remove all inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm

All other land within the City of Bayswater-

- i. Firebreaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land;
- ii. Firebreaks of a minimum width of 3 metres and height of 3 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept.

If for any reason an owner and/or occupier consider it impractical to clear firebreaks or comply with other fire protection measures in accordance with this Notice, the owner and/or occupier may apply in writing to Council not later than 29 November 2016.

Where an owner and/or occupier of land fails or neglects to comply with any requirement of this Notice, Council may undertake the work and recover the costs and expenses from the owner and/or occupier pursuant to the Act, in addition to any penalty which might be imposed. A Penalty of not more than \$5,000 applies.

Burning off within the City of Bayswater is prohibited. All clearing and disposal of waste should be carried out by methods other than burning.
