This declaration is the Biosecurity and Agriculture Management (Declared Pest) Declaration (No. 2) 2016.

#### 2. Declared Pest

(1) Cosmopolites sordidus (Germar, 1824) is declared under section 22 (2) of the Act to be a Declared Pest for the whole of the State.

(2) Cosmopolites sordidus (Germar, 1824) is assigned the control category C3-Management in the area within 50 km of Carnarvon Post Office and the area within 50 km of Kununnura Post Office.
(3) Cosmopolites sordidus (Germar, 1824) is assigned the control category C1-Exclusion in the rest of the State.

#### 3. Revocation

All previous declarations relating to Cosmopolites sordidus (Germar, 1824) are revoked.
